NOTIFICATION

Whereas, power to makes rules under the condition of previous publication under sub section (1) of section 212 by notification in official gazette for implementing the provisions of section 26, 38, 65, 95, 107, 111, 138, 176, 211 and 213 and 215 (D) of the Motor Vehicles Act, 1988 (Act no. 59 of 1988) is, vested in State Government;

Now, therefore, as per the requirement of sub-section (1) of section 212 of the Motor Vehicles Act, 1988 (Act no. 59 of 1988), the Governor hereby publishes the draft of Uttarakhand Motor Vehicles (Amendment) Rules, 2025 to amend the Uttarakhand Motor Vehicles Rules, 2011 for the information of all concerned;

The Governor directs that any representation and objections related to this notification by the beneficiary and the general public may be sent within the period of 30 days from the date of publication of this notification in the newspaper to the office of Secretary, Transport Department, Government of Uttarakhand, 4 Subhash Road, Dehradun;

The Governor also directs that representations and objections shall not be accepted after the said time period.
