Industrialisation plays a vital role in the economy of a State. The Index of Industrial Production (IIP) is one of the prime short-term micro economic indicators of the economic development to measure trend in the behavior of the industrial performance over a period of time in comparison to a chosen base year. It indicates the relative change of physical production in the field of industries during a specified year as compared to previous year.

The Department of Economic and Statistical Analysis, Haryana has been compiling the Index of Industrial Production for Haryana State under the guidance of the Central Statistics office (CSO), Govt. of India since 1971-72 and publishes its report periodically. The present report containing information relating to IIP from the year 2012-13 to 2015-16 is the first issue of the series with base year 2011-12. The Index of Industrial Production of Haryana State relates to Manufacturing and Electricity Sectors with an analysis of use-based classification of the index numbers.

This report provides a useful information for planners, industrialists and researchers etc. interested in the industrial development of the State.

I take this opportunity to thank the Central Statistics Office, Government of India for providing valuable guidance. Efforts made by the District Statistical Officers for timely collection of production data from various industrial units is also acknowledged. The cooperation extended by various industrial units in Haryana for providing required production data for computation of IIP is appreciated and acknowledged.

EXECUTIVE SUMMARY

Industrialization plays a vital and crucial role in the economic development of an economy. It accelerates economic growth of a State and thereby increases the contribution of industry sector in the State Domestic Product by way of increase in the production and employment. Index of Industrial Production (IIP) is one of the prime indicators of the economic development for measurement of trend in the industrial production over a period of time with reference to a chosen base year.

The Index of Industrial Production for the State is compiled in accordance with the guidelines of the Central Statistics Office (CSO), Govt. of India. In the Ist part of the report detail methodology source of data and computation of index number have been given.

A total of 178 items have been selected from registered manufacturing sector for the year 2011-12. Electricity has been taken as single item. Mining and Quarrying sector has been excluded due to its insignificant contribution in GSDP which was 0.04% in 2011-12 in the State. The total weight of industrial sector has been taken as 1000 which has been distributed to Registered Manufacturing & Electricity sectors. The weights of registered manufacturing sector have further been distributed at 2/3 digit as well as item level as per criteria suggested by CSO. Production data of selected items is collected directly from the selected factories in the State.

Presently Index of Industrial Production being prepared in the State with 2011-12 as base year covers Manufacturing and Electricity sectors. Index number has been calculated at sector level, group level (2 digits) and item level. The same has been presented in the report accordingly. Review of index numbers for the year 2015-16 has also been given in the report.

The General Index of Industrial Production with 2011-12 as base year increased from 120.3 in 2014-15 to 126.1 in 2015-16, registering a growth of 4.8 percent. The Index of Manufacturing Sector which carries the highest weight in IIP rose from 120.3 in 2014-15 to 128.7 in 2015-16, exhibiting a growth of 7.0 percent. The Index of Electricity Sector indicates a negative growth of -22.6 percent as it decreased from 119.5 in 2014-15 to 92.5 in 2015-16.

In the last part of the report use-based classification which represents the changing pattern of customer's needs, based on taste and habits towards the purchase of industrial product has been given. Review of the use-based classification for the year 2015-16 has also been given therein.

The report elaborates that the Index of Primary Goods Industries like Argon gas, urea, bitumen, LPG cylinder of iron and steel, electricity etc. has decreased from 122.8 in 2014-15 to 96.7 in 2015-16, which recorded a decrease of -21.2 percent.

The Index of Capital Goods Industries like conveyor belts, tractor tyres, link forging, optical components, acephate / speedometer, diamond tools, spring pins etc. remained same as 115.4 in 2014-15 and 2015-16, showing no growth.

The Index of Intermediate Goods Industries like plywood boards, wooden chips, cast iron, stone dust powder, seat for motor vehicle etc. has decreased from 117.8 in 2014-15 to 109.7 in 2015-16, recording a negative growth of -6.88 percent.

The Index of Infrastructure / Construction Goods Industries like paints, ceramic tiles, scrap cast iron etc. has fallen from 112.0 to 109.8, showing a negative growth of 2.0 percent.

The Index of Consumer Durables Industries like cotton fabrics, blankets, artificial fur hand bags, books, rexin, button plastic, glass components, water pump, AC motor car etc. has increased from 124.6 in 2014-15 to 142.1 in 2015-16, registering a growth of 14.0 percent.

The Index of Consumer Non-Durables Industries like dried vegetables, milk, rice basmati, sugar, biscuits, black tea, waste paper etc. has moved from 124.9 in 2014-15 to 152.8 in 2015-16, registering a growth of 22.3 percent.

INTRODUCTION

Industrial Sector occupies an important position in Indian Economy and has pivotal role to play in the rapid and balanced economic development. Index of Industrial Production (IIP) is one of the tools for measuring the growth of the industrial sector at a particular point of time. The index shows the relative change over time in the volume of industrial production and is an effective tool to measure the trend of current industrial production. IIP can be defined as a single representative figure (an abstract number) to measure the general level of industrial performance in the economy. It is a short-term micro- economic indicator of industrial growth which is used extensively by Government Departments, Industrial Associations, Research Institutes, Academicians etc. for research and policy making.

Due to liberal industrial policy and close proximity of the State to National Capital, the investment in the industrial sector is growing rapidly. There is need to continuously measure the growth of industrial sector with a view to assess and plan the industrial development schemes in the State. IIP is an effective indicator to assess the performance of State economy under industrial sector over a period of time. The need to prepare IIP was also felt to facilitate comparative studies on performance of various States/ UTs in the industrial sector and to bring uniformity in selection of items basket and preparation of weighting diagram, formula with a common methodology for preparation of IIP.


At the National level, Central Statistics Office (CSO), Government of India prepares all India Index of Industrial Production. The Department of Economic and Statistical Analysis, Haryana is preparing Index of Industrial Production of Haryana since the year 1971-72. A number of State Directorates of Economic & Statistics are also engaged in compiling the State level Index of Industrial Production. The Govt. of India has constituted a Technical Advisory Committee (TAC) for an in-depth examination of various technical issues such as identification of representative items basket for individual State, development of corresponding weighting diagram with an appropriate linkage with the weighting diagram of all India's Index of Industrial Production etc. The TAC resolves technical issues relating to IIP and provides technical guidance in the matter of shifting the base year of current series to new series.

The recommendations of the Technical Advisory Committee on comparable Index of Industrial Production are examined by the Central Statistics Office (CSO), Govt. of India and the guidelines on compilation of State level Index of Industrial Production are prepared. According to criteria laid down in the guidelines issued by CSO, the Department of Economic

and Statistical Analysis, Haryana prepared the comparable State level Index of Industrial Production with 2011-12 as base year.

In the present report, the State indices of Industrial Production for Manufacturing and Electricity Sectors for the years 2012-13 to 2015-16 with base year 2011-12 have been given. The General Index of Industrial Production for the series with base year 2011-12 is as under:-

METHODOLOGY

Scope and Coverage

The Index of Industrial Production (IIP) is prepared as per National Industrial Classification (NIC) 08 for manufacturing and electricity sectors. The manufacturing sector covers the industries registered under section 2m (i) and 2m (ii) of the factory Act, 1948 and functioning within jurisdiction of Haryana State. The section 2m (i) refers to the units employing 10 or more workers with power and section 2m (ii) refers to the units employing 20 or more workers without power on any day of the preceding twelve months.

Base Year

To capture the changes in the industrial sector, the State series of IIP is revised from time to time by dropping obsolete items, including the new items in the items basket and also by shifting the base year to a more recent one. The current State series of IIP has been revised by shifting its base year from 2004-05 to 2011-12 under the overall guidance of Central Statistics Office, Govt. of India, New Delhi.

The methodology for compiling an index of industrial production is two fold. The first stage is to identify and select the items to be included in the items basket which could monitor and reflect the performance of the industrial sector. The second stage is to allocate the weights to the items included in the items basket.

The State level IIP with base year 2011-12 covers two major industrial sectors viz manufacturing (Registered) and electricity. Mining and Quarrying sector has been excluded due to its insignificant contribution in GSDP which was 0.04 percent in 2011-12 in the State. For selection of items weightage of each item in the base year has been determined. For this purpose total weight has been taken as 1000. The total weight of 1000 has been first distributed to registered manufacturing and electricity sectors on the basis of Gross Value Added of each sector for the base year 2011-12. For manufacturing sector, the weights of registered manufacturing sector have further been distributed to 2 digit industry groups (10-32) of NIC 2008. Previously, CSO (IS Wing), Kolkata used to explain the methodology, selection of item basket and preparation of weighting diagram and the States / UTs are to prepare item basket and weighting diagram etc. but many States / UTs could not do it properly and so this time CSO (IS Wing), Kolkata has selected the item basket and prepared weighting diagram and also prepared the list of factories (both selected and reserved) and provided to the States / UTs. The electricity sector has been taken as single item.

In all 178 items have been selected for the collection of production data for registered manufacturing sector of the year 2011-12. The selected items have been assigned use based codes i.e. primary goods, capital goods, intermediate goods, infrastructure / construction goods, consumer durables and consumer non-durables.

The selected items have been classified under 3 digit industry groups which in turn have been classified under 2 digit industry group. List of selected items of manufacturing (registered) sector alongwith their respective item weight have been shown in table no 1.1.

Weighting Diagram

For this purpose, total weight has been taken as 1000. The total weight of 1000 has been first distributed to registered manufacturing and electricity sectors on the basis of Gross Value Added (GVA) of each sector for the year 2011-12. The weights of registered manufacturing sector have further been distributed to various 2 digit industry groups 10-32 of NIC-08. After that the 2 digit level weights have further been distributed to represent 3 digit groups. The weighting diagram prepared at item level is further assigned use based categories. Since electricity sector is a single item sector, no apportioning of weight has been done.

Table number 1.2 shows the distribution of weights for the year 2011-12 at sector level. Distribution of weight among selected groups at 2 & 3 digit level of manufacturing sector have been shown in table no. 1.3. Item level distribution of weights of manufacturing sector is available at table no. 1.4.

Selection of units

For selection of industrial units for collection of production data for manufacturing sector the unit wise ASI frame of items selected in the items basket for the year 2011-12 is used. Item-wise frame of Industrial units has been supplied by CSO (ISW), Kolkata. The month-wise data on generation of electricity taken from the website (www.cea.nic.in) of the Central Electricity Authority is used. In this way, 544 industrial units have been selected for collection of data.

Source of data

For manufacturing sector, the Department of Economic & Statistical Analysis, Haryana has created necessary infrastructure for collection of data regularly from industrial units selected for the purpose. The data is collected directly from the selected industrial units by the District Statistical Officers of the department. Efforts are being made to promote online system for data collection. For electricity sector, the necessary data is obtained from the website of Central Electricity Authority www.cea.nic.in.

Computation of Index Number

The change in production of selected units producing the item in the current period viz-a-viz their production in base year is relative change in the production of the item. The total production of an item in the current period is estimated using the relative change in production of the selected units.

The Index is computed by using the Laspeyre's Formula: -

$$I = \frac{\sum R_i W_i}{\sum W_i}$$

Where I = Index Number

R_i = Production relative of ith selected item

W_i = Weight assigned to ith item

∑ = Summation of all items within each
group upto major group (2 digit) level.

The production relative of an item is defined as percentage growth of the production compared to the base year production.

$$R_i = \frac{P_{ci}}{P_{oi}} \times 100$$

Where R_i = Production relative of ith selected item.

P_{ci} = Current year production of ith item

P_{oi} = Base year production of ith item.

The production relatives are thus calculated at product (3 digit) level of NIC code and the ultimate indices are calculated up to major group (2 digit) level. Sectoral Indices and General Index are based on weighted Laspeyre's Index Number.

REVIEW OF INDEX OF INDUSTRIAL PRODUCTION IN HARYANA 2015-2016

The industry sector recorded an annual growth of 4.8 percent in 2015-16 over the previous year as the Index of Industrial Production increased from 120.3 in 2014-15 to 126.1 in 2015-16. The sector wise and group wise details of IIP are given below: -

Manufacturing Sector

The Index of Manufacturing Sector increased from 120.3 in 2014-15 to 128.7 in 2015-16 registering an annual growth of 7.0 percent over the previous year. The Manufacture of machinery equipment (28) recorded the highest growth of 35.8 percent followed by Manufacture of food products (10) which recorded the growth of 25.7 percent. Manufacture of cock and refined petroleum products (19) recorded a growth of 21.4 percent. Manufacture of furniture (31) recorded a growth of 20.0 percent. Manufacture of wood and products of wood, cork (16), Manufacture of chemical and chemical products (20), Manufacture of basic metal (24) and Manufacture of other non-metallic products (23) have recorded negative growth of 4.9 percent, 4.4 percent, 4.1 percent and 3.9 percent, respectively.

Electricity Sector

The Index of Electricity Sector decreased from 119.5 in 2014-15 to 92.5 in 2015-16 registering a negative growth of 22.6 percent over the previous year.

Index of Industrial Production at Major Group (2-digit level) of Manufacturing Sector:-

1 - Manufacture of Food Products (10)

The food manufacturing industries carries a weight of 83.50 in the manufacturing sector. The index of this group increased from 135.4 in 2014-15 to 170.2 in 2015-16, recorded a growth of 25.7 percent. Dried vegetables has highest growth of 514.7 percent followed by Rice basmati exhibited 37.2 percent. Black tea (CTC) 28.6 percent, Sauces; mixed condiments 24.9 percent and butter and other fats have 9.7 percent. The index of refined sugar, Guar Kernel, Mud / Molasses waste, Husk (animal feed), Gola (cattle feed) and milk decreased as compared to previous year.

2 - Manufacture of Beverages (11)

The beverage carries a weight of 12.57 in the manufacturing sector. The index of this group has increased from 78.5 in 2014-15 to 79.3 in 2015-16, recorded a growth of 1 percent. Country liquor and its variant recorded highest growth of 47.2 percent. Soft drink, carbonated beverages other than soda water and beer made from malt recorded a negative growth of 19.0 percent and 18.1 percent respectively.

3 - Manufacture of Tobacco Products (12)

Tobacco group carries a weight of only 0.75 in the manufacturing sector. The index of this group has increased from 112.9 in 2014-15 to 120.8 in 2015-16, recorded a growth of 7.0 percent. Tobacco, chewing (scented or not) in this group recorded positive growth of 8.4 percent. Other shelled nuts have negative growth of 3.0 percent.

3 - Manufacture of Textiles (13)

The textiles industries carry a weight of 40.43 in the manufacturing sector. The index of this group has decreased from 203.8 in 2014-15 to 198.1 in 2015-16 and recorded a negative growth of 2.8 percent. The index of lining cloth, cotton recorded highest growth of 90.9 percent, followed by yarn dyed, cotton, fabrics polyester fibre and carpets and other textile floor covering knotted 11.3 percent, 5.6 percent and 4.2 percent respectively. Carpets and other textile floor covering tufted; cotton, carded or combed has shown negative growth of 18.0 percent and 16.4 percent respectively.

4 - Manufacture of Wearing apparel (14)

The wearing apparel industry has been assigned the weight of 49.68 in the manufacturing sector. The index of this group increased from 119.0 in 2014-15 to 123.2 in 2015-16, recorded a growth of 3.5 percent. The index of cotton garments cloth has recorded a growth of 30.0 percent.

5 - Manufacture of Leather and related products (15)

The leather industries have been allotted a weight of 27.44 in the manufacturing sector. The index of this group has increased 98.9 in 2014-15 to 103.9 in 2015-16, recorded a growth of 5.1 percent. The index of footwear incorporating a protective metal toe-cap, footwear with uppers of leather, other than sport footwear, footwear incorporating a protective metal toe-cap & miscellaneous special footwear and other sports footwear, except skating boots recorded positive growth of 8.5 percent, 5.7 percent and 2.9 percent, respectively in 2015-16.

6 - Manufacture of Wood & products of Wood & Cork, except furniture, Manufacture of Articles of Straw & plaiting materials (16)

The wood industry has been assigned a weight of 3.09 in the manufacturing sector. The index of this group has decreased from 186.3 in 2014-15 to 177.1 in 2015-16, recorded a negative growth of 4.9 percent. The index of wooden chips, wood cutting processed sized and plywood board recorded a growth of 100.9 percent, 45.7 percent and 29.6 percent, respectively.

7 - Manufacture of Paper and paper Products (17)

The paper industries have been assigned the weight of 9.27 in the manufacturing sector. The index of this group has increased from 103.9 in 2014-15 to 119.1 in 2015-16, recorded a growth of 14.7 percent. The index of paper, printing & writing recorded a growth of 34.6 percent. The paper polythene coated and boxes, corrugated sheet have recorded negative growth of 28.9 percent and 16.7 percent respectively.

8 - Printing and Reproduction of Recorded Media (18)

The printing and reproduction of recorded media carry a weight of 4.16 in the manufacturing sector. The index of this group decreased from 160.6 in 2014-15 to 156.7 in 2015-16, recorded a negative growth of 2.4 percent. The index of waste paper and books recorded a negative growth of 6.7 percent and 2.0 percent respectively.

9 - Manufacture of Coke, Refined Petroleum Products (19)

The petroleum industries carry a weight of 0.41 only. The index of this group increased from 91.0 in 2014-15 to 110.5 in 2015-16, recorded a growth of 21.4 percent. The index of nitrogen liquid & oxygen liquid recorded a growth of 38.6 percent and 12.2 percent respectively. The index of argon gas recorded negative growth of 6.4 percent.

10 - Manufacture of Chemical and Chemical Products (20)

The chemical and chemical products industry group carries a weight of 23.19 in the manufacturing sector. The index of this group decreased from 113.7 in 2014-15 to 108.7 in 2015-16, recorded a negative growth of 4.4 percent. The index of primer, stoving, synthetic and paint recorded a growth of 4.2 percent & 2.4 percent respectively. The index of rexin, bitumen and urea recorded a negative growth of 88.8 percent, 19.3 percent and 14.9 percent respectively.

11 - Manufacture of Pharmaceuticals, Medicinal Chemical and Botanical Products (21)

The pharmaceuticals industries carry a weight 13.34 in the manufacturing sector. The index of this group increased from 120.9 in 2014-15 to 132.2 in 2015-16 with a growth of 9.4 percent. The index of vaccine for veterinary medicine and allopathic ointments recorded a growth of 52.6 percent and 46.0 percent respectively. The bandage including adhesive gauze bandage recorded a negative growth of 53.0 percent.

12 - Manufacture of Rubber and Plastics Products (22)

The rubber and plastic industries have been assigned a weight of 22.53. The index of this group increased from 86.8 in 2014-15 to 90.3 in 2015-16 with a growth of 4.1 percent. The index of button moulds & other parts of buttons; button plastic and unsaturated polyester resin recorded a positive growth of 61.5 percent, 61.3 percent and 9.7 percent, respectively. The index of conveyor belts, plastic bag and parts of footwear recorded a negative growth of 23.6 percent, 11.0 percent and 7.4 percent respectively.

13 - Manufacture of other Non-Metallic mineral Products (23)

This industry group carries a weight of 18.73 in the manufacturing sector. The index of this group has decreased from 112.6 in 2014-15 to 108.2 in 2015-16 and recorded a negative growth of 3.9 percent. The index of white cement, asbestos corrugated sheet and fibre glass sheet / board recorded a growth of 53.0 percent, 17.7 percent and 8.3 percent respectively. The index of stone dust / powder and Portland cement recorded a negative growth of 45.3 percent and 37.8 percent respectively in this group.

14 - Manufacture of Basic Metals (24)

The basic metal group carries a weight of 48.60 in the manufacturing sector. The index of this group has decreased from 104.7 in 2014-15 to 100.4 in 2015-16 with a negative growth of 4.1 percent. The index of aluminum circles alloyed, refined copper wire bars and brass copper zinc base alloys recorded a growth of 57.7 percent, 55.1 percent and 10.2 percent respectively. The index of tubes, pipes of stainless steel, CR sheet and aluminum alloys profile follow recorded a negative growth of 45.5 percent, 23.0 percent and 14.0 percent respectively.

15 - Manufacture of Fabricated Metal Products, Except Machinery and Equipment (25)

The fabricated metal products industry carries a weight of 32.54 in the manufacturing sector. The index of this group decreased from 145.9 in 2014-15 to 123.5 in 2015-16, recorded a negative growth of 15.4 percent. The index of heavy machinery for fabrication recorded a growth of 234.3 percent in this group. The index of utensils of iron or steel enameled, machine screw iron & steel and LPG cylinders of iron and steel recorded a negative growth of 23.5 percent, 18.6 percent and 13.0 percent respectively in this group.

16 - Manufacture of Computer, Electronic and Optical Products (26)

This industry group carries a weight of 11.15 in the manufacturing sector. The index of this group has increased from 121.2 in 2014-15 to 125.2 in 2015-16, recorded a growth of 3.2 percent. The index of biological microscope recorded the highest growth of 59.9 percent followed by instruments and apparatus for telecommunications with 15.8 percent. The index of electro-diagnostic apparatus used in medical, surgical, dental and electronic pcb / micro circuit has declined by 75.3 percent and 57.3 percent respectively.

17 - Manufacture of Electrical Equipment (27)

The electrical equipment industries carry a weight of 58.22 in the manufacturing sector. The index of this industry group increased from 115.1 in 2014-15 to 118.2 in 2015-16, recorded a growth of 2.6 percent. The index of parts of electricity distribution or control apparatus recorded the highest growth of 23.9 percent followed by pvc insulated cable with a growth of 16.3 percent. The index of wire stainless steel electrode quality and motor fan recorded a negative growth of 41.8 percent and 32.7 percent respectively.

18 - Manufacture of Machinery and Equipment n.e.c. (28)

The machinery equipment industry carries a weight of 106.63 in the manufacturing sector. The index of this group has increased from 125.3 in 2014-15 to 170.3 in 2015-16 with a growth of 35.8 percent. The air conditioner-window / wall has recorded highest growth of 605.1 percent followed by offset printing machines 18.1 percent in this group where as the growth of self propelled tamping machines & road rollers and book binding machinery declined by 80.8 percent and 68.2 percent respectively.

19 - Manufacture of Motor Vehicles, Trailers and Semi-Trailers (29)

This industry group carries highest weight of 230.72 in the manufacturing sector. The index of this group increased from 109.9 in 2014-15 to 111.4 in 2015-16, recorded a growth of 1.4 percent. The air break sets in this group has recorded a growth of 28.6 percent followed by trailers and semi trailers of the caravan type for housing and camping 14.5 percent. Exhaust tubes and parts of petrol engine for motor vehicles recorded a negative growth of 67.9 percent and 7.5 percent respectively.

20 - Manufacture of Other Transport Equipment (30)

The other transport equipment industry has assigned a weight of 121.25 in the manufacturing sector. The index of this group increased from 115.1 in 2014-15 to 116.2 in 2015-16, recorded a growth of 1.0 percent only. Railway / tramway tracks and parts & accessories of motor cycles recorded a growth of 37.7 percent and 2.3 percent respectively.


21 - Manufacture of Furniture (31)

The furniture industry carries a weight of 0.41 only in the manufacturing sector. This group contained only one product i.e. furniture and fixture wooden with a growth of 20.0 percent.


22 - Other Manufacturing (32)

The other manufacturing industry group has been assigned a weight of 9.21 in the manufacturing sector. The index of this group has increased from 135.8 in 2014-15 to 138.7 in 2015-16 with a growth of 2.2 percent. The staplers, ophthalmic lens and sports goods rubber recorded a growth of 67.4 percent, 40.9 percent and 6.7 percent respectively. The ointments imitation, electricity and pen body plastic has recorded a negative growth of 44.1 percent, 22.6 percent and 12.2 percent respectively.

 (Base Year 2011-12)




**G-2.2 Index of Industrial Production in Haryana

G-2.3 Index of Industrial Production in Haryana Manufacturing Sector





INDEX OF INDUSTRIAL PRODUCTION IN HARYANA

Use-Based Classification

The Use-Based Classification represents the changing pattern of customer's needs, based on the tastes and habits towards the purchase of industrial products. The industrial products have been clubbed into four major groups comprising of Basic Goods Industries, Capital Goods Industries, Intermediate Goods Industries and Consumer Goods Industries with a view to analyse the movement of growth rate of different groups of industries and their achievements within the frame of organized sector.

The Use-Based Classification represents the classification of the industrial products according to the product applications. Each industry group reflects the variations in the production of a particular class of industries based on product usage. The industries are classified into six groups viz., Primary Goods, Capital Goods, Intermediate Goods, Infrastructure/Construction Goods, Consumer Durables and Consumer Non-Durables Goods. Concepts and definitions for Use-Based Classification are given below.

(i) Primary Goods

Only such goods which are directly obtained from natural sources and used for further processing and consumption in manufacturing and power generating activities.

(ii) Capital Goods

Plants, machinery and goods used for further investments.

(iii) Infrastructure/Construction Goods

Finished goods which are primarily used in infrastructure industry or construction industry as an input. This category has been created to precisely items which could not be classified under consumer durables or intermediate goods

(iv) Intermediate Goods

Any good/product produced as incomplete product or which goes as input in production for further finishing or forming a part of a product.

(v) Consumer Durables

Products directly used by consumers and having a longer durability (more than 2 to 3 years).

(vi) Consumer Non-Durables

Products that are directly used by consumers and cannot be preserved for long periods.

The share of each use-based industry group to the industry sector of the State and the number of industrial groups and items covered representing the use-based groups are as under: -



During the year 2015-16, Consumer Non-Durable Industries recorded highest growth of 22.3 percent, followed by Consumer Durables Industries 14.0 percent. Capital Goods industries has stable growth. Primary Goods Industries, Intermediate Goods Industries and Infrastructure/ Construction Goods industries recorded a negative growth of 21.2 percent, 6.9 percent and 2.0 percent, respectively.

A. Primary Goods Industries

Primary Goods Industries which has been assigned the weight of 83.59 recorded a negative growth of 21.2 percent during the year 2015-16 as compared to the previous year. The index of this industry group decreased from 122.8 in 2014-15 to 96.7 in 2015-16. Argon gas, Liquid Nitrogen, Urea, Bitumen, LPG and generation of electricity are the major products in this group. Liquid Nitrogen and Liquid oxygen recorded a notable increase during the year 2015-16. Index of

Electricity, Bitumen, Urea, LPG cylinders of iron and steel and Argon Gas have recorded negative growth over the previous year.

B. Capital Goods Industries

The Index of Capital Goods Industries having weight of 312.42 showing a stable growth of 115.4 in 2014-15 to 115.4 in 2015-16. Conveyer belts, tyre tractor, link forging, optical components, biological microscope, fabricated metal products, acephate/speedometer, hydraulic equipment, diamond tools, cultivators, spring pins, mini bus, axel and shock absorbers are major products of this group. Heavy machinery for fabrication recorded the highest growth of 234.3 percent followed by tracks, railway/tramway 37.7 percent and conveyor belts 36.5 percent. Self-propelled tamping machine and road rollers, electro-diagnostic apparatus used in medical, surgical, dental, exhaust tubes and wire stainless steel, electrode quality have recorded a negative growth in this group.

C. Intermediate Goods Industries

The Intermediate Goods Industries carry a weight of 108.14. The Index of this industry group has decreased from 117.8 in 2014-15 to 109.7 in 2015-16 recorded a decreased of 6.9 percent. Mud/molasses waste, wooden chips, plywood board, stone dust powder, hot rolled plates, cast iron, utensils iron or steel enameled, seat for motor vehicle, gear case assemblies and medical surgical or laboratory sterilizers are major products in this group. The manufacturing of aluminum circle alloyed recorded the highest growth of 577.0 percent followed by wood cutting processed sized 45.7 percent and plywood board 29.6 percent during the year 2015-16 over the previous year. Tubes/pipes of stainless steel, stone dust powder, mud/molasses waste and CR Sheets have recorded negative growth during the year over previous year.

D. Infrastructure/Construction Goods Industries

Infrastructure/construction Goods Industries has captured the weight of 49.01. This industry group has recorded a negative growth of 2.0 percent during the year 2015-16 as the index of this group decreased from 112.0 in 2014-15 to 109.8 in 2015-16. Paint, ceramic tiles, white cement, cold finished/formed of flat rolled products, pvc insulated cables and scrap cast iron etc. are major products in this group. White cement, pvc insulated cable recorded a positive growth of 53.0 percent and 16.3 percent. Ceramic tiles, portland cement, tiles, flagstones, bricks and similar articles of cement, concrete or artificial stone and cold finished/formed of flat rolled products recorded a negative growth in this group.

E. Consumer Durables Industries


The Consumer Durable Goods Industries has been assigned the weight of 335.27. The Index of this industry group has increased from 124.6 in 2014-15 to 142.1 in 2015-16 recorded a growth of 14.0 percent. Cotton fabrics, manmade fibre fabrics, blankets, artificial far hand bag, printing/writing paper, books, plastic button, audio cd/dvd player, ac motor car, water pump, staplers, silencer and wooden furniture and fixture etc. are the main products of this group. Manufacturing of Air conditioner-window/wall recorded the highest growth of 605.1 percent followed by cotton lining cloth 90.9 percent, button moulds and other parts of buttons 61.5 percent, plastic button 61.3 percent and ophthalmic lens 40.9 percent during the year 2015-16 as compared to 2014-15. The manufacturing of Rexin, electronic pcb/micro circuit, ornaments imitation, and electric meter others have recorded negative growth of 88.8 percent, 57.3 percent, 44.1 percent and 33.0 percent respectively.

F. Consumer Non -Durables Industries

The Consumer Non-Durable Goods Industries has been allotted the weight of 111.57. The Index of this industry group has increased from 124.9 in 2014-15 to 152.8 in 2015-16 and recorded a growth of 22.3 percent as compared to previous year. Dried vegetables, milk, rice basmati, sugar, biscuit, black tea, gola, rectified spirit, waste paper, allopathic ointments and filters for beverages etc. are the major products of this group. The manufacturing of dried vegetables recorded the highest growth of 514.7 percent followed by vaccine for veterinary medicine 52.6 percent and country liquor & its variant 47.2 percent during the year 2015-16 over previous year. Refined sugar, guar kernel, bandage including adhesive gauze bandage, husk, beer made from malt have recorded negative growth.



(Base Year 2011-12)




**G-3.3 Index of Industrial Production in Haryana

(Base Year 2011-12)**




**G-3.4 Index of Industrial Production in Haryana Intermediate Goods Industries
(Base Year 2011-12)**




**G-3.5 Index of Industrial Production in Haryana

(Base Year 2011-12)**


