The Index of Industrial Production (IIP) is one of the prime short-term micro economic indicators of the economic development to measure trend in the behavior of the industrial performance over a period of time in comparison to a chosen base year. It indicates the relative change of physical production in the field of industries during a specified year as compared to previous year.

The Department of Economic and Statistical Affairs, Haryana has been compiling the Index of Industrial Production for Haryana State under the guidance of the National Statistical Office (NSO), Govt. of India since 1971-72 and publishes its report on annual basis. The present report containing information relating to IIP from the year 2019-20 is the third issue of the series with base year 2011-12. This Index of Industrial Production of Haryana State relates to Manufacturing and Electricity Sectors with an analysis of use-based classification of the index numbers.

This report provides a useful information for planners, industrialists and researchers etc. interested in the industrial development of the State.

I take this opportunity to thank the National Statistical Office, Government of India for providing valuable guidance. Efforts made by the District Statistical Offices for collection of production data from various industrial units are also acknowledged. The cooperation extended by various industrial units of the State for providing required production data for computation of IIP are appreciated and acknowledged.

This report has been prepared by Sh. Bijender Kumar, Research Officer with the help of Sh. EXECUTIVE SUMMARY

Industrialization plays a vital and crucial role in the economic development of an economy. It accelerates economic growth of a State and thereby increases the contribution of Industry Sector in the State Domestic Product by way of increase in the production and employment. Index of Industrial Production (IIP) is one of the prime indicators of the economic development for measurement of trend in the industrial production over a period of time with reference to a chosen base year.

The Index of Industrial Production for the State is compiled in accordance with the guidelines of the National Statistical Office (NSO), Govt. of India. In Part-I of the report, the detailed methodology, sources of data and computation of index numbers have been presented.

A total of 178 items have been selected from Registered Manufacturing sector for the year 2011-12. Electricity has been taken as a single item. Mining and Quarrying sector has been excluded due to its insignificant contribution in GSDP which was 0.04% in 2011-12 in the State. The total weight of Industrial Sector has been taken as 1000 which has been distributed to Registered Manufacturing & Electricity sectors. The weights of Registered Manufacturing sector have further been distributed at 2/3 digit as well as item level as per criteria suggested by NSO. Production data of selected items are collected directly from the selected factories in the State.

Presently, Index of Industrial Production is being prepared in the State with 2011-12 base year and covers Manufacturing and Electricity sectors. Index number has been calculated at sector level, group level (2 digits) and item level. The same has been presented in the report accordingly. Review of index numbers for the year 2019-20 has also been given in the report.

The General Index of Industrial Production with 2011-12 base year increased from 141.9 in 2018-19 to 154.4 in 2019-20, registering a growth of 8.8 percent. The Index of Manufacturing sector which carries the highest weight in IIP rose from 144.7 in 2018-19 to 166.4 in 2019-20, exhibiting a growth of 15.0 percent. The Index of Electricity sector indicates a negative growth of 31.9 percent as it decreased from 105.7 in 2018-19 to 72.0 in 2019-20.

In last part of the report, the use-based classification which represents the changing pattern of customer's needs, based on taste and habits towards the purchase of industrial product has been given. Review of the use-based classification for the year 2019-20 has also been given therein. The report elaborates that the Index of Primary Goods Industries like argon gas, urea, bitumen, LPG cylinder of iron and steel, electricity etc. has decreased from 111.8 in 2018-19 to 85.4 in 2019-20 which recorded a decrease of 23.6 percent.

The Index of Capital Goods Industries like conveyor belts, tractor tyres, link forging, optical components, acephate/speedometer, diamond tools, spring pins etc. increased from 162.5 in 2018-19 to 203.6 in 2019-20, which recorded an increase of 25.3 percent.

The Index of Intermediate Goods Industries like plywood boards, wooden chips, cast iron, stone dust powder, motor vehicle seats etc. has increased from 127.1 in 2018-19 to 139.5 in 2019-20, recording a growth of 9.8 percent.

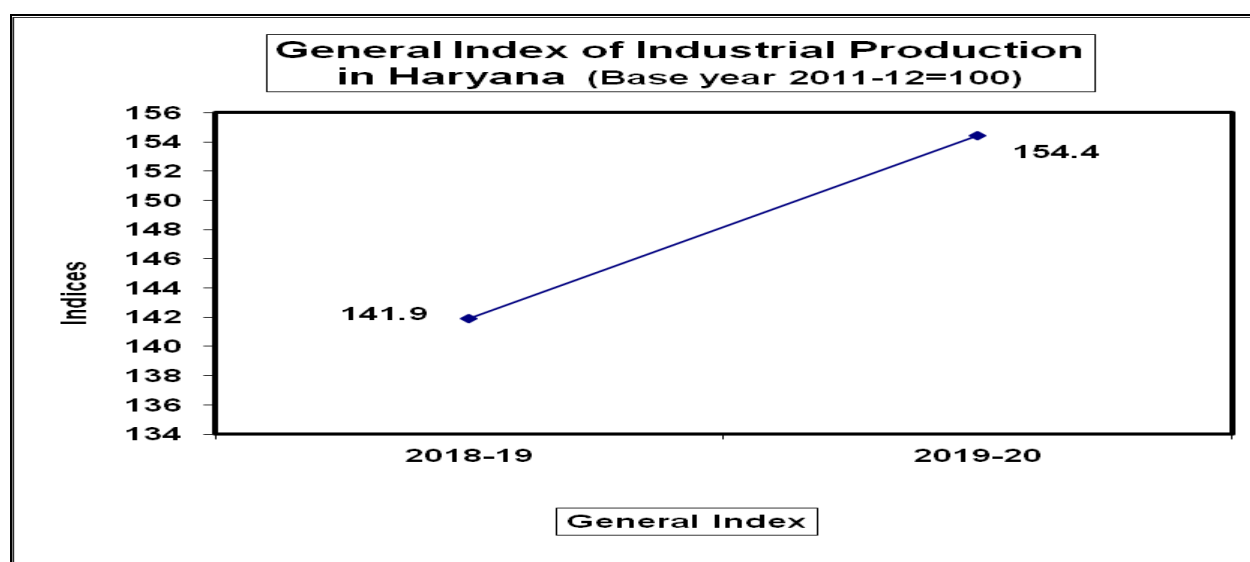
The Index of Infrastructure/Construction Goods Industries like paints, ceramic tiles, scrap cast iron etc. has increased from 145.9 in 2018-19 to 126.7 in 2019-20, recording a negative growth of 13.2 percent.

The Index of Consumer Durables Industries like cotton fabrics, blankets, artificial fur hand bags, books, rexin, button plastic, glass components, water pump, AC motor car etc. has increased from 161.9 in 2018-19 to 163.0 in 2019-20, registering a growth of 0.7 percent.

The Index of Consumer Non-Durables Industries like dried vegetables, milk, rice basmati, sugar, biscuits, black tea, waste paper etc. has decreased from 64.2 in 2018-19 to 68.9 in 2019-20, which registering a growth of 7.3 percent.

The General Index of Industrial Production for the series with base year 2011-12 is as under:-

INTRODUCTION

Industrial sector occupies an important position in Indian Economy and has pivotal role to play in the rapid and balanced economic development. Index of Industrial Production (IIP) is one of the tools for measuring the growth of the industrial sector at a particular point of time. The index shows the relative change over time in the volume of industrial production and is an effective tool to measure the trend of current industrial production. IIP can be defined as a single representative figure (an abstract number) to measure the general level of industrial performance in the economy. It is a short-term micro- economic indicator of industrial growth which is used extensively by Government Departments, Industrial Associations, Research Institutes, Academicians etc. for research and policy making.

Due to liberal industrial policy and close proximity of the Haryana State to National Capital, the investment in the industrial sector is growing rapidly. There is need to continuously measure the growth of industrial sector with a view to assess and plan the industrial development schemes in the State. IIP is an effective indicator to assess the performance of State economy under industrial sector over a period of time. The need to prepare IIP was also felt to facilitate comparative studies on performance of various States/ UTs in the industrial sector and to bring uniformity in selection of items basket and preparation of weighting diagram, formula with a common methodology for preparation of IIP.

At the National level, National Statistical Office (NSO), Government of India prepares all India Index of Industrial Production. The Department of Economic and Statistical Affairs, Haryana is preparing Index of Industrial Production of Haryana since the year 1971-72. A number of State Directorates of Economics & Statistics are also engaged in compiling the State level Index of Industrial Production. The Govt. of India has constituted a Technical Advisory Committee (TAC) for an in-depth examination of various technical issues such as identification of representative items basket for individual State, development of corresponding weighting diagram with an appropriate linkage with the weighting diagram of all India's Index of Industrial Production etc. The TAC resolves technical issues relating to IIP and provides technical guidance in the matter of shifting the base year of current series to new series.

The recommendations of the Technical Advisory Committee on comparable Index of Industrial Production are examined by the NSO and the guidelines on compilation of State level Index of Industrial Production are prepared. According to criteria laid down in the guidelines issued by NSO, the Department of Economic and Statistical Affairs, Haryana prepared the comparable State level Index of Industrial Production with base year 2011-12 for the year 2019-20.

METHODOLOGY

Scope and Coverage

The Index of Industrial Production (IIP) is prepared as per National Industrial Classification (NIC)-2008 for manufacturing and electricity sectors. The manufacturing sector covers the industries registered under Section 2 (m) (i) and 2 (m) (ii) of the factory Act, 1948 and functioning within jurisdiction of Haryana State. The section 2 (m) (i) refers to the units employing 10 or more workers with power and Section 2 (m) (ii) refers to the units employing 20 or more workers without power on any day of the preceding twelve months.

Base Year

To capture the changes in the industrial sector, the State series of IIP is revised from time to time by dropping obsolete items, including the new items in the items basket and also by shifting the base year to a more recent one. The current State series of IIP has been prepared on its base year 2011-12 under the overall guidance of National Statistical Office (NSO), Govt. of India, New Delhi.

The two stage methodology has been adopted for compiling an Index of Industrial Production. The first stage is to identify and select the items to be included in the items basket which could monitor and reflect the performance of the industrial sector. The second stage is to allocate the weights to the items included in the items basket.

The State level IIP with base year 2011-12 covers two major industrial sectors viz manufacturing (Registered) and electricity. Mining and Quarrying sector has been excluded due to its insignificant contribution in GSDP which was 0.04 percent in 2011-12 in the State. For selection of items weightage of each item in the base year has been determined. For this purpose total weight has been taken as 1000. The total weight of 1000 has been first distributed to registered manufacturing and electricity sectors on the basis of Gross Value Added of each sector for the base year 2011-12. For manufacturing sector, the weights of registered manufacturing sector have further been distributed to 2 digit industry groups (10-32) of NIC 2008. Previously, NSO (IS Wing), Kolkata used to explain the methodology, selection of items basket and preparation of weighting diagram and the States / UTs are to prepare items basket and weighting diagram etc. but many States / UTs could not do it properly, therefore, NSO (IS Wing), Kolkata has selected the items basket and prepared weighting diagram and also prepared the list of factories (both selected and reserved) and provided to the States / UTs. The electricity sector has been taken a single item.

In all 178 items have been selected for the collection of production data for registered manufacturing sector of the base year 2011-12. The selected items have been assigned use based

codes i.e. primary goods, capital goods, intermediate goods, infrastructure / construction goods, consumer durables and consumer non-durables.

The selected items have been classified under 3 digit industry groups which in turn have been classified under 2 digit industry groups. List of selected items of manufacturing (registered) sector alongwith their respective item weight have been shown in table no 1.1.

Weighting Diagram

For this purpose, total weight has been taken as 1000. The total weight of 1000 has been first distributed to registered manufacturing and electricity sectors on the basis of Gross Value Added (GVA) of each sector for the year 2011-12. The weights of registered manufacturing sector have further been distributed to various 2 digit industry groups 10-32 of NIC-08. After that, the 2 digit level weights have further been distributed to represent 3 digit groups. The weighting diagram prepared at item level is further assigned use-based categories. Since electricity sector is a single item sector, no apportioning of weight has been done.

Table number 1.2 shows the distribution of weights for the year 2011-12 at sector level. Distribution of weight among selected groups at 2 & 3 digit level of manufacturing sector have been shown in table no. 1.3. Item level distribution of weights of manufacturing sector is available at table no. 1.4.

Selection of units

For selection of industrial units for collection of production data for manufacturing sector, the unit wise ASI frame of items selected in the items basket for the year 2011-12 is used. Item-wise frame of Industrial units has been supplied by NSO (ISW), Kolkata. The month-wise data on generation of electricity taken from the website (www.cea.nic.in) of the Central Electricity Authority is used. In this way, 544 industrial units have been selected for collection of data.

Source of data

For manufacturing sector, the Department of Economic & Statistical Affairs, Haryana has created necessary infrastructure for collection of data regularly from industrial units selected for the purpose. The data is collected directly from the selected industrial units by the District Statistical Officers of the department. Efforts are being made to promote online system for data collection. For electricity sector, the necessary data is obtained from the website of Central Electricity Authority www.cea.nic.in.

Computation of Index Number

The change in production of selected units producing the item in the current period viz-a-viz their production in base year is relative change in the production of the item. The total production of an item in the current period is estimated using the relative change in production of the selected units.

The Index is computed by using the Laspeyre's Formula: -

$$I = \frac{\sum R_i W_i}{\sum W_i}$$

Where I = Index Number

R_i = Production relative of ith selected item

W_i = Weight assigned to ith item

\sum = Summation of all items within each group upto major group (2 digit) level.

The production relative of an item is defined as percentage growth of the production compared to the base year production.

$$R_i = \frac{P_{ci} \times 100}{P_{oi}}$$

Where R_i = Production relative of ith selected item.

P_{ci} = Current year production of ith item

P_{oi} = Base year production of ith item.

The production relatives are thus calculated at product (3 digit) level of NIC code and the ultimate indices are calculated up to major group (2 digit) level. Sectoral Indices and General Index are based on weighted Laspeyre's Index Number.

REVIEW OF INDEX OF INDUSTRIAL PRODUCTION IN HARYANA 2019-20

The industry sector recorded an annual growth of 8.8 percent in 2019-20 over the previous year as the Index of Industrial Production increased from 141.9 in 2018-19 to 154.4 in 2019-20. The sector-wise and group-wise details of IIP are given below: -

Manufacturing Sector

The Index of Manufacturing sector increased from 144.7 in 2018-19 to 166.4 in 2019-20 registering an annual growth of 15.0 percent over the previous year. The manufacture of electrical equipment (27) recorded the highest growth of 50.9 percent followed by Other manufacturing (32) recorded a growth of 49.9 percent, Manufacture of motor vehicles (29) recorded a growth of 26.2 percent, Manufacture of coke and refined petroleum products (19) recorded a growth of 16.6 percent, Manufacture of furniture (31) recorded a growth of 13.5 percent, Manufacture of computer, electronic and optical products (26) recorded a growth of 13.1 percent, Manufacture of rubber and plastic products (22) recorded a growth of 12.7 percent, Manufacture of fabricated metal products except machinery and equipment (25) recorded a growth of 8.7 percent, Manufacture of other non metallic products (23) recorded a growth of 8.5 percent, Manufacture of food products (10) recorded a growth of 4.8 percent, Manufacture of wearing apparel (14) recorded a growth of 1.1 percent, Manufacture of beverages (11) recorded a growth of 0.5 percent, Manufacture of paper and paper products (17) recorded a growth of 0.5 percent, Manufacture of pharmaceuticals, medicinal chemical and botanical products (21) recorded a growth of 0.2 percent respectively.

Electricity Sector

The Index of Electricity Sector decreased from 105.7 in 2018-19 to 72.0 in 2019-20 registering a negative growth of 31.9 percent over the previous year.

Index of Industrial Production at Major Group (2-digit level) of Manufacturing Sector:-

1 - Manufacture of Food Products (10)

The food manufacturing industries carry a weight of 83.50 in the Manufacturing sector. The index of this group increased from 56.4 in 2018-19 to 59.1 in 2019-20 recorded a growth of 4.8 percent. The index of milk has recorded a highest growth of 120.9 percent followed by black tea (CTC) 91.3 percent, rice basmati 39.3 percent, sugar confectionery (including white chocolate), not containing cocoa; vegetables fruit nuts, fruit- peel and other parts of plants,

preserved by sugar 20.7 percent, biscuits 15.0 percent, sugar 0.7 percent. The index of gola (cattle feed), dried vegetables, refined sugar, sauces; mixed condiments; mustard flour and meal; prepared mustard, husk animal (feed), skim milk and whey powder, gaur kernel, other vegetable oils and fats, refined, mud molasses waste, butter and other fats and oils derived from milk of cattle recorded a negative growth respectively.

2 - Manufacture of Beverages (11)

The beverage industry carries a weight of 12.57 in the Manufacturing sector. The index of this group has increased from 90.7 in 2018-19 to 91.2 in 2019-20 recorded a growth of 0.6 percent. The index of rectified spirit has recorded a highest growth of 21.7 percent followed by soft drink, carbonated beverages other than soda water 1.8 percent, country liquor and its variant recorded 0.2 percent. The index of bear made from malt, whether or not roasted recorded a negative growth respectively.

3 - Manufacture of Tobacco Products (12)

The Tobacco group carries a weight of only 0.75 in the Manufacturing sector. The index of this group has decreased from 289.0 in 2018-19 to 246.7 in 2019-20, recorded a negative growth of 14.6 percent. The index of other shelled nuts and Tobacco, chewing (scented or not) in this group recorded a negative growth respectively.

4 - Manufacture of Textiles (13)

The textiles industries carry a weight of 40.43 in the Manufacturing sector. The index of this group has decreased from 161.1 in 2018-19 to 145.9 in 2019-20 recorded a negative growth of 9.4 percent. The index of yarn of wool, containing 85% or more by weight of wool, not put up for retail sale recorded highest growth of 180.6 percent, carpets and other textile floor covering, tufted 169.3 percent, cotton carded or combed 158.6 percent, cotton fabrics, 118.2 percent, lining cloth, cotton 66.9 percent, carpets and other textile floor covering knotted 1.9 percent. The index of fabrics, polyester fiber, terry towel, fabrics, mixed, fabrics cotton, fabrics/cloth, man-made fiber fabrics, yarn dyed, cotton and blankets recorded a negative growth respectively.

5 - Manufacture of Wearing Apparel (14)

The wearing apparel industry has been assigned the weight of 49.68 in the 21 Manufacturing sector. The index of this group increased from 223.8 in 2018-19 to 226.2 in 2019-20 recorded a positive growth of 1.1 percent. The index of garments made up of textile fabrics impregnated has recorded a highest growth of 112.5 percent. The index of garments made up of textile fabrics coated with other materials and garments cloth, cotton recorded a negative growth respectively.

6 - Manufacture of Leather and related Products (15)

The leather industries have been allotted a weight of 27.44 in the Manufacturing sector. The index of this group has decreased 112.5 in 2018-19 to 108.9 in 2019-20 recorded a negative growth of 3.2 percent. The index of hand bag, artificial fur recorded a highest growth of 11.6 percent followed by footwear with uppers of leather, other than sports footwear, footwear incorporating a protective metal toe-cap and misc. special footwear recorded a growth of 10.0 percent, footwear incorporating a protective metal toe-cap, except those covered in subclass 29320 recorded 0.0 percent. The index of other sports footwear, except skating boots recorded a negative growth 20.9 percent respectively.

7 -Manufacture of Wood & Products of Wood & Cork, except Furniture, Manufacture of Articles of Straw & Plaiting Materials (16)

The wood industry has been assigned a weight of 3.09 in the Manufacturing sector. The index of this group has decreased from 324.2 in 2018-19 to 312.0 in 2019-20 recorded a negative growth of 3.8 percent. The index of wooden chips recorded a highest growth of 302.7 percent followed by plywood decorative growth of 6.7 percent. The index of plywood board, plywood, wood cutting processed sized recorded negative growth respectively.

8 - Manufacture of Paper and Paper Products (17)

The paper industries have been assigned the weight of 9.27 in the Manufacturing sector. The index of this group has increased from 129.6 in 2018-19 to 130.3 in 2019-20 recorded a positive growth of 0.5 percent. The index of boxes, corrugated sheet recorded a highest growth of 224.7 percent followed by paper, printing & writing growth of 5.6 percent. The index of paper polythene coated, sheet laminated plastic recorded a negative growth respectively.

9 - Printing and Reproduction of Recorded Media (18)

The printing and reproduction of recorded media carry a weight of 4.16 in the Manufacturing sector. The index of this group decreased from 223.1 in 2018-19 to 185.9 in 2019-20 recorded a negative growth of 16.7 percent. The index of books and waste paper recorded a negative growth of 11.1 percent and 75.8 percent respectively.

10 - Manufacture of Coke, Refined Petroleum Products (19)

The petroleum industries carry a weight of 0.41 only. The index of this group increased from 150.4 in 2018-19 to 175.4 in 2019-20, recorded a positive growth of 55.4 percent. The index of nitrogen liquid recorded highest growth of 55.9 percent. The index of oxygen liquid & argon gas recorded a negative growth of 1.7 and 64.4 percent respectively.

11 - Manufacture of Chemical and Chemical Products (20)

The chemical and chemical products industry group carries a weight of 23.19 in the Manufacturing sector. The index of this group decreased from 151.9 in 2018-19 to 145.3 in 2019-20 recorded a negative growth of 4.3 percent. The index of urea recorded a highest growth of 30.2 percent followed by primer, stoving, synthetic recorded a growth of 6.3 percent, paint recorded a growth of 3.4 percent. The index of bitumen, paint, plastics emulsion, recorded a negative growth respectively.

12 - Manufacture of Pharmaceuticals, Medicinal Chemical and Botanical Products (21)

The pharmaceuticals industries carry a weight 13.35 in the Manufacturing sector. The index of this group increased from 92.5 in 2018-19 to 92.6 in 2019-20 with a positive growth of 0.1 percent. The index ointments, allopathic recorded a highest growth of 49.0 percent followed by anti diabetic drugs excl. insulin (metformin, pioglitazone, glimepiride etc.) recorded a growth of 9.5 percent, glues and gelatin, peptones and their derivatives and related products; caseinates and other casein derivatives; albuminates and other albumin derivatives recorded a growth of 6.2 percent. The vaccine for veterinary medicine, bandage including adhesive gauze bandage recorded negative growth respectively.

13 - Manufacture of Rubber and Plastics Products (22)

The rubber and plastic industries have been assigned a weight of 22.53. The index of this group increased from 105.1 in 2018-19 to 118.5 in 2019-20 with a positive growth of 12.7 percent. The index of unsaturated polyester resin recorded highest growth of 91.3 percent followed by parts of footwear, removable insoles, heel cushions and similar articles, gaiters, leggings and similar articles and parts of thereof growth of 47.9 percent, plastic bag growth of 34.5 percent, rubber cloth/sheet growth of 26.5 percent, button moulds and other parts of button, button blanks, parts of slide fasteners growth of 20.3, component plastic growth of 11.8 percent, conveyor belts growth of 10.3 percent, rubber break lining growth of 1.7 percent. The index of tyre tractor, button plastic recorded a negative growth respectively.

14 - Manufacture of other Non-Metallic Mineral Products (23)

This industry group carries a weight of 18.73 in the Manufacturing sector. The index of this group has increased from 155.0 in 2018-19 to 168.1 in 2019-20 recorded a positive growth of 8.4 percent. The index of asbestos, corrugated sheet recorded highest growth of 469.7 percent

followed by fiber glass sheet/board recorded a growth of 289.5 percent, sanitary ware others of iron and steel recorded a growth of 77.5 percent, ceramic tiles recorded a growth of 29.2 percent, stone dust/powder recorded a growth of 15.1 percent. The index of cement, white, cement, others products, tiles, flagstones, bricks and similar articles, of cement, concrete or artificial stone, glass components, cement, portland recorded a negative growth respectively.

15 - Manufacture of Basic Metals (24)

The basic metal group carries a weight of 48.60 in the Manufacturing sector. The index of this group has recorded 94.5 in 2018-19 to 94.5 in 2019-20 shows no growth percent. The index recorded a positive growth of aluminum ingots 93.0 percent, copper wire bars, refined 59.0 percent, plates hot rolled 44.0 percent, tubes, pipes of stainless steel 32.1 percent, cold finished/formed of flat rolled products 7.8 percent. The index of cast iron, CR sheet 1t 600mm, aluminum circles alloyed, aluminum profile hollow, copper zinc base alloys, brass recorded a negative growth respectively.

16 - Manufacture of Fabricated Metal Products, Except Machinery and Equipment (25)

The fabricated metal products industry carries a weight of 32.54 in the Manufacturing sector. The index of this group increased from 155.6 in 2018-19 to 169.1 in 2019-20 recorded a positive growth of 8.6 percent. The index recorded a highest growth of link forging 17.6 percent, utensils of iron (other than cast iron) or steel, enameled 12.7 percent, liquefied petroleum gas (LPG) cylinders of iron and steel 9.2 percent, machine screw iron and steel 6.7 percent, bolts, screws, nuts, iron/steel 5.1 percent, grease guns excl compressed air type 1.7 percent, The index of tower for transmission lines of iron and steel, heavy machinery for fabrication, forging, die stamping machines incl. presses and hammers, recorded a negative growth respectively.

17 - Manufacture of Computer, Electronic and Optical Products (26)

This industry group carries a weight of 11.16 in the Manufacturing sector. The index of this group has increased from 253.5 in 2018-19 to 286.6 in 2019-20, recorded a positive growth of 13.1 percent. The index of meter, electric-others, recorded the highest growth of 103.0 percent followed by biological microscope 73.7 percent, drafting tables and machines, and other drawing, marking out or mathematical calculating instruments 32.6 percent, film polyester (metalized) 17.3 percent, instruments and apparatus (except cathode-ray oscilloscopes and oscillograph) for telecommunications 9.9 percent, electro-diagnostic apparatus used in medical, surgical, dental 3.9 percent. The index of audio CD/DVD player, optical components recorded a negative growth respectively.

18- Manufacture of Electrical Equipment (27)

The electrical equipment industries carry a weight of 58.22 in the Manufacturing sector. The index of this industry group increased from 175.7 in 2018-19 to 265.1 in 2019-20, recorded a growth of 50.8 percent. The index of fabricated metal products recorded the highest growth of 437.3 percent followed by wire, stainless steel, electrode quality 166.9 percent, parts of electric motors, generators and the like 142.8 percent, parts of electricity distribution or control apparatus 93.6 percent, optical fiber cables, made up of individually sheathed fibers 3.8 percent. The index of cable, rubber insulated, boards, consoles, cabinets and other bases, equipped with electrical switching etc. apparatus, for electric control of the distribution of electricity, for a voltage exceeding 1000v, light fitting accessories, motor, fan, cable, PVC insulated fluorescent tubes recorded a negative growth respectively.

19 - Manufacture of Machinery and Equipment (28)

The machinery equipment industry carries a weight of 106.6 in the Manufacturing sector. The index of this group has decreased from 224.8 in 2018-19 to 203.8 in 2019-20 with a negative growth of 3.4 percent. The cultivators have recorded a highest growth of 334.5 percent followed by diamond tools 218.3 percent, book-binding machinery, machinery for type-setting and for offset printing machines for uses ancillary items to printing (except office type sheet-fed) 82.7 percent, acephate/speedometer 81.9 percent, offset printing machines 81.5, other agricultural tractors 44.1 percent, tamping machines and road rollers, self-propelled 34.7 percent, scrap cast iron 30.2 percent, hydraulic equipment 27.6 percent, water pump 16.3 percent, bearing steel 7.6 percent, AC motor car 4.8 percent. The index of compressor used in refrigerator, filter for beverages, internal combustion piston engines, other than for motor vehicles and aircraft, air conditioner-window/wall, parts of agricultural machinery recorded a negative growth respectively.

20 - Manufacture of Motor Vehicles, Trailers and Semi-Trailers (29)

This industry group carries highest weight of 230.72 in the Manufacturing sector. The index of this group increased from 148.8 in 2018-19 to 187.7 in 2019-20 recorded a positive growth of 26.1 percent. The parts and accessories for the goods of subclass 49211 has recorded highest growth of 44.1 percent, gear case assemblies 43.1 percent, locks used in motor vehicles 21.3 percent, mini bus/bus-complete 12.0 percent, shafts, all kinds 11.4 percent, seat for motor vehicle 7.3 percent, parts of petrol engine for motor vehicle 6.1 percent, engine assembly parts 4.8 percent, gear box motor vehicles 2.8 percent, steering gear control system 0.0 percent.

The index of silencer, spring pins, axel, air break sets, shock absorbers, exhaust tubes, auto door rubber fittings, trailers and semi trailer of caravan type, for housing or camping, leaf spring for motor vehicles recorded a negative growth respectively.

21 - Manufacture of Other Transport Equipment (30)

The other transport equipment industry has been assigned a weight of 121.25 in the Manufacturing sector. The index of this group increased from 97.0 in 2018-19 to 110.8 in 2019-20 recorded a growth of 14.2 percent. The tracks, railway/tramway tracks has recorded highest growth of 69.8 percent followed by parts of motor cycle/moped/cycle 41.1 percent, parts and accessories of motorcycles and side cars growth of 1.9 percent respectively.

22 - Manufacture of Furniture (31)

The furniture industry carries a weight of 0.41 only in the Manufacturing sector. This group contained only one product i.e. furniture and fixture wooden with a positive growth of 13.5 percent.

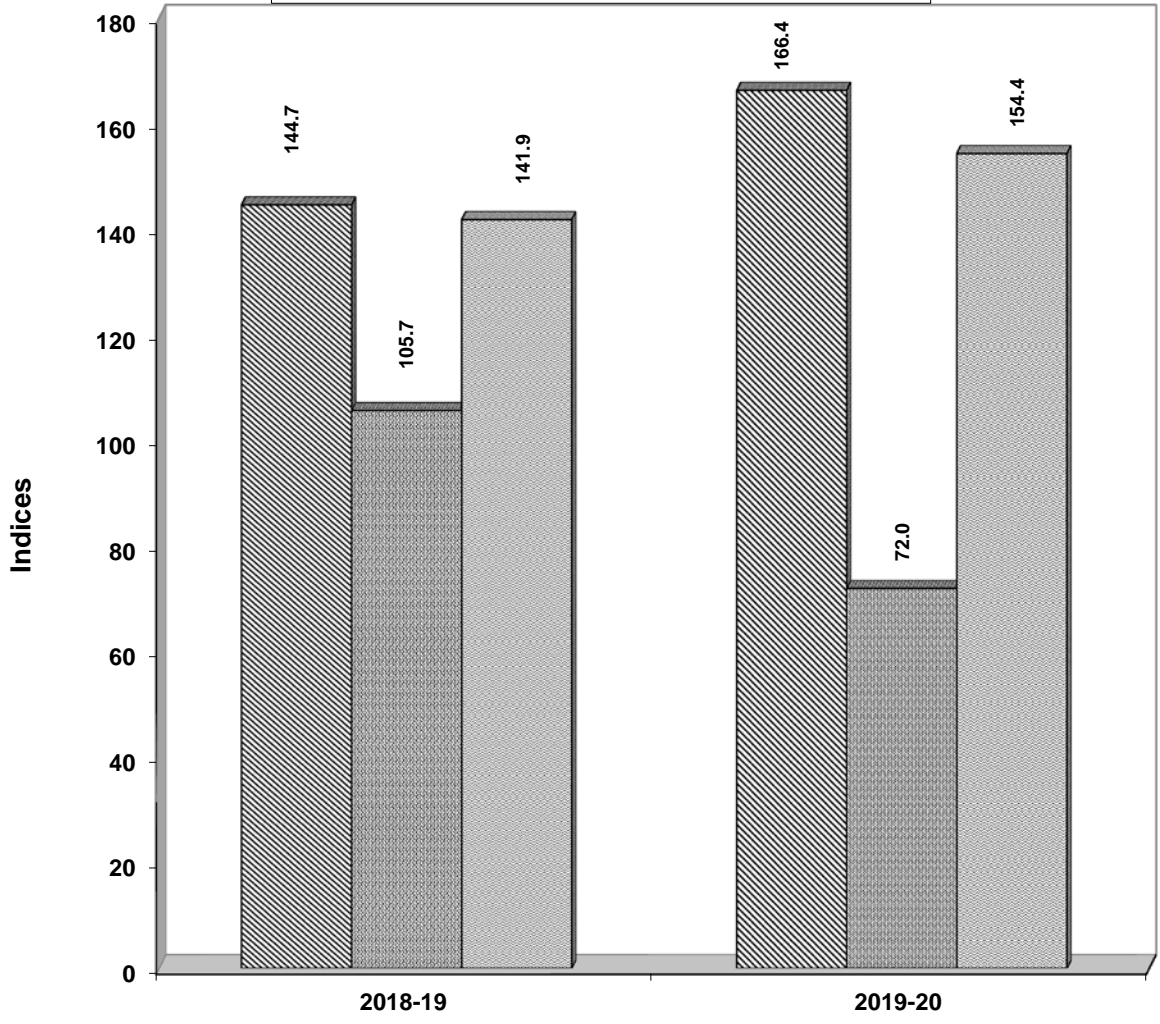
23 - Other Manufacturing (32)

The other manufacturing industry group has been assigned a weight of 9.21 in the Manufacturing sector. The index of this group has increased from 155.3 in 2018-19 to 232.9 in 2019-20 recorded as positive growth of 49.9 percent. The sports goods rubber has recorded highest growth of 123.0 percent followed by lens, ophthalmic 94.4 percent, medical surgical or laboratory sterilizers 69.8 percent, staplers 28.1 percent. The index of electricity, handicraft/decorative fancy items, pen body plastic, blade, stainless steel, ornaments imitation has recorded a negative growth respectively.

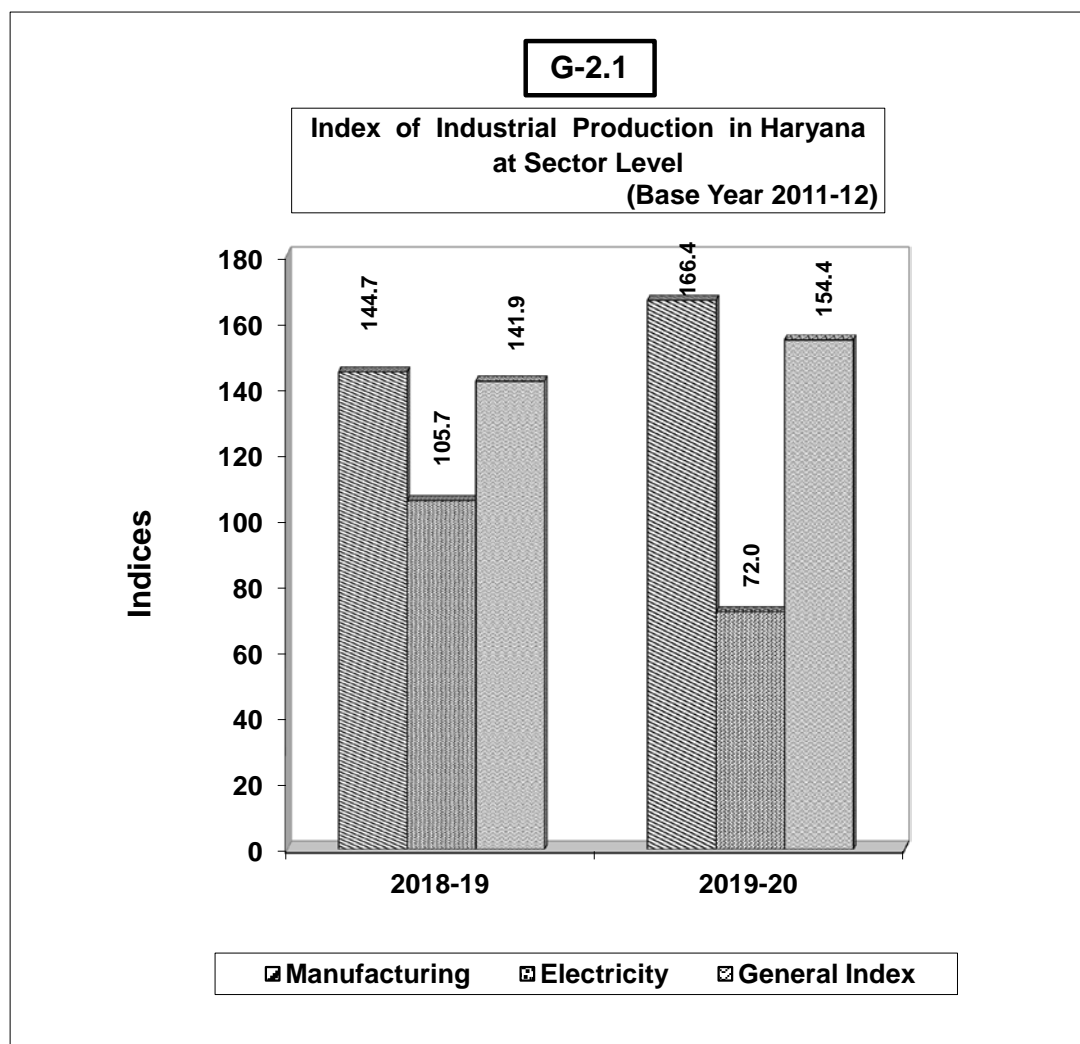

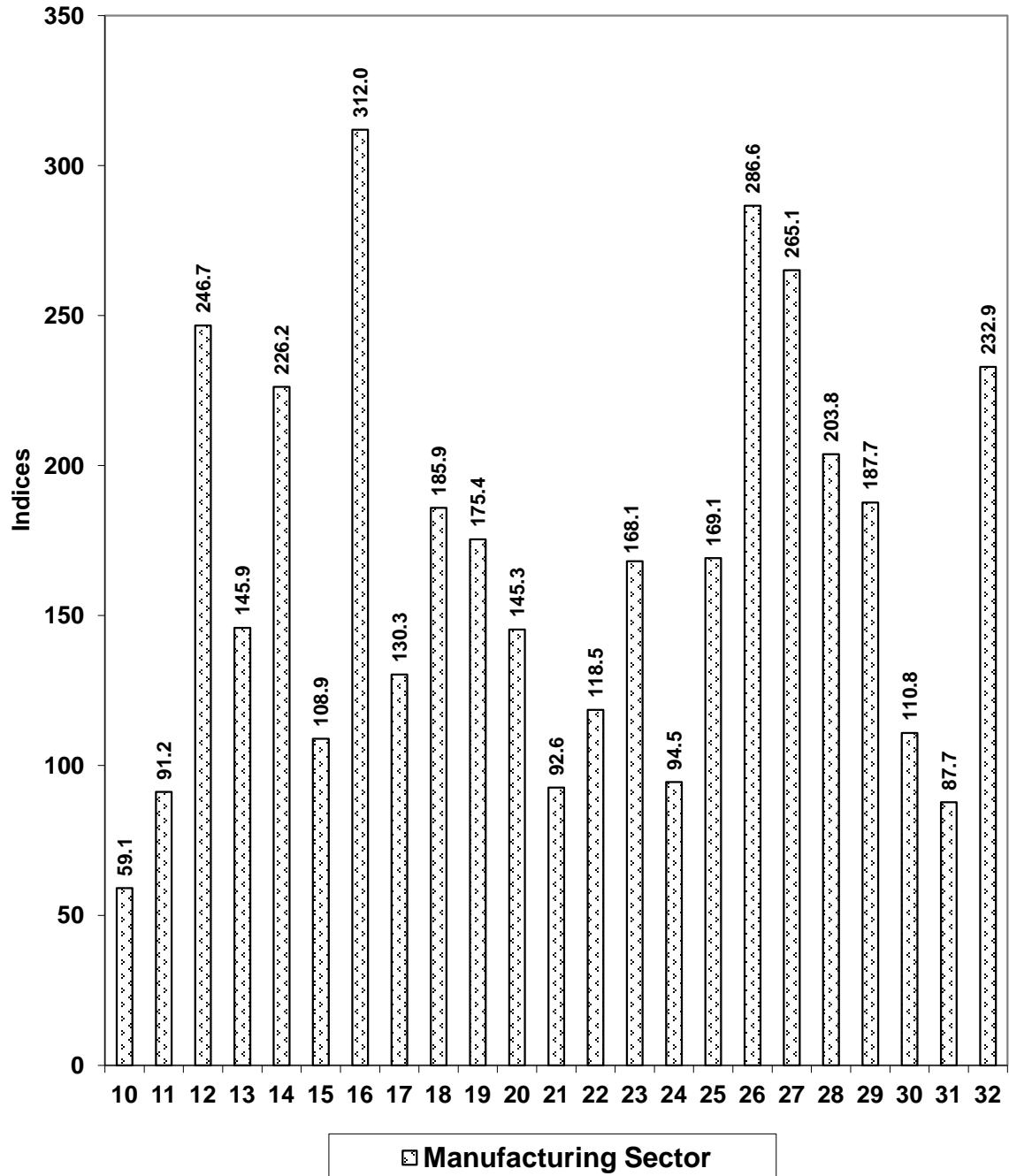

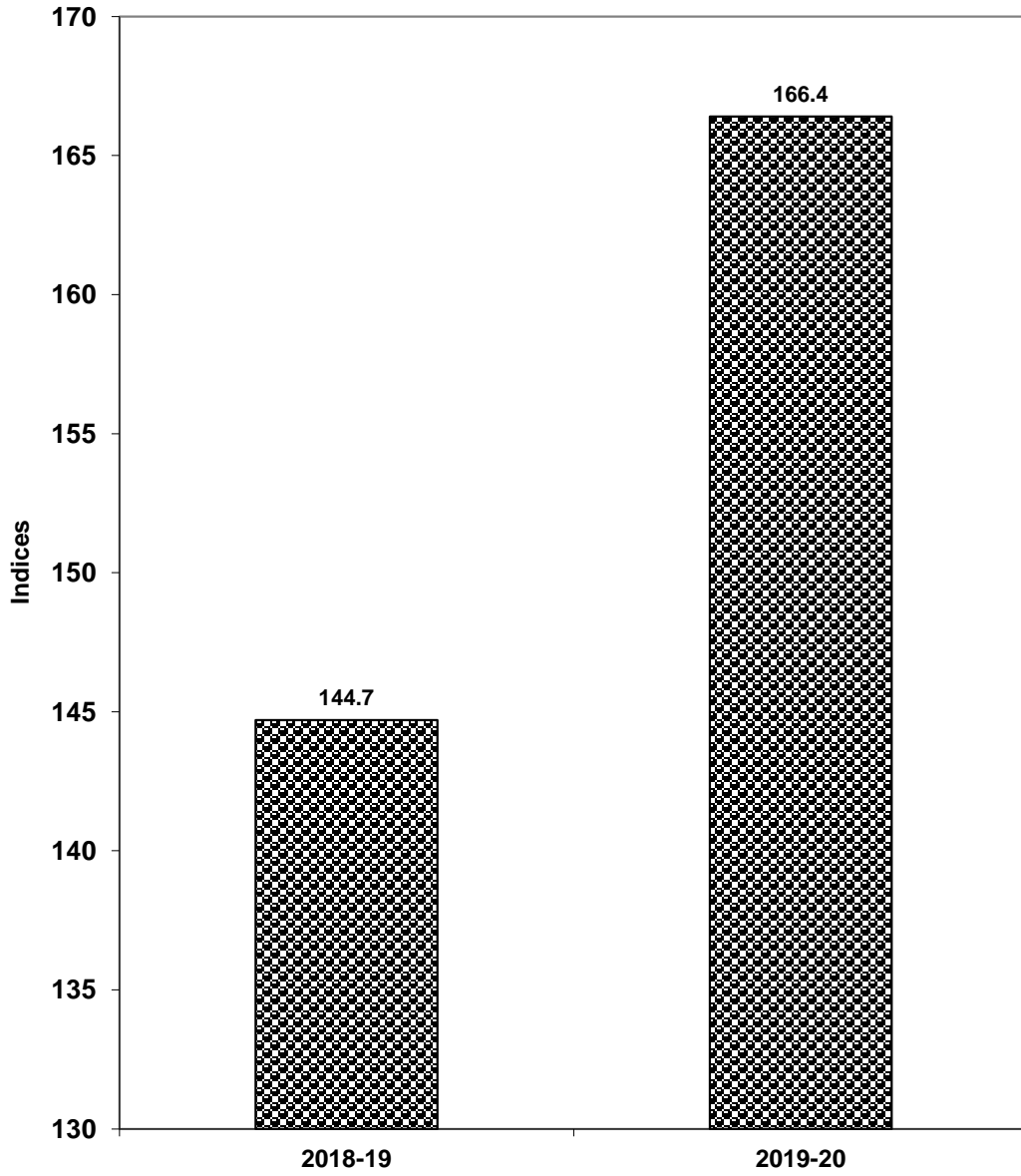

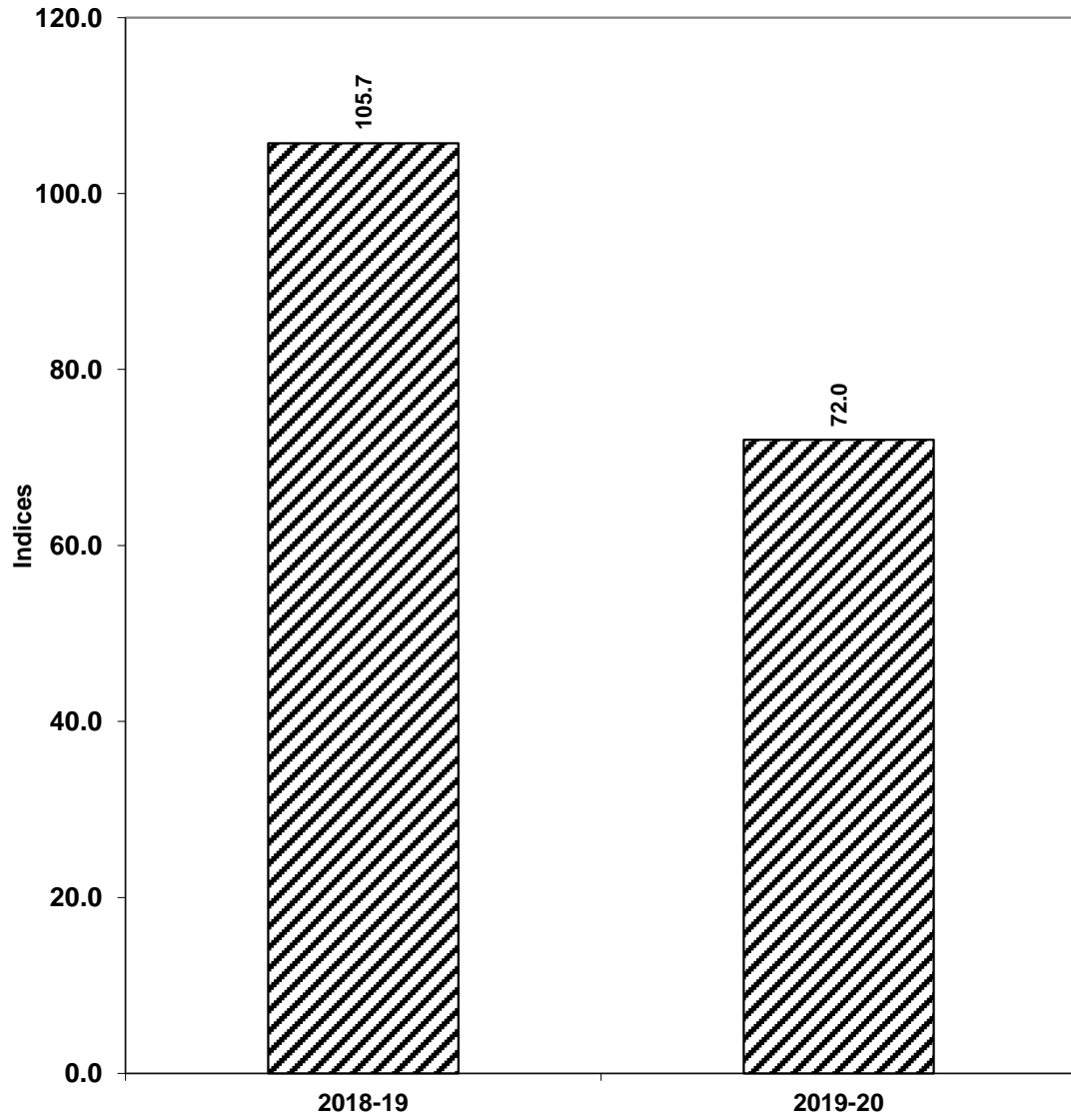
**Index of Industrial Production in Haryana

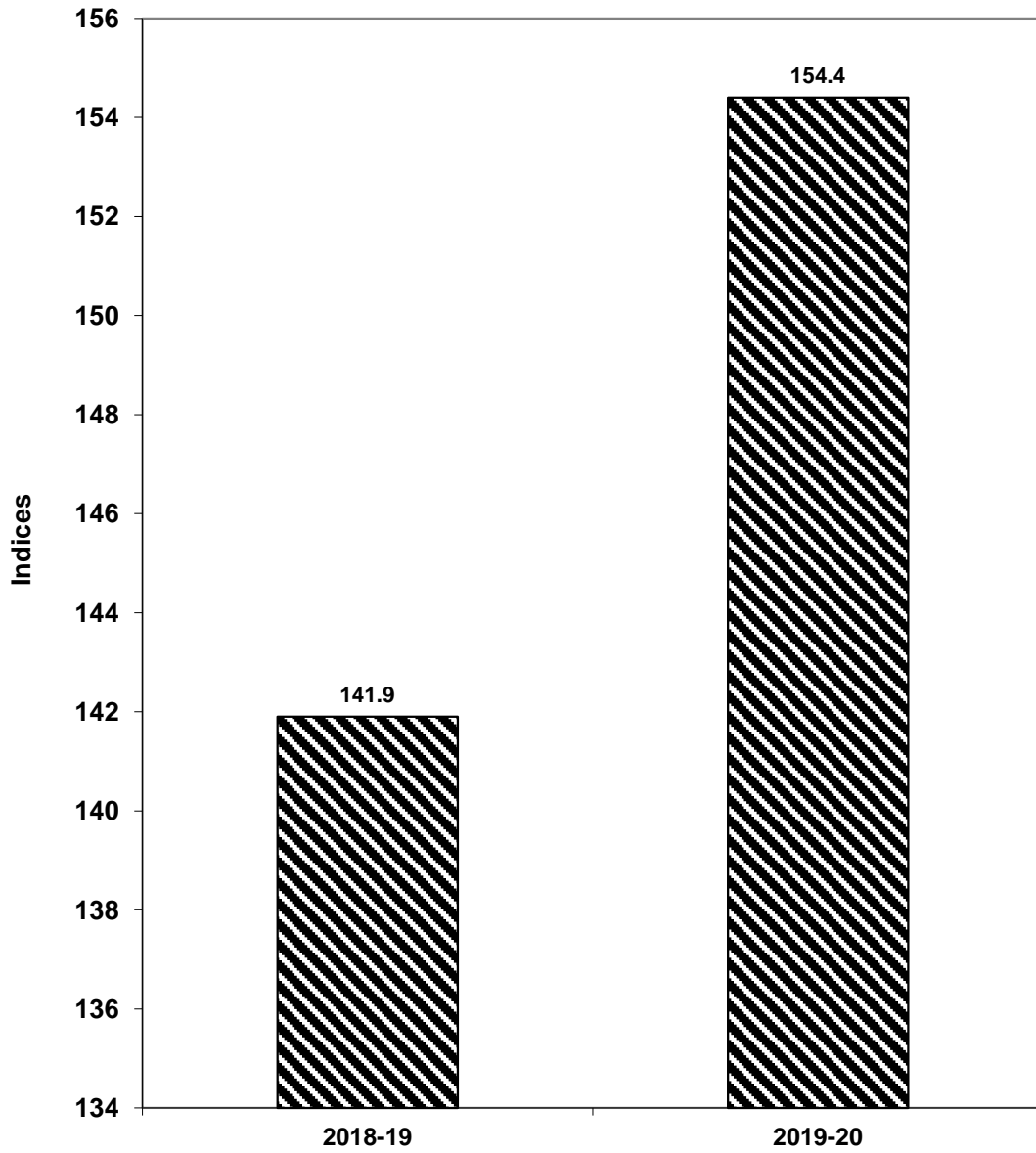
**Index of Industrial Production in Haryana

INDEX OF INDUSTRIAL PRODUCTION IN HARYANA

Use-Based Classification

The Use-Based Classification represents the changing pattern of customer's needs, based on the tastes and habits towards the purchase of industrial products. The industrial products have been clubbed into four major groups comprising of Basic Goods Industries, Capital Goods Industries, Intermediate Goods Industries and Consumer Goods Industries with a view to analyse the movement of growth rate of different groups of industries and their achievements within the frame of organized sector.

The Use-Based Classification represents the classification of the industrial products according to the product applications. Each industry group reflects the variations in the production of a particular class of industries based on product usage. The industries are classified into six groups viz., Primary Goods, Capital Goods, Intermediate Goods, Infrastructure/Construction Goods, Consumer Durables and Consumer Non-Durables Goods. Concepts and definitions for Use-Based Classification are given below.

(i) Primary Goods

Only such goods which are directly obtained from natural sources and used for further processing and consumption in manufacturing and power generating activities.

(ii) Capital Goods

Plants, machinery and goods used for further investments.

(iii) Infrastructure/Construction Goods

Finished goods which are primarily used in infrastructure industry or construction industry as an input. This category has been created to precisely items which could not be classified under consumer durables or intermediate goods

(iv) Intermediate Goods

Any goods/products produced as incomplete product or which goes as input in production for further finishing or forming a part of a product.

(v) Consumer Durables

Products directly used by consumers and having a longer durability (more than 2 to 3 years).

(vi) Consumer Non-Durables

Products that are directly used by consumers and cannot be preserved for long periods.

The share of each use-based industry group to the industry sector of the State and the number of industrial groups and items covered representing the use-based groups are as under: -

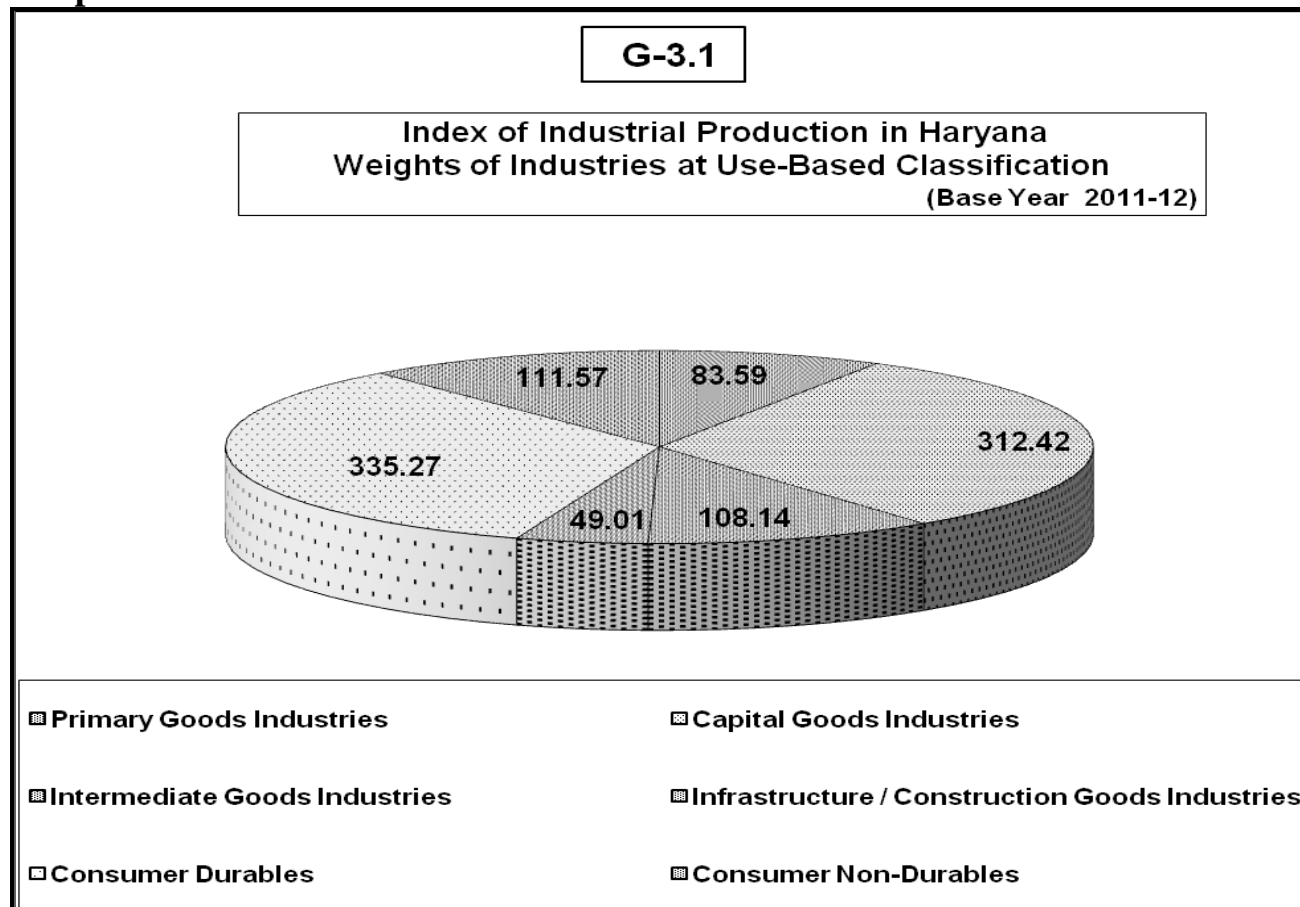

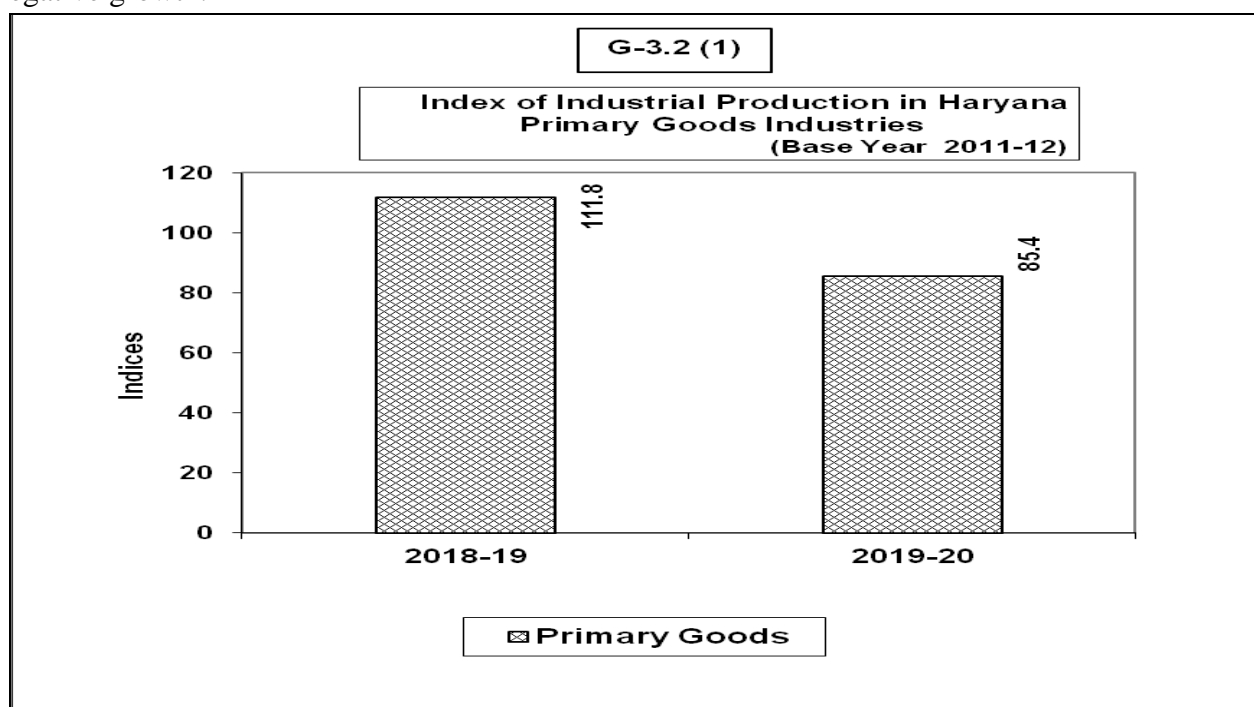

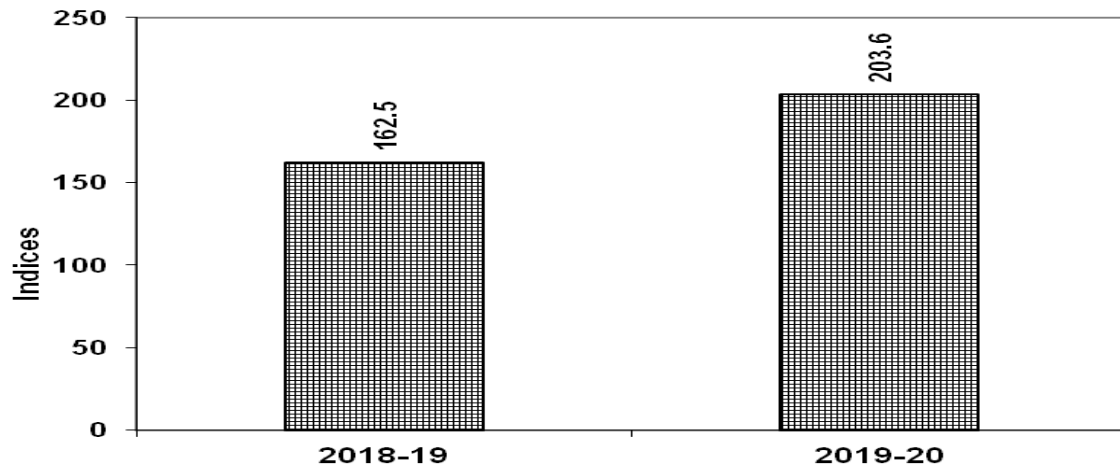

During the year 2019-20, Capital Goods Industries recorded highest growth of 25.3 percent, followed by Intermediate Goods 9.8 percent, Consumer Non-Durables goods 7.3 percent, Consumer Durables 0.7 percent. Infrastructure/Construction Goods and Primary Goods recorded a negative growth.

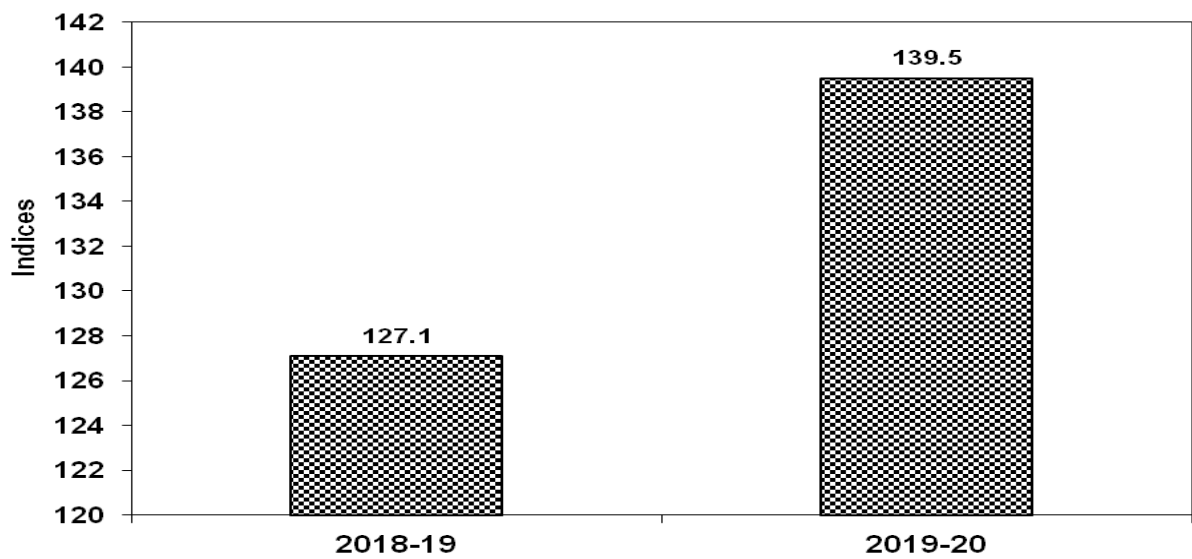
**Index of Industrial Production in Haryana

(Base Year 2011-12)**



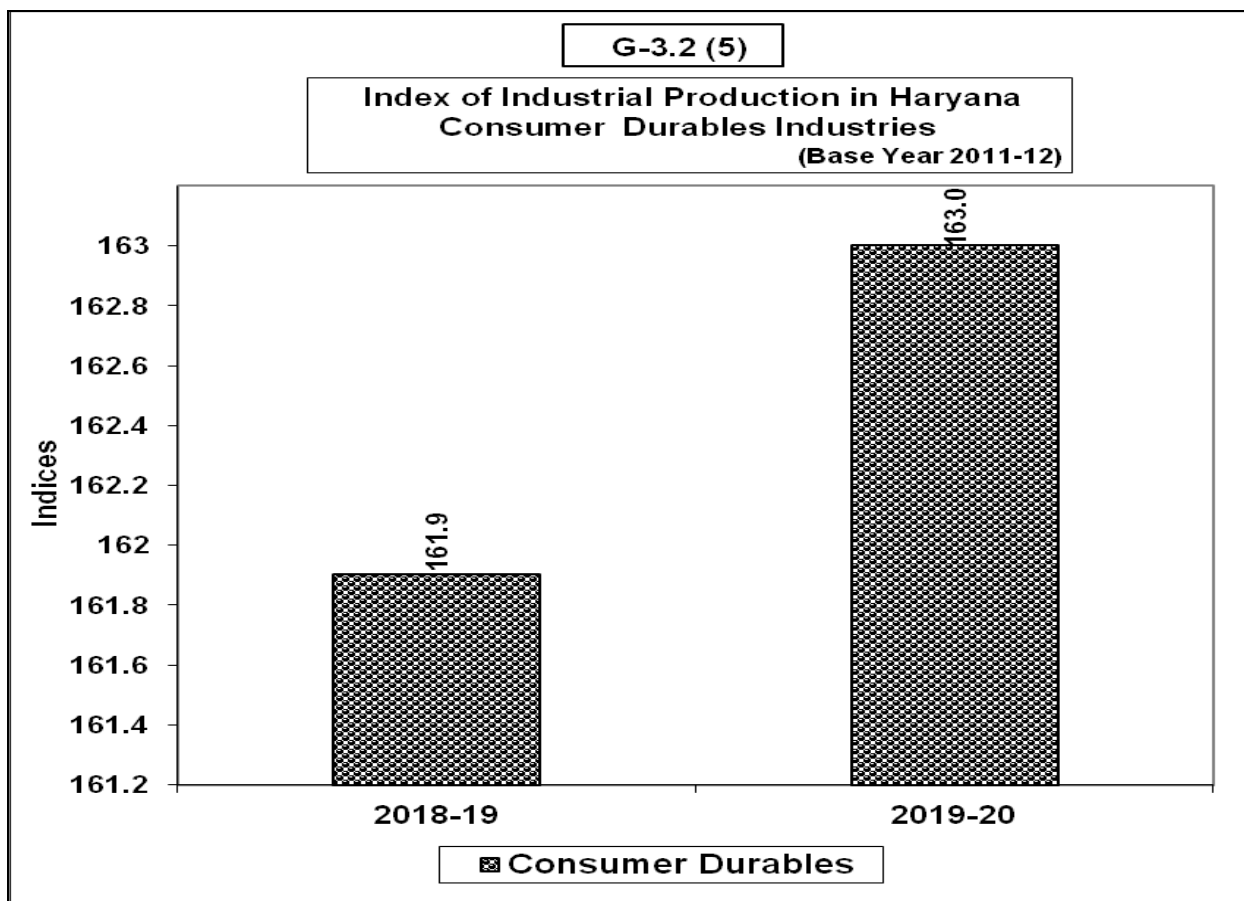
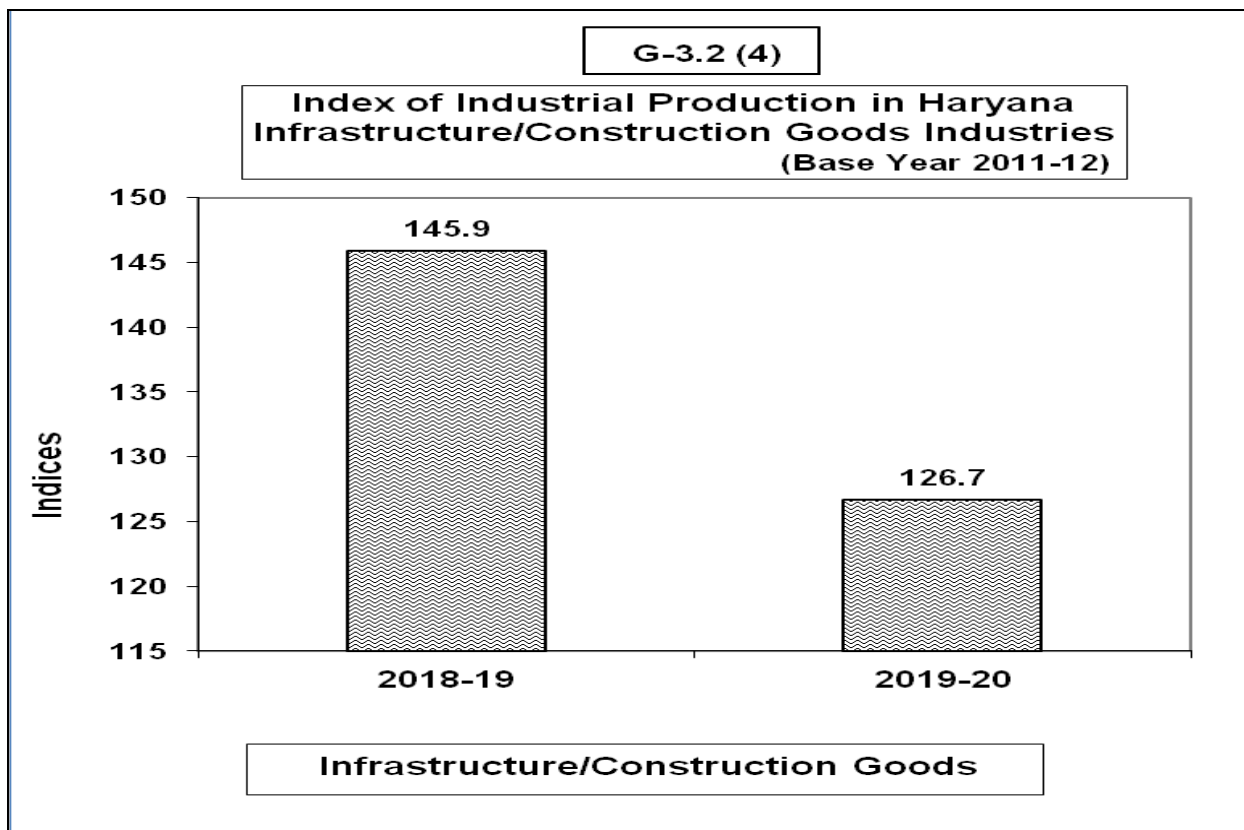

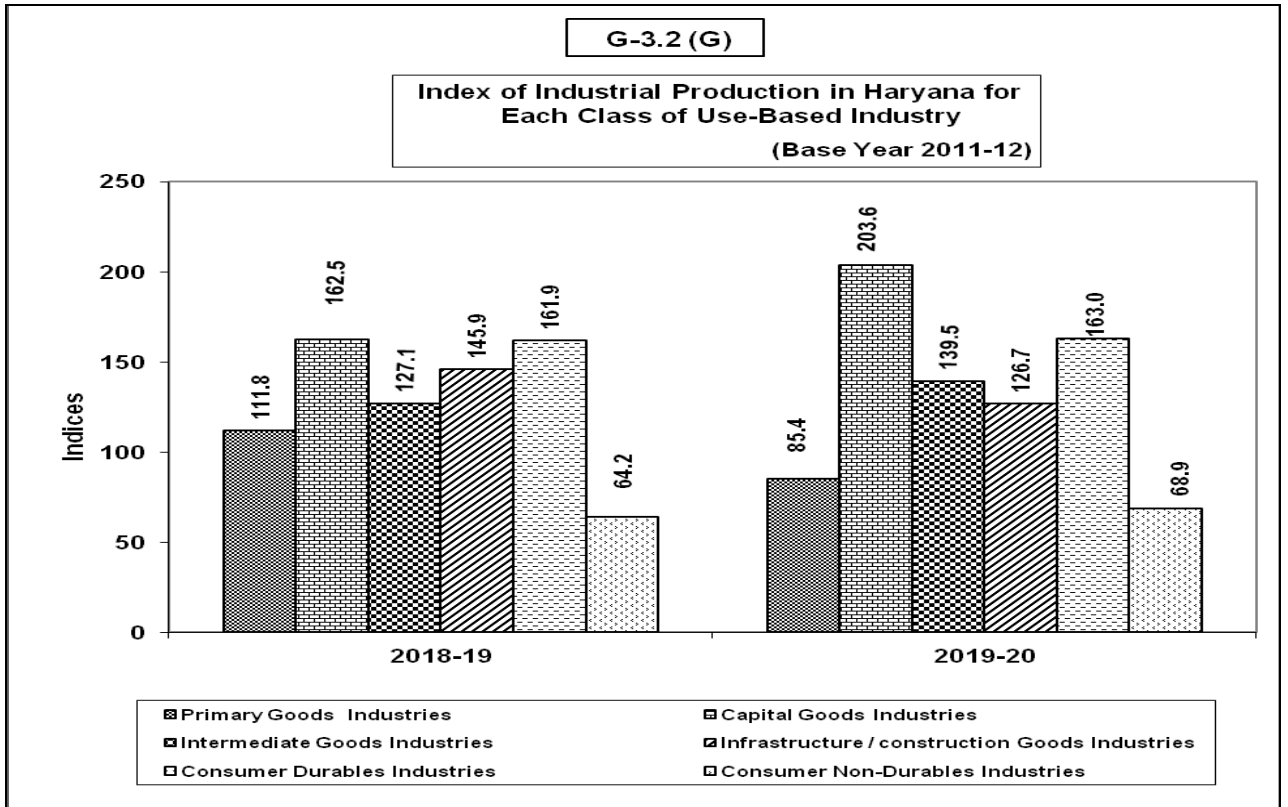
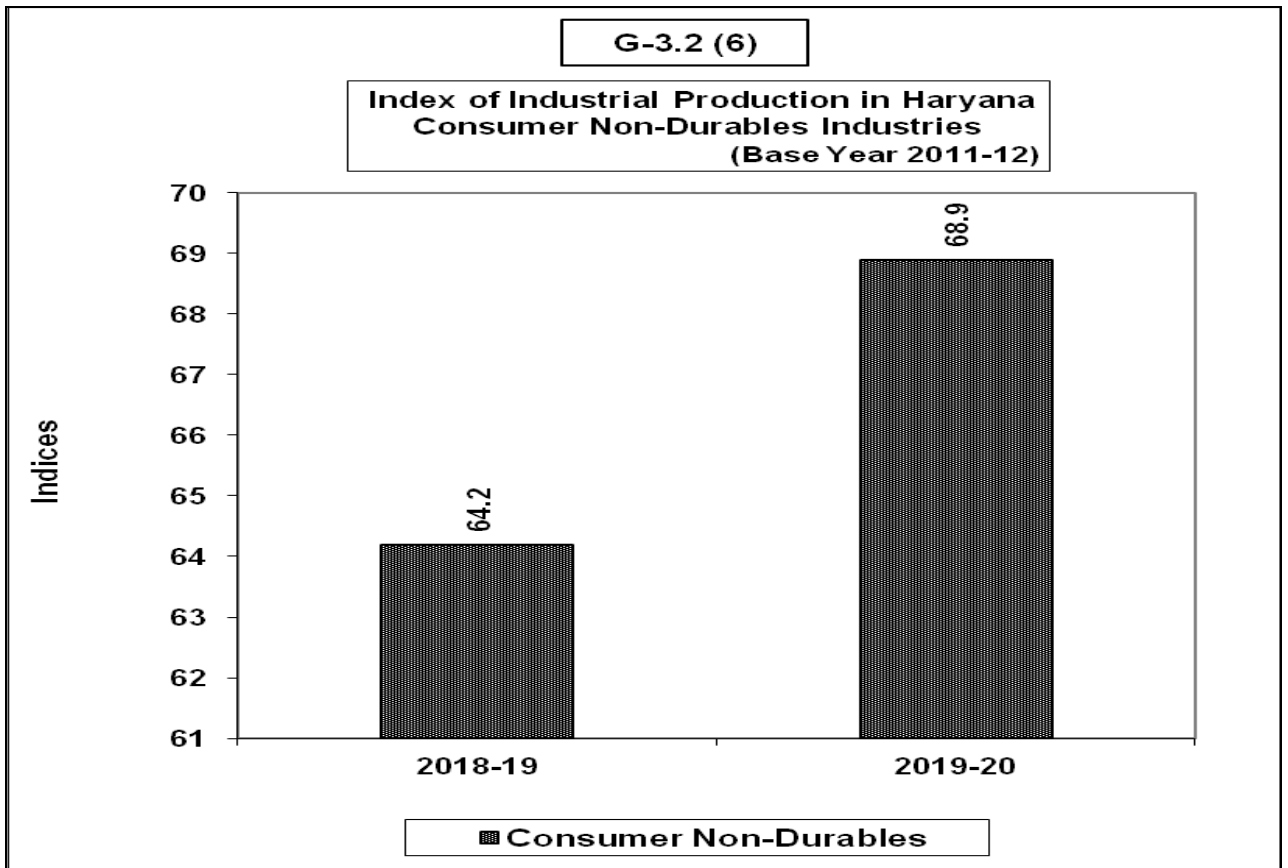

A. Primary Goods Industries

Primary Goods Industries which have been assigned a weight of 83.59 recorded a negative growth of 23.6 percent during the year 2019-20 as compared to the previous year. The index of this industry group decreased from 111.8 in 2018-19 to 85.4 in 2019-20. Argon gas, Liquid Nitrogen, Urea, Bitumen, LPG and generation of electricity are the major products in this group. Liquefied Petroleum Gas (LPG) Cylinders of iron and steel, Urea, Nitrogen Liquid recorded a notable increase during the year 2019-20. The index of Bitumen, Electricity, Oxygen liquid and Argon gas have recorded negative growth over the previous year.

B. Capital Goods Industries

The Index of Capital Goods Industries having weight of 312.42 showing a stable growth of 162.5 in 2018-19 to 203.6 in 2019-20. Other agricultural tractors, engine assembly parts, shafts all kind, parts of electricity distribution or control apparatus, fabricated metal products, parts of electricity motors, generator and the like, steering gear control system, shock absorbers, acephate/speedometer, auto door rubber fittings, cultivators, book binding machinery, machinery for type setting and the offset printing, diamond tools, link forging, wire, stainless steel, electrode quality, offset printing machine, rubber break lining, tamping machine and road rollers, self propelled, biological microscope, conveyer belts recorded a positive growth in this group. The index of mini bus/bus-complete, air break sets, tracks, railway/tramway, tyre tractor, hydraulic equipment, leaf spring for motor vehicles, internal combustion piston engine, other than for motor vehicle and aircraft etc., axel, motors-fan, exhaust tubes, compressors used in refrigerator, spring pins, heavy machinery for fabrication, forging, die stamping machines including presses and hammers, optical component, parts of agricultural machinery, electro-diagnostic apparatus, used in medical, surgical, dental recorded a negative growth in this group.

C. Intermediate Goods Industries

The Intermediate Goods Industries carry a weight of 108.14. The Index of this industry group has increased from 127.1 in 2018-19 to 139.5 in 2019-20 recorded a increased of 9.8 percent. The gear case assemblies, medical, surgical or laboratory sterilizers, seat for motor vehicles, plates, hot rolled, gear boxes, motor vehicles, tube, pipe of stainless steel, film polyester (metalized), locks used in motor vehicles, unsaturated polyester resin, stone dust/powder, bearing steel, fiber glass sheet/board, copper wires bars, refine, bolts, screws, nuts, iron/steel, sanitary ware others of iron and steel, machine screws iron and steel, aluminum ingots, wooden chips recorded as positive growth in this group. The index of Aluminum circle alloyed, plywood board, plywood, cast iron, CR sheet 1t 600mm, powers for transmission lines of iron and steel, mud/molasses waste, copper zinc base

alloys, brass aluminum alloys profile hollow, utensils iron, (other than cast iron), or steel, enamelled, sheet laminated plastic wood cutting processed sized recorded a negative growth during the year over previous year.

D. Infrastructure/Construction Goods Industries

Infrastructure/construction Goods Industries have captured a weight of 49.01. This industry group has recorded a negative growth of 13.1 percent during the year 2019-20 as the index of this group decreased from 145.9 in 2018-19 to 126.7 in 2019-20. The cold finished/formed of flat rolled products, paint, optical fibers cables made up of indivisibly sheathed fiber, primer, stoving, synthetic, ceramic tiles, asbestos, corrugated sheet, scrap cast iron recorded as positive growth in this group. The index of paint, plastic, emulsion, tiles, flagstone bricks and similar articles of cement, concrete or artificial stone, cement other products, Cement Portland, cable, PVC, insulated, cement, white, cable, rubber insulated recorded a negative growth in this group.

E. Consumer Durables Industries

The Consumer Durable Goods Industries have been assigned a weight of 335.27. The Index of this industry group has increased from 161.9 in 2018-19 to 163.0 in 2019-20 recorded a positive growth of 0.7 percent. The index of parts and accessories of motor cycle and side cars, apparatus for electric control or the distribution of electricity for a voltage, parts for motorcycle/moped/cycle, garments made up of textile fabric, impregnated, footwear incorporating a protective metal toe-cap, except those covered in subclass 29320, AC motor car, lining cloth, cotton, parts of petrol engine for motor vehicles, paper printing and writing, carpets and other textile floor covering, tufted, cotton fabrics, Parts and accessories for the goods of subclass 49211, Footwear with uppers of leather, other than sports footwear, footwear incorporating a protective metal toe-cap and miscellaneous special footwear, hand bag, artificial fur, Yarn of wool, containing 85% or more by weight of wool, not put up for retail sale, lens, ophthalmic, Grease guns excl compressed air type, rubber cloth/sheet, cotton, carded or combed, components plastic, meter, electric-others, boxes corrugated sheet, water pump, Button moulds and other parts of buttons; button blanks; parts of slide fasteners, Drafting tables and machines, and other drawing, marking-out or mathematical calculating instruments, plastic bag, sports goods rubber, leggings and similar articles, staplers, electronic pcb/micro circuit, electronic pcb/micro circuit, furniture and fixture wooden recorded as positive growth. The index of Garments made up of textile fabrics coated with other materials, Air conditioner-window/wall, Instruments and apparatus (except cathode-ray oscilloscopes and oscillographs) for telecommunications, carpets and other textile floor coverings, knotted, Light fitting accessories, other sports footwear, except skating boots, books, garment cloth, cotton, motor cycle, racing with cylinder capacity exceeding 50 cc,

silencer, fabrics/cloths, glass components, fabrics mixed, fabrics cotton, terry towels (cotton) yarn dyed cotton, handicraft/decorative fancy items, man-made fiber fabrics, other paper, paperboard, cellulose wadding and webs of cellulose fibres, cut to size or shape; cigarette paper, in booklets or tubes, or in rolls of a width not exceeding 5 cm; of other articles of paper pulp, paper, paperboard, cellulose wadding or webs, trailers and semi-trailers of the caravan type, for housing or camping, paper polythene coated, button plastic, blankets, fluorescent tubes audio cd and dvd player, pen body plastic, blade, stainless steel, ornaments imitation recorded as a negative growth.

F. Consumer Non -Durables Industries

The Consumer Non-Durable Goods Industries have been allotted a weight of 111.57. The Index of this industry group has increased from 64.2 in 2018-19 to 68.9 in 2019-20 have recorded a positive growth of 7.3 percent as compared to previous year. The index of rice basmati, Antidiabetic drugs excl. insulin (metformin, pioglitazone, glimepiride etc.), milk, soft drink, carbonated beverages other than soda water, black tea, vegetables, fruit, nuts, fruit-peel and other parts of plants, preserved by sugar, country liquor and its variant, ointment, allopathic, sugar, rectified spirit, biscuits, Glues and gelatine, peptones and their derivatives, and related products; caseinates and other casein derivatives; albuminates and other albumin derivatives recorded as a positive growth. The index of refined sugar, guar kernel, bear made from malt, tobacco, chewing (scented or not), vaccine for veterinary medicine, bandage including adhesive gauze bandage etc., skim milk and whey power, malt whether or not roasted, other vegetables oils and fats, rectified, husk (animal feed), waste paper, sauces; mixed condiments; mustard flour and meal; prepared mustard, dried vegetables, other shelled nuts, gola (cattle feed), butter and other fats and oils Derived from milk of cattle, filter for beverages have recorded as negative growth respectively.
