- (B) The terms of reference of the Committee will be:-
 - To hold review meetings on quarterly/half yearly basis and coordinate with different Departments to ensure:
 - a) Systematic transition of EBT to DBT mode so that the benefits go to individuals bank accounts.
 - b) Minimising tiers involved in fund flow thereby reducing delay in payments,
 - c) Ensuring accurate targeting of beneficiary and
 - d) Curbing pilferage and duplication.
 - Monitoring the deadlines towards DBT implementation across different schemes.
 - 3. Study of best practices being followed in other States.
