The Index of Industrial Production (IIP) is one of the prime short-term micro economic indicators of the economic development to measure trend in the behavior of the industrial performance over a period of time in comparison to a chosen base year. It indicates the relative change of physical production in the field of industries during a specified year as compared to previous year.

The Department of Economic and Statistical Affairs, Haryana has been compiling the Index of Industrial Production for Haryana State under the guidance of the National Statistical Office (NSO), Govt. of India since 1971-72 and publishes its report on annual basis. The present report containing information relating to IIP for the year 2022-23 is the sixth issue of the series with base year 2011-12. This Index of Industrial Production of Haryana State relates to Manufacturing and Electricity Sectors with an analysis of use-based classification of the index numbers.

This report provides an useful information for planners, industrialists and researchers etc. interested in the industrial development of the State.

I take this opportunity to thank the National Statistical Office, Government of India for providing valuable guidance. Efforts made by the District Statistical Offices for collection of production data from various industrial units are also acknowledged. The cooperation extended by various industrial units of the State for providing required production data for computation of IIP are appreciated and acknowledged.

EXECUTIVE SUMMARY

Industrialization plays a vital and crucial role in the economic development of an economy. It accelerates economic growth of a State and thereby increases the contribution of Industry Sector in the State Domestic Product by way of increase in the production and employment. Index of Industrial Production (IIP) is one of the prime indicators of the economic development for measurement of trend in the industrial production over a period of time with reference to a chosen base year.

The Index of Industrial Production for the State is compiled in accordance with the guidelines of the National Statistical Office (NSO), Govt. of India. In Part-I of the report, the detailed methodology, sources of data and computation of index numbers have been presented.

A total of 178 items have been selected from Registered Manufacturing sector for the year 2011-12. Electricity has been taken as a single item. Mining and Quarrying sector has been excluded due to its insignificant contribution in GSDP which was 0.04% in 2011-12 in the State. The total weight of Industrial Sector has been taken as 1000 which has been distributed to Registered Manufacturing & Electricity sectors. The weights of Registered Manufacturing sector have further been distributed at 2/3 digit as well as item level as per criteria suggested by NSO. Production data of selected items are collected directly from the selected factories in the State.

Presently, Index of Industrial Production is being prepared in the State with 2011-12 base year and covers Manufacturing and Electricity sectors. Index number has been calculated at sector level, group level (2 digits) and item level. The same has been presented in the report accordingly. Review of index numbers for the year 2022-23 has also been given in the report.

The General Index of Industrial Production with 2011-12 base year increased from 169.2 in 2021-22 to 181.4 in 2022-23 registering a growth of 7.2 percent. The Index of Manufacturing sector which carries the highest weight in IIP increased from 174.6 in 2021-22 to 185.1 in 2022-23, positive growth of 6.0 percent. The Index of Electricity sector indicates a positive growth of 34.3 percent as it is increased from 99.6 in 2021-22 to 133.7 in 2022-23.

In last part of the report, the use-based classification which represents the changing pattern of customer's needs, based on taste and habits towards the purchase of industrial product has been given. Review of the use-based classification for the year 2022-23 has also been given therein. The report elaborates that the Index of Primary Goods Industries like argon gas, urea, bitumen, LPG cylinder of iron and steel, electricity etc. has decreased from 90.7 in 2021-22 to 20.6 in 2022-23 which recorded an decreased of 77.2 percent.

The Index of Capital Goods Industries like conveyor belts, tractor tyres, link forging, optical components, acephate/speedometer, diamond tools, spring pins etc. increased from 207.6 in 2021-22 to 224.1 in 2022-23, which recorded a increase of 7.9 percent.

The Index of Intermediate Goods Industries like plywood boards, wooden chips, cast iron, stone dust powder, motor vehicle seats etc. has increased from 174.6 in 2021-22 to 186.6 in 2022-23, recording a growth of 6.9 percent.

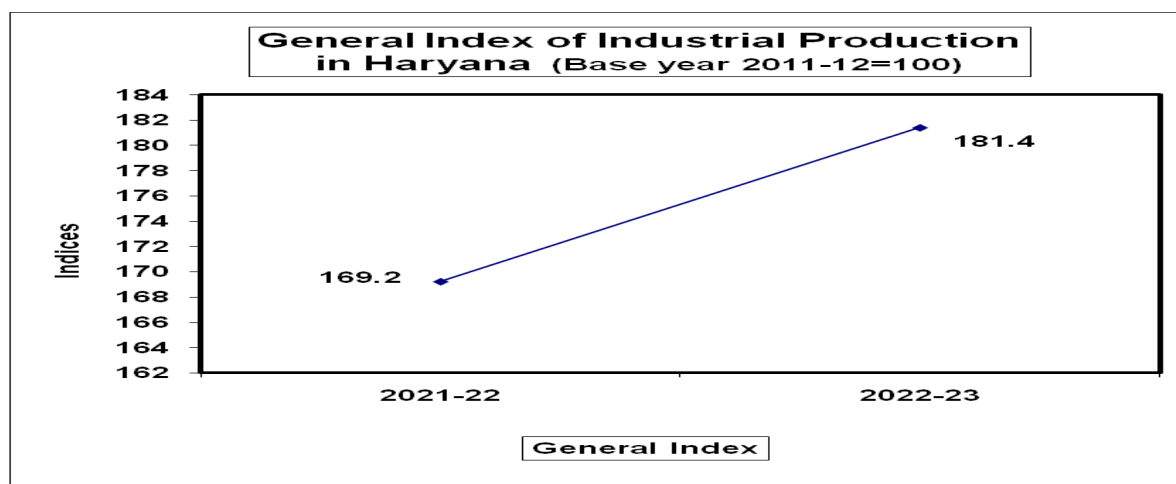
The Index of Infrastructure/Construction Goods Industries like paints, ceramic tiles, scrap cast iron etc. has increased from 127.6 in 2021-22 to 423.4 in 2022-23, recording a positive growth of 231.8 percent.

The Index of Consumer Durables Industries like cotton fabrics, blankets, artificial fur hand bags, books, rexin, button plastic, glass components, water pump, AC motor car etc. has decreased from 208.7 in 2021-22 to 169.5 in 2022-23, registering a negative growth of 18.8 percent.

The Index of Consumer Non-Durables Industries like dried vegetables, milk, rice basmati, sugar, biscuits, black tea, waste paper etc. has increased from 40.8 in 2021-22 to 90.4 in 2022-23, which registering a positive growth of 121.6 percent.

The General Index of Industrial Production for the series with base year 2011-12 is as under:-

INTRODUCTION

Industrial sector occupies an important position in Indian Economy and has pivotal role to play in the rapid and balanced economic development. Index of Industrial Production (IIP) is one of the tools for measuring the growth of the industrial sector at a particular point of time. The index shows the relative change over time in the volume of industrial production and is an effective tool to measure the trend of current industrial production. IIP can be defined as a single representative figure (an abstract number) to measure the general level of industrial performance in the economy. It is a short-term micro- economic indicator of industrial growth which is used extensively by Government Departments, Industrial Associations, Research Institutes, and Academicians etc. for research and policy making.

Due to liberal industrial policy and close proximity of the Haryana State to National Capital, the investment in the industrial sector is growing rapidly. There is need to continuously measure the growth of industrial sector with a view to assess and plan the industrial development schemes in the State. IIP is an effective indicator to assess the performance of State economy under industrial sector over a period of time. The need to prepare IIP was also felt to facilitate comparative studies on performance of various States/ UTs in the industrial sector and to bring uniformity in selection of items basket and preparation of weighting diagram, formula with a common methodology for preparation of IIP.

At the National level, National Statistical Office (NSO), Government of India prepares all India Index of Industrial Production. The Department of Economic and Statistical Affairs, Haryana is preparing Index of Industrial Production of Haryana since the year 1971-72. A number of State Directorates of Economics & Statistics are also engaged in compiling the State level Index of Industrial Production. The Govt. of India has constituted a Technical Advisory Committee (TAC) for an in-depth examination of various technical issues such as identification of representative items basket for individual State, development of corresponding weighting diagram with an appropriate linkage with the weighting diagram of all India's Index of Industrial Production etc. The TAC resolves technical issues relating to IIP and provides technical guidance in the matter of shifting the base year of current series to new series.

The recommendations of the Technical Advisory Committee on comparable Index of Industrial Production are examined by the NSO and the guidelines on compilation of State

level Index of Industrial Production are prepared. According to criteria laid down in the guidelines issued by NSO, the Department of Economic and Statistical Affairs, Haryana prepared the comparable State level Index of Industrial Production with base year 2011-12 for the year 2022-23.

METHODOLOGY

Scope and Coverage

The Index of Industrial Production (IIP) is prepared as per National Industrial Classification (NIC)-2008 for manufacturing and electricity sectors. The manufacturing sector covers the industries registered under section 2m (i) and 2m (ii) of the factory Act, 1948 and functioning within jurisdiction of Haryana State. The section 2m (i) refers to the units employing 10 or more workers with power and section 2m (ii) refers to the units employing 20 or more workers without power on any day of the preceding twelve months.

Base Year

To capture the changes in the industrial sector, the State series of IIP is revised from time to time by dropping obsolete items, including the new items in the items basket and also by shifting the base year to a more recent one. The current State series of IIP has been prepared on its base year 2011-12 under the overall guidance of National Statistical Office (NSO), Govt. of India, New Delhi.

The two stage methodology has been adopted for compiling an Index of Industrial Production. The first stage is to identify and select the items to be included in the items basket which could monitor and reflect the performance of the industrial sector. The second stage is to allocate the weights to the items included in the items basket.

The State level IIP with base year 2011-12 covers two major industrial sectors viz manufacturing (Registered) and electricity. Mining and Quarrying sector has been excluded due to its insignificant contribution in GSDP which was 0.04 percent in 2011-12 in the State. For selection of items weightage of each item in the base year has been determined. For this purpose total weight has been taken as 1000. The total weight of 1000 has been first distributed to registered manufacturing and electricity sectors on the basis of Gross Value Added of each sector for the base year 2011-12. For manufacturing sector, the weights of registered manufacturing sector have further been distributed to 2 digit industry groups (10-32) of NIC 2008. Previously, NSO (IS Wing), Kolkata used to explain the methodology, selection of item basket and preparation of weighting diagram and the States / UTs are to

prepare item basket and weighting diagram etc. but many States / UTs could not do it properly, therefore, NSO (IS Wing), Kolkata has selected the item basket and prepared weighting diagram and also prepared the list of factories (both selected and reserved) and provided to the States / UTs. The electricity sector has been taken as single item.

In all 178 items have been selected for the collection of production data for registered manufacturing sector of the base year 2011-12. The selected items have been assigned use based codes i.e. primary goods, capital goods, intermediate goods, infrastructure / construction goods, consumer durables and consumer non-durables.

The selected items have been classified under 3 digit industry groups which in turn have been classified under 2 digit industry group. List of selected items of manufacturing (registered) sector alongwith their respective item weight have been shown in table no 1.1.

Weighting Diagram

For this purpose, total weight has been taken as 1000. The total weight of 1000 has been first distributed to registered manufacturing and electricity sectors on the basis of Gross Value Added (GVA) of each sector for the year 2011-12. The weights of registered manufacturing sector have further been distributed to various 2 digit industry groups 10-32 of NIC-08. After that the 2 digit level weights have further been distributed to represent 3 digit groups. The weighting diagram prepared at item level is further assigned use based categories. Since electricity sector is a single item sector, no apportioning of weight has been done.

Table number 1.2 shows the distribution of weights for the year 2011-12 at sector level. Distribution of weight among selected groups at 2 & 3 digit level of manufacturing sector have been shown in table no. 1.3. Item level distribution of weights of manufacturing sector is available at table no. 1.4.

Selection of units

For selection of industrial units for collection of production data for manufacturing sector the unit wise ASI frame of items selected in the items basket for the year 2011-12 is used. Item-wise frame of Industrial units has been supplied by NSO (ISW), Kolkata. The month-wise data on generation of electricity taken from the website (www.cea.nic.in) and (npp.gov.in) NPP portal of the Central Electricity Authority is used. In this way, 544 industrial units have been selected for collection of data.

Source of data

For manufacturing sector, the Department of Economic & Statistical Affairs, Haryana has created necessary infrastructure for collection of data regularly from industrial units selected for the purpose. The data is collected directly from the selected industrial units by the District Statistical Officers of the department. Efforts are being made to promote online system for data collection. For electricity sector, the necessary data is obtained from the website of Central Electricity Authority www.cea.nic.in and NPP portal npp.gov.in.

Computation of Index Number

The change in production of selected units producing the item in the current period viz-a-viz their production in base year is relative change in the production of the item. The total production of an item in the current period is estimated using the relative change in production of the selected units.

The Index is computed by using the Laspeyre's Formula: -

$$I = \frac{\sum R_i W_i}{\sum W_i}$$

Where I = Index Number

R_i = Production relative of ith selected item

W_i = Weight assigned to ith item

∑ = Summation of all items within each group upto major group (2 digit) level.

The production relative of an item is defined as percentage growth of the production compared to the base year production.

$$R_i = \frac{P_{ci}}{P_{oi}} \times 100$$

Where R_i = Production relative of ith selected item.

P_{ci} = Current year production of ith item

P_{oi} = Base year production of ith item.

The production relatives are thus calculated at product (3 digit) level of NIC code and the ultimate indices are calculated up to major group (2 digit) level. Sectoral Indices and General Index are based on weighted Laspeyre's Index Number.

REVIEW OF INDEX OF INDUSTRIAL PRODUCTION IN HARYANA 2022-23

The industry sector recorded an annual positive growth of 7.2 percent in 2022-23 over the previous year as the Index of Industrial Production increased from 169.2 in 2021-22 to 181.4 in 2022-23. The sector-wise and group-wise details of IIP are given below: -

Manufacturing Sector

The Index of Manufacturing sector increased from 174.6 in 2021-22 to 185.1 in 2022-23 registering an annual positive growth of 6.0 percent over the previous year. The Manufacture of Furniture (31) recorded a growth of 949.1 percent, manufacture of Chemical and Chemical Products (20) recorded a growth of 475.8 percent, Manufacture of Tobacco products (12) recorded a growth of 348.3 percent, Manufacture of Crude and Refined Petroleum Products (19) recorded a growth of 201.0 percent, Manufacture of Beverages (11) recorded a growth of 188.9 percent, Manufacture of other Manufacturing (32) recorded a negative growth of 73.9 percent, Manufacture of Machinery equipment n.e.c (28) recorded a negative growth of 49.3 percent, Manufacture of wearing apparel (14) recorded a negative growth of 41.6 percent and Manufacture of Motor vehicles, trailers and semi trailers (29) recorded a negative growth of 11.7 percent respectively.

Electricity Sector

The Index of Electricity Sector increased from 99.6 in 2021-22 to 133.7 in 2022-23 registering a positive growth of 34.3 percent over the previous year.

The food manufacturing industries carry a weight of 83.50 in the Manufacturing sector. The index of this group increased from 36.1 in 2021-22 to 83.5 in 2022-23 recorded a growth of 131.3 percent. The index of Butter and other fats and oils derived from milk of cattle 14853.3 percent followed by Skim Milk and whey powder has recorded a highest growth of 10215.5 percent, Biscuit 6721.2 percent, Sugar confectionery (including white chocolate), not containing cocoa; vegetables, fruit, nuts, fruit-peel and other parts of plants, preserved by sugar 3490.1 percent, Other vegetable oils and fats, refined 1085.6 percent, Sugar 1040.1 percent, Guar kernel 212.8 percent, Milk 42.4 percent, Mud / molasses waste 24.9 percent, Refined sugar 3.7 percent. The index of Black Tea (CTC), Rice basmati, Husk (animal feed), Sauces; mixed condiments; mustard flour and meal; prepared mustard, Dried

vegetables and Gola (cattle feed) recorded a negative growth respectively.

2 - Manufacture of Beverages (11)

The beverage carry a weight of 12.57 in the Manufacturing sector. The index of this group has increased from 28.4 in 2021-22 to 82.1 in 2022-23 recorded a growth of 188.9 percent. The index of Soft drinks, carbonated beverages other than soda water, Country Liquor and its variant, Malt, whether or not roasted, Rectified spirit recorded a Positive growth respectively. Beer made from malt recorded a negative growth.

3 - Manufacture of Tobacco Products (12)

Tobacco group carry a weight of only 0.75 in the Manufacturing sector. The index of this group has increased from 178.5 in 2021-22 to 800.4 in 2022-23, recorded a positive growth of 348.3 percent. The index of Other Shelled nuts and Tobacco, chewing (scented or not) in this group recorded a positive growth respectively.

4 - Manufacture of Textiles (13)

The textiles industries carry a weight of 40.43 in the Manufacturing sector. The index of this group has increased from 117.2 in 2021-22 to 151.7 in 2022-23 recorded a positive growth of 29.5 percent. The index of Cotton, carded or combed is recorded highest growth 604.0 percent followed by Man-made fiber fabrics 339.14 percent, blankets 316.02 percent, Yarn dyed and cotton 244.8 percent, Fabrics/cloth 29.5 percent, Terry towel (cotton) 27.4 percent, Fabrics cotton 26.5 percent and Carpets and other textile floor covering, tufted 3.8 percent respectively. The index of Cotton fabrics, Carpets and other textile floor coverings, Knotted, Fabrics mixed, Yarn of wool, containing 85% or more by weight of wool, not put up for retail sale recorded a negative growth respectively. The index of Lining cloth, cotton and Fabrics, polyester fibre recorded a Nil growth respectively.

5 - Manufacture of Wearing Apparel (14)

The wearing apparel industry has been assigned the weight of 49.68 in the Manufacturing sector. The index of this group decreased from 103.9 in 2021-22 to 60.6 in 2022-23 recorded a negative growth of 41.6 percent. The index of Garments cloth, cotton is recorded positive growth of 8.5 percent. The index of Garments made up of textile fabrics impregnated, Garments made up of textile fabrics coated with other materials recorded a negative growth respectively.

6 - Manufacture of Leather and related Products (15)

The leather industries have been allotted a weight of 27.44 in the Manufacturing

sector. The index of this group has increased 127.2 in 2021-22 to 148.2 in 2022-23 recorded a positive growth of 16.5 percent. The index of Hand Bag, artificial fur recorded a highest growth 339.8 percent followed by Footwear with uppers of leather, other than sports footwear, footwear incorporating a protective metal toe-cap and misc. special footwear 32.9 percent respectively. The index of other sports foot wear , except skating boots and Footwear incorporating a protective metal toe-cap, except those covered in subclass 29320 recorded a negative growth of 5.8 and 3.5 percent respectively.

7 -Manufacture of Wood & Products of Wood & Cork, except Furniture, Manufacture of Articles of Straw & Plaiting Materials (16)

The wood industry has been assigned a weight of 3.09 in the Manufacturing sector. The index of this group has increased from 339.5 in 2021-22 to 524.1 in 2022-23 recorded a positive growth of 54.4 percent. The index of Wood cutting processed sized recorded a highest Growth of 3829.1 percent followed by Plywood 227.9 percent, plywood board 12.9 percent and Plywood decorative 1.4 percent respectively. The index of Wooden chips recorded a negative growth of 22.4 percent.

8 - Manufacture of Paper and Paper Products (17)

The paper industries have been assigned the weight of 9.27 in the Manufacturing sector. The index of this group has increased from 89.7 in 2021-22 to 153.3 in 2022-23 recorded a positive growth of 70.8 percent. The index of Paper polythene coated recorded a highest positive growth of 496.6 percent followed by Paper printing and writing 76.5 percent, Boxes, corrugated sheet recorded as 8.9 percent and sheet laminated plastic 4.5 percent as positive growth respectively. The index of other paper, paper board, cellulose wadding and webs of cellulose fibers, cut to size or shape, cigarette paper, in booklets or in rolls of a width not exceeding 5cm; of other articles of paper pulp, paper, paperboard, cellulose wadding or webs recorded a negative growth 9.3 percent.

9 - Printing and Reproduction of Recorded Media (18)

The printing and reproduction of recorded media carry a weight of 4.16 in the Manufacturing sector. The index of this group increased from 200.5 in 2021-22 to 212.1 in 2022-23 recorded a positive growth of 5.8 percent. The index of books recorded a positive growth 6.0 percent and waste paper recorded a negative growth 1.5 percent respectively.

10 - Manufacture of Coke, Refined Petroleum Products (19)

The petroleum industries carry a weight of 0.41 only. The index of this group increased from 79.8 in 2021-22 to 240.1 in 2022-23, recorded a positive growth of 201.0 percent. The index of industrial production of Argon Gas and Nitrogen liquid increased

45411.8 percent and 762.6 percent respectively. The index of oxygen liquid recorded a negative growth 28.0 percent.

11 - Manufacture of Chemical and Chemical Products (20)

The chemical and chemical products industry group carry a weight of 23.19 in the Manufacturing sector. The index of this group increased from 106.4 in 2021-22 to 612.9 in 2022-23 recorded a positive growth of 475.8 percent. The index of Paint, plastics emulsion recorded a highest growth of 784.6 percent followed by Paint 597.5 percent, Urea 23.3 percent, Primer, stoving, synthetic 16.5 percent and Bitumen recorded a 16.1 percent positive growth respectively. The index of Rexin recorded a Nul growth.

12 - Manufacture of Pharmaceuticals, Medicinal Chemical and Botanical Products (21)

The pharmaceuticals industries carry a weight 13.35 in the Manufacturing sector. The index of this group increased from 77.8 in 2021-22 to 110.6 in 2022-23 with a positive growth of 42.2 percent. The vaccine for Anti diabetic drugs excl. insulin (metformin, pioglitazone, glimepiride etc.) recorded a positive growth 334.9 percent followed by Bandage including adhesive gauze bandage 108.6 percent, Ointments, allopathic 49.6 percent and Vaccine for veterinary medicine 14.8 percent respectively. The index of and Glues and gelatin, peptones and their derivatives and related products; castigates and other casein derivatives; aluminates and other albumin derivatives recorded negative growth of 2.1 percent respectively.

13 - Manufacture of Rubber and Plastics Products (22)

The rubber and plastic industries have been assigned a weight of 22.53. The index of this group increased from 38.9 in 2021-22 to 55.1 in 2022-23 with a positive growth of 41.6 percent. The index of Button plastic recorded a highest positive growth of 2658.7 percent followed by Rubber cloth/sheet 26.6 percent, Unsaturated polyester resin 26.4 percent, Parts of footwear, removable insoles, heel cushions and similar articles, gaiters, leggings and similar articles and parts thereof 22.7 percent, Tyre tractor 13.1 percent, Component plastic 0.4 percent, Plastic bag 0.1 percent respectively. The index of Rubber break lining, recorded a negative growth of 5.7 percent. The index of Conveyor belts and Button moulds and other parts of button, button blanks, parts of slide fasteners recorded a Nul growth respectively.

14 - Manufacture of other Non-Metallic Mineral Products (23)

This industry group carry a weight of 18.73 in the Manufacturing sector. The index of this group has increased from 91.5 in 2021-22 to 151.2 in 2022-23 recorded a positive growth of 65.3 percent. The index of Cement, others products recorded highest growth of 1399.9 percent followed by Glass components 307.2 percent, Sanitary ware others of iron and steel

65.8 percent, Fibre glass sheet/board 53.5 percent, Cement Portland 28.0 percent, Asbestos, corrugated sheet 26.7 percent, Ceramic tiles 11.8 percent, Stone dust/powder 1.2 percent respectively, The index of Cement White, Tiles, flagstones, bricks and similar articles, of cement, concrete or artificial stone recorded a negative growth respectively.

15 - Manufacture of Basic Metals (24)

The basic metal group carries a weight of 48.60 in the Manufacturing sector. The index of this group has increased from 131.3 in 2021-22 to 190.3 in 2022-23 recorded a positive growth of 45.0 percent. The index recorded a highest positive growth of Copper zinc, base alloys, brass 1568.9 percent followed by Tubes, pipes of stainless steel 809.5 percent, Copper wire bars, refined 8.0 percent, CR sheet 1t 600mm 4.1 percent respectively. The index of Aluminum ingots 86.4 percent, Plates, hot rolled 79.9 percent, Cast iron 15.0 percent, Aluminum circles alloyed 9.1 percent and Cold finished/formed of flat rolled Products recorded a negative growth of 9.0 percent respectively.

16 - Manufacture of Fabricated Metal Products, Except Machinery and Equipment (25)

The fabricated metal products industry carry a weight of 32.54 in the Manufacturing sector. The index of this group decreased from 118.2 in 2021-22 to 111.9 percent in 2022-23 recorded a negative growth of 5.3 percent. The index recorded a highest growth Machine screw iron and steel 914.9 percent, followed by Grease guns excl compressed air type 599.8 percent, Bolts, screws, nuts, iron/steel 132.3 percent, Towers for transmission lines of iron and steel 61.0 percent, Liquefied petroleum gas (LPG) cylinders of iron and steel 52.9 percent and Forging, die stamping machines, Presses and hammers 28.8 percent respectively. The index of Heavy Machinery for fabrication, Link forging, Utensils of iron (other than cast iron) or steel, enameled, recorded a negative growth respectively.

17 - Manufacture of Computer, Electronic and Optical Products (26)

This industry group carry a weight of 11.16 in the Manufacturing sector. The index of this group has increased from 90.9 in 2021-22 to 105.9 percent in 2022-23, recorded a positive growth of 16.5 percent. The index of Electronic pcb/microcircuit recorded a highest growth 215.0 percent followed by Biological microscope 28.6 percent, Optical components 21.3 percent, Film polyester (metalized) 17.0 percent, Audio cd/dvd player 5.9 percent, Meter, electric-others 5.8 percent and Instruments and apparatus (except cathode-ray oscilloscopes and oscillograph) for telecommunications 4.9 percent respectively. The index of Drafting tables and machines, and other drawing, marking out or mathematical calculating instruments and Electro-diagnostic apparatus used in medical, surgical, dental recorded a negative growth

respectively.

18- Manufacture of Electrical Equipment (27)

The electrical equipment industries carry a weight of 58.22 in the Manufacturing sector. The index of this industry group decreased from 187.6 in 2021-22 to 247.3 in 2022-23, recorded a positive growth of 31.8 percent. The index of Fluorescent tubes 557.5 percent, recorded the highest growth of 557.5 percent followed by Boards, consoles, cabinets and other bases, equipped with electrical switching etc. apparatus, for electric control of the distribution of electricity, for a voltage exceeding 1000v 415.1 percent, Optical fiber cables, made up of individually sheathed fibers 293.7 percent, Wire, stainless steel, electrode quality 56.0 percent, Cable, rubber insulated 18.5 percent, Light fitting accessories 13.1 percent, Parts of electricity distribution or control apparatus 11.3 percent, Cable, pvc insulated 8.9 percent, Parts of electric motors, generators and the like 8.0 percent, Motor fan 7.4 percent and Fabricated metal products 1.7 percent respectively.

19 - Manufacture of Machinery and Equipment n.e.c (28)

The machinery equipment industry carry a weight of 106.6 in the Manufacturing sector. The index of this group has decreased from 391.8 in 2021-22 to 198.8 in 2022-23 with a negative growth of 49.3 percent. The index of internal combustion piston engines, cultivators, other than for motor vehicles and aircraft recorded a highest positive growth of 117516.6 percent followed by parts of agricultural machinery 92601.1 percent, Other agricultural tractors 483.4 percent, Scrap cast iron 281.4 percent, Book Binding machinery, machinery for type-setting and the for for uses ancillary to printing (except office type sheet-fed) 36.4 percent, Diamond tools 33.0 percent, Water pump 30.6 percent, Hydraulic equipment 11.9 percent, Compressor used in refrigerator 11.2 percent, Bearing, steel 8.0 percent, Tamping machines and rod rollers, self propelled 7.0 percent, Offset printing machines 1.5 percent and Filter for beverages 0.9 percent respectively. The index of Air conditioner-window/wall 88.9 percent, AC motor car 18.5 percent and Cultivators 15.1 percent recorded a negative growth respectively.

20 - Manufacture of Motor Vehicles, Trailers and Semi-Trailers (29)

This industry group carry highest weight of 230.72 in the Manufacturing sector. The index of this group decreased from 225.9 in 2021-22 to 199.5 in 2022-23 recorded a negative growth of 11.7 percent. The index of Leaf spring for motor vehicles recorded as highest positive growth 7511.1 percent followed by Trailers and semi trailer of caravan type, for housing or camping 6533.3 percent, Axle 77.5 percent, Sheet for motor vehicle 42.8 percent, Auto door rubber fittings 30.0 percent, Silencer 25.4 percent, Shafts all kinds 16.5 percent, Shock absorbers 10.3 percent, Parts of petrol engine for motor vehicles 6.8 percent,

Parts and accessories for the goods job subclass 49211 at 6.5 percent, Gear case assemblies 4.8 percent, Steering gear control system 4.2 percent, Locks used in motor vehicle 4.0 percent, Exhaust tubes 3.3 percent, Gear boxes, motor vehicles 3.2 percent and Spring pins 1.8 percent respectively. The index of Engine assembly parts 51.2 percent, Air break sets 36.6 percent and Mini bus/bus-complete 0.7 percent recorded a negative growth respectively.

21 - Manufacture of Other Transport Equipment (30)

The other transport equipment industry has assigned a weight of 121.25 in the Manufacturing sector. The index of this group increased from 76.5 in 2021-22 to 227.4 percent in 2022-23 recorded a positive growth of 197.3 percent. Tracks, railway/tramway recorded a highest growth 727.7 percent, followed by Parts and accessories of motorcycles and side cars 331.6 percent, Motor cycle, racing with cylinder capacity exceeding 50 cc 78.7 percent and Parts for motorcycle/moped/cycle 7.1 percent respectively.

22 - Manufacture of Furniture (31)

The furniture industry carry a weight of 0.41 only in the Manufacturing sector. This group contained only one product i.e. furniture and fixture wooden with a positive growth of 949.1 percent.

23 - Other Manufacturing (32)

The other manufacturing industry group has been assigned a weight of 9.21 in the Manufacturing sector. The index of this group has decreased from 1186.0 in 2021-22 to 309.7 in 2022-23 recorded as negative growth of 73.9 percent. The index of **Ornaments imitation** has recorded highest growth of 1412.3 percent followed by **Handicraft / decorative fancy items** 64.3 percent, Electricity 34.3 percent, Lens, ophthalmic 34.3 percent, Pen body plastic 17.3 percent, Sports goods rubber 15.7 percent and Blade, stainless steel 3.0 percent respectively. The index of staplers 99.2 percent and Medical surgical or laboratory sterilizers 66.0 percent has recorded a negative growth respectively.

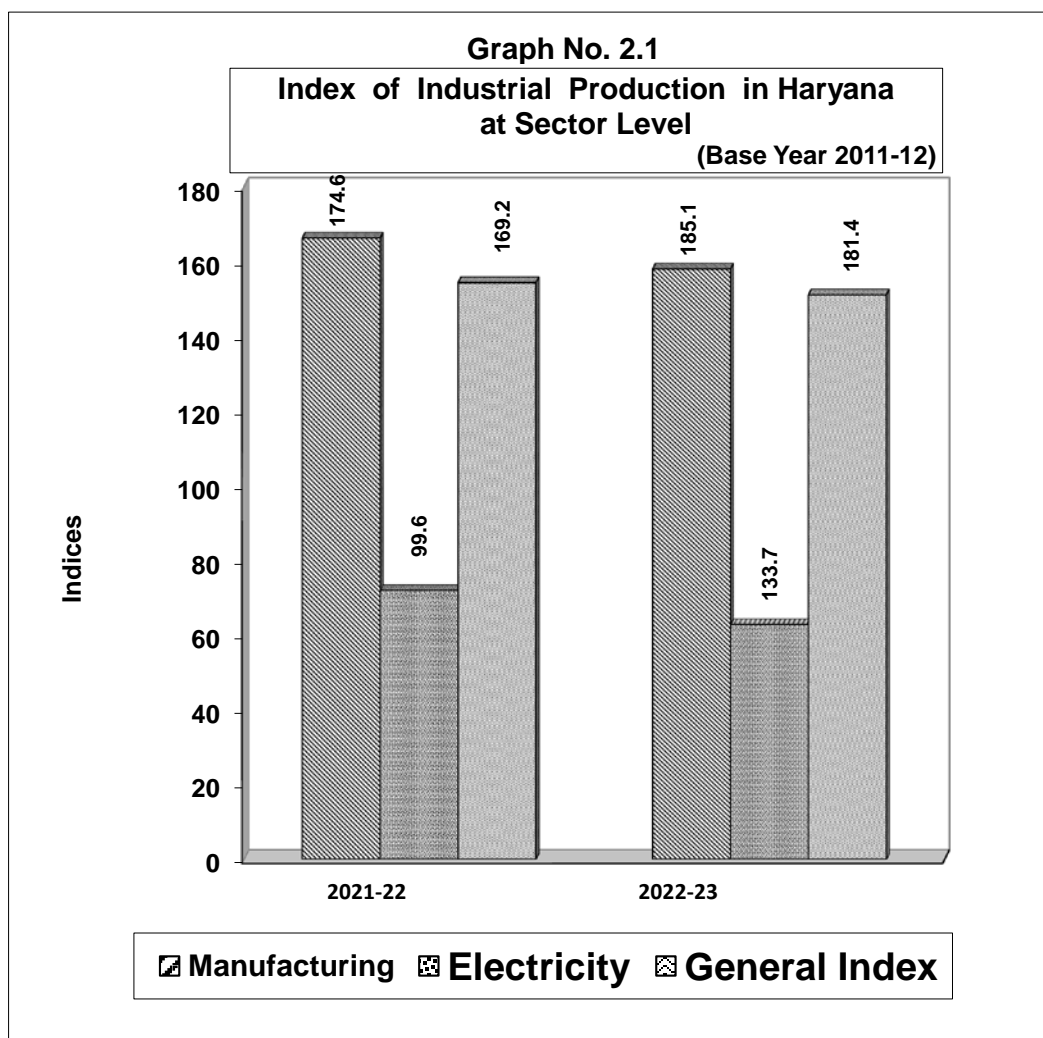

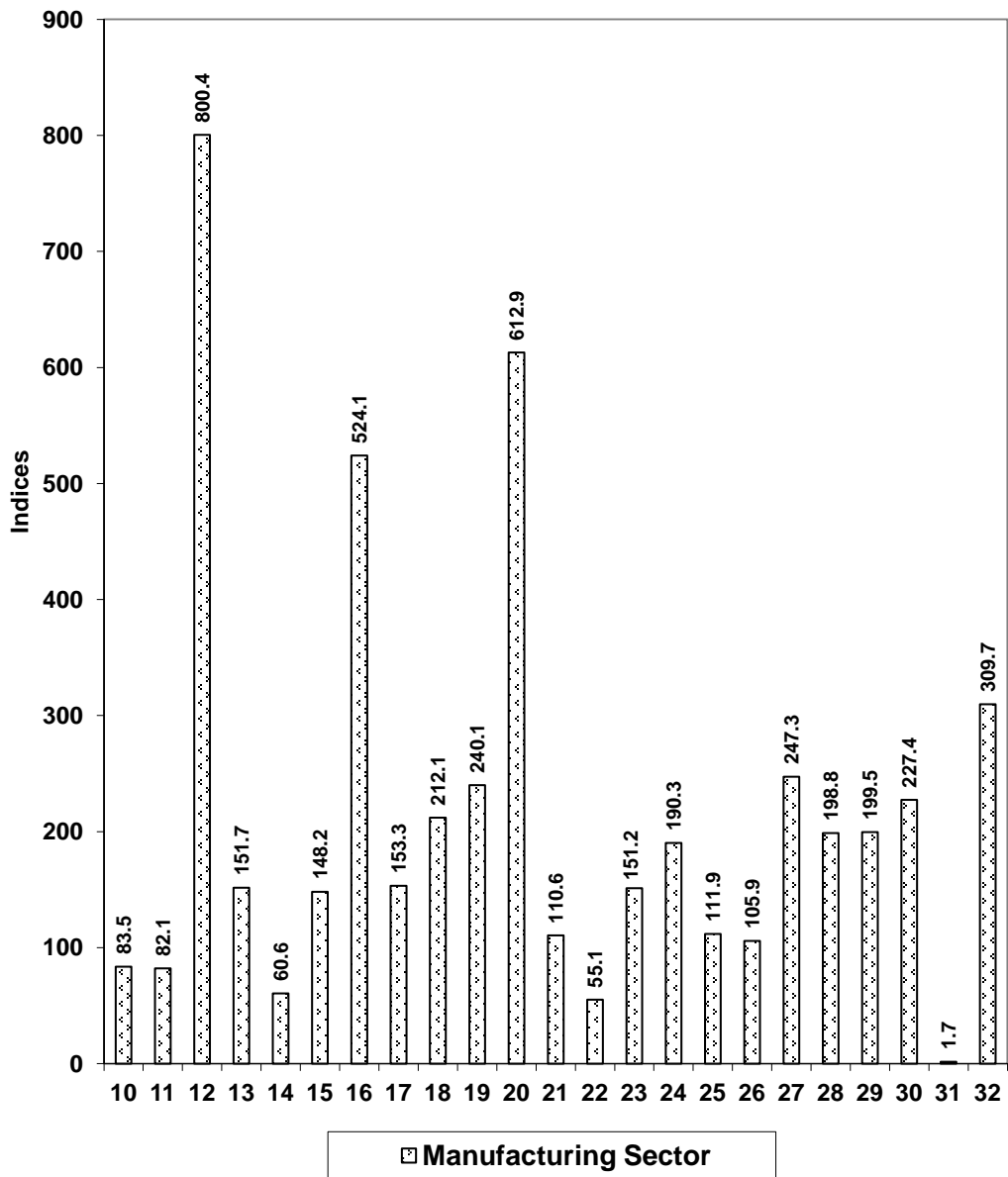

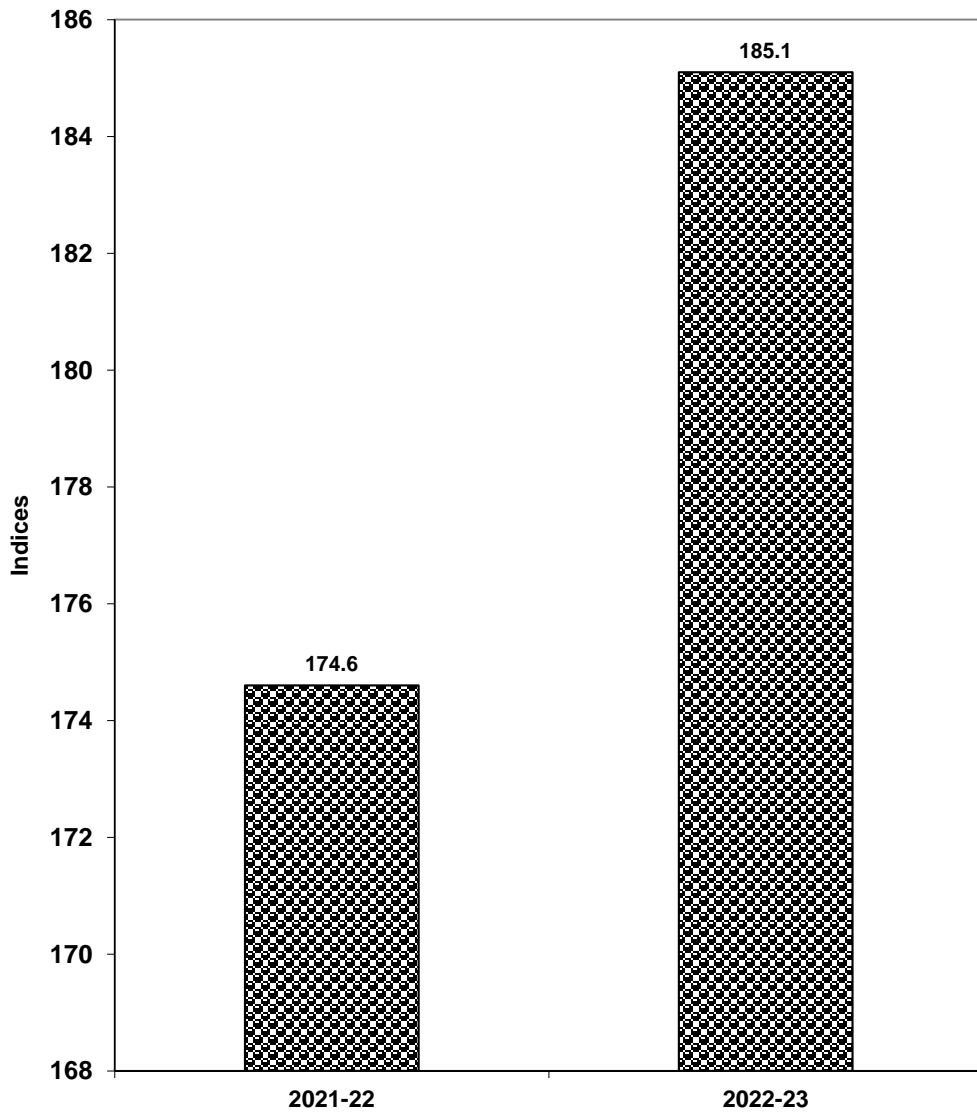

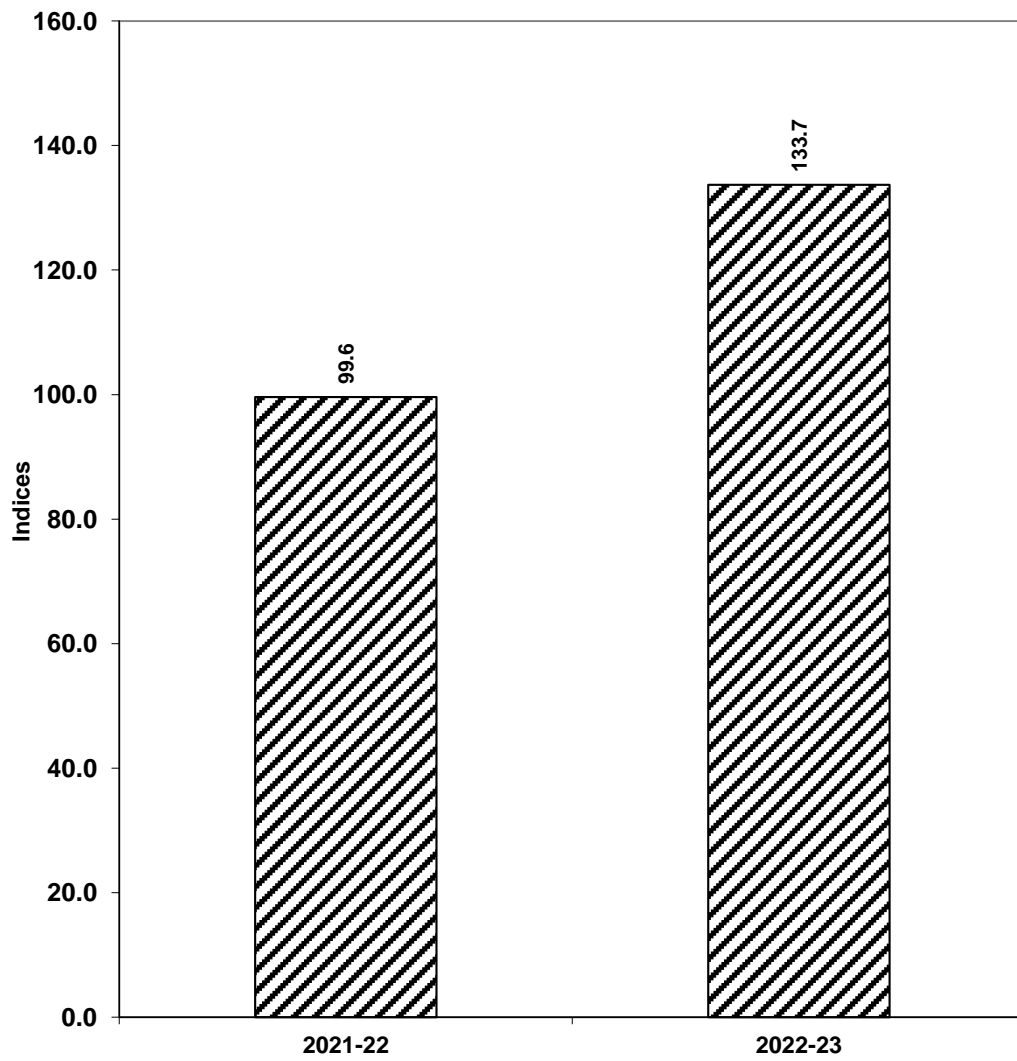
**Annual Index of Industrial Production in Haryana

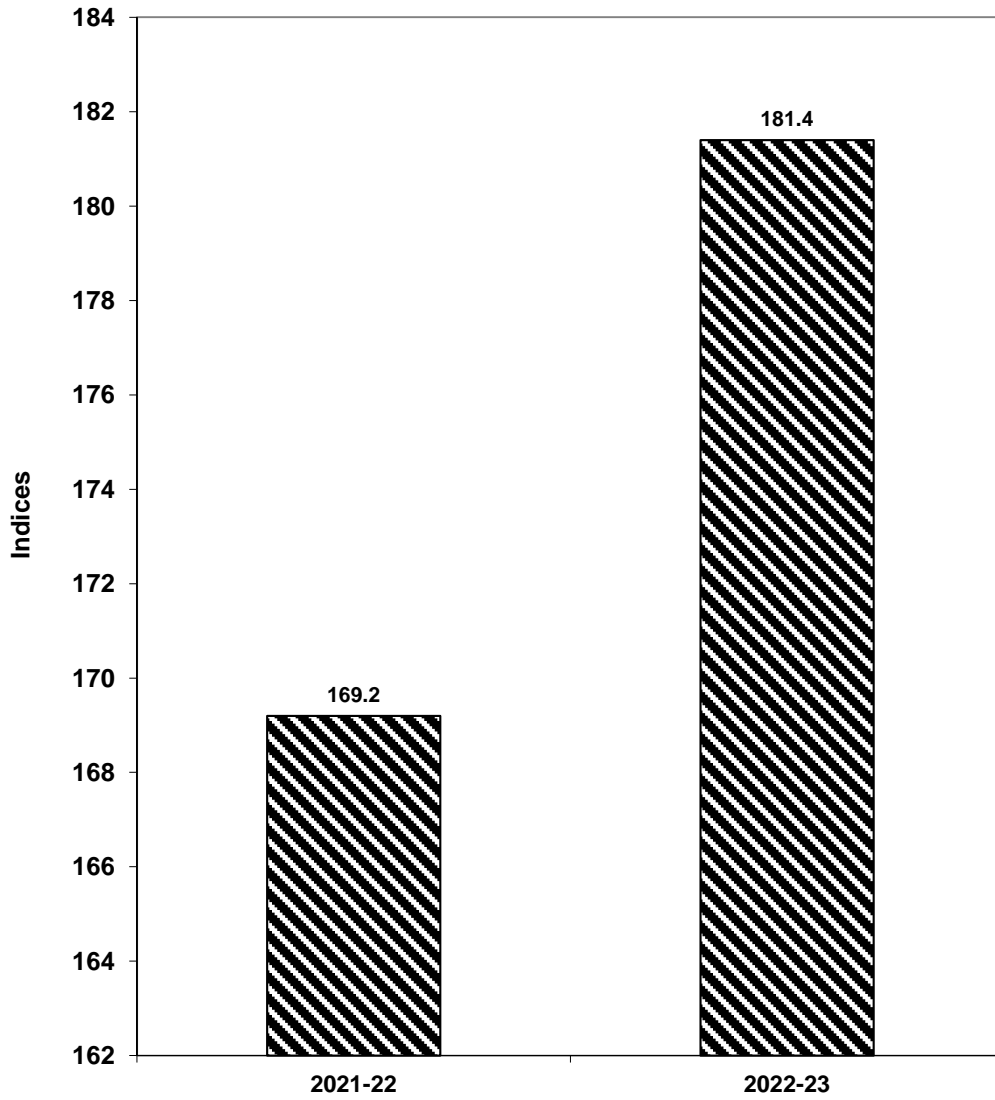
**Annual Index of Industrial Production in Haryana

INDEX OF INDUSTRIAL PRODUCTION IN HARYANA

Use-Based Classification

The Use-Based Classification represents the changing pattern of customer's needs, based on the tastes and habits towards the purchase of industrial products. The industrial products have been clubbed into four major groups comprising of Basic Goods Industries, Capital Goods Industries, Intermediate Goods Industries and Consumer Goods Industries with a view to analyse the movement of growth rate of different groups of industries and their achievements within the frame of organized sector.

The Use-Based Classification represents the classification of the industrial products according to the product applications. Each industry group reflects the variations in the production of a particular class of industries based on product usage. The industries are classified into six groups viz., Primary Goods, Capital Goods, Intermediate Goods, Infrastructure/Construction Goods, Consumer Durables and Consumer Non-Durables Goods. Concepts and definitions for Use-Based Classification are given below.

(i) Primary Goods

Only such goods which are directly obtained from natural sources and used for further processing and consumption in manufacturing and power generating activities.

(ii) Capital Goods

Plants, machinery and goods used for further investments.

(iii) Infrastructure/Construction Goods

Finished goods which are primarily used in infrastructure industry or construction industry as an input. This category has been created to precisely items which could not be classified under consumer durables or intermediate goods

(iv) Intermediate Goods

Any goods/products produced as incomplete product or which goes as input in production for further finishing or forming a part of a product.

(v) Consumer Durables

Products directly used by consumers and having a longer durability (more than 2 to 3 years).

(vi) Consumer Non-Durables

Products that are directly used by consumers and cannot be preserved for long periods.

The share of each use-based industry group to the industry sector of the State and the number of industrial groups and items covered representing the use-based groups are as under: -

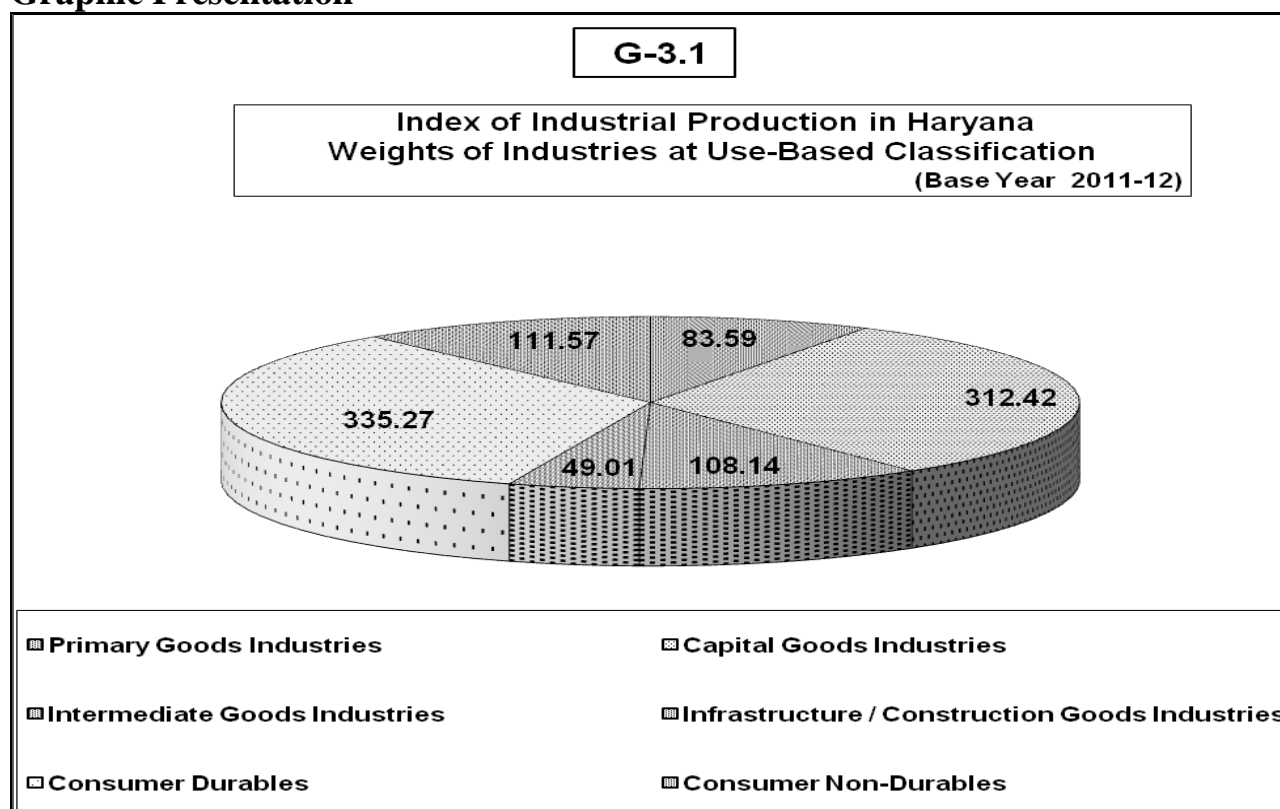

During the year 2022-23, Infrastructure / Construction Goods recorded highest growth of 16.0 percent followed by Consumer Non-Durables 121.6 percent, Capital Goods Industries 7.9 percent and Intermediate Goods Industries 6.9 percent. The Primary Goods Industries 77.2 percent and Consumer Durables Goods 18.8 percent recorded a negative growth.,









A. Primary Goods Industries

Primary Goods Industries which has been assigned the weight of 83.59 recorded a negative growth of 77.2 percent during the year 2022-23 as compared to the previous year. The index of this industry group decreased from 90.7 in 2021-22 to 20.6 in 2022-23. The Argon gas, Nitrogen Liquid, Liquefied Petroleum Gas (LPG) Cylinders of iron and steel, Urea and Bitumen recorded a positive growth in this group. The index of Oxygen liquid and Electricity have recorded negative growth over the previous year.

B. Capital Goods Industries

The Index of Capital Goods Industries having weight of 312.42 showing a growth of 207.6 in 2021-22 to 224.1 in 2022-23. recorded a positive growth of 7.9 Percent. The Conveyor belts, Internal combustion piston engines, other than for motor vehicles and aircraft, Parts of agricultural machinery, Tracks, railway/tramway, Other agricultural tractors, Acephate / Speedometer, Axle, Wire, stainless steel, electrode quality, Bookbinding machinery; machinery for type-setting and the and offset printing machinery) like; printing machinery machines for uses ancillary to printing (except office type sheet-fed, Diamond tools, Auto door rubber fittings, Forging, die stamping machines incl. Presses and hammers, Biological microscope, Optical components, Shafts, all kinds, Tyre tractor, Hydraulic equipment, Parts of electricity distribution or control apparatus, Compressors used in refrigerator, Shock absorbers, Air brake sets, Parts of electric motors, generators and the like, Motors, fan, Tamping machines and road rollers, self-propelled, Steering gear control system, Exhaust tubes, Spring pins, Fabricated metal products and Offset printing machines recorded a positive growth in this group. The index of Leaf spring for motor vehicles, Link forging, Heavy machinery for fabrication, Engine assembly parts, Electro-diagnostic apparatus, used in medical, surgical, dental, Cultivators, Rubber brake lining and Mini bus / bus – complete recorded a negative growth in this group.

C. Intermediate Goods Industries

The Intermediate Goods Industries carry a weight of 108.14. The Index of this industry group has increased from 174.6 in 2021-22 to 186.6 in 2022-23 recorded a increased of 6.9 percent. The Wood cutting processed sized, Copper zinc base alloys, brass, Machine screw iron and steel, Tubes, pipes of stainless steel, Plywood, Bolts, screws, nuts, iron /steel,

Sanitary ware others of iron and steel, Towers for transmission lines of iron and steel, Fibre glass sheet/board, Seat for motor vehicle, Unsaturated Polyester Resin, Mud / molasses waste, Film polyester (metalised), Plywood board, Copper wire bars, refined, Bearing, steel, Gear case assemblies, Sheet laminated plastic, C R sheet l t 600 mm, Locks used in motor vehicles, Gear boxes, motor vehicles, Plywood decorative, Stone dust/powder and Aluminium alloys profile hollow recorded as positive growth in this group. The index of Utensils of iron (other than cast iron) or steel , enamelled, Aluminium ingots, Plates, hot rolled, Medical, surgical or laboratory sterilizers, Cast iron, Wooden chips and Aluminium circles alloyed recorded as negative growth during the year over previous year.

D. Infrastructure/Construction Goods Industries

Infrastructure/construction Goods Industries has captured the weight of 49.01. This industry group has recorded a positive growth of 231.8 percent during the year 2022-23 as the index of this group increased from 127.6 in 2021-22 to 423.4 in 2022-23. The Cement, others products, Paints, plastic emulsion, Paint, Optical fibre cables made up of individually sheathed fibres, Scrap cast iron, Cement, portland, Asbestos , corrugated sheet, Cable, rubber insulated, Primer, stoving, synthetic, Ceramic tiles and Cable, pvc insulated recorded as positive growth in this group. The index of Tiles, flagstones, bricks and similar articles, of cement, concrete or artificial stone, Cold finished/formed of flat rolled products and Cement, White recorded a negative growth in this group.

E. Consumer Durables Industries

The Consumer Durable Goods Industries has been assigned the weight of 335.27. The Index of this industry group has decreased from 208.7 in 2021-22 to 169.5 in 2022-23 recorded a negative growth of 18.8 percent. The index of Trailers and semi-trailers of the caravan type, for housing or camping, Button plastic, Furniture & fixture wooden, Ornaments imitation, Cotton, carded or combed, Grease guns excl compressed air type, Fluorescent tubes, Paper polythene coated, Boards, consoles, cabinets and other bases, equipped with electrical switching etc. apparatus, for electric control or the distribution of electricity, for a voltage exceeding 1000 v, Hand bag, artificial fur, Man-made fibre fabrics, Parts and accessories of motorcycles and side-cars, Blankets, Glass components, Yarn dyed, cotton, Electronic p c b /micro circuit, Motor cycle, racing with cylinder capacity exceeding 50 cc,

Paper, printing & writing, Handicraft / decorative fancy items, Lens, ophthalmic, Footwear with uppers of leather, other than sports footwear, footwear incorporating a protective metal toe-cap and miscellaneous special footwear, Water pump, Fabrics/cloth, Terry towell (cotton), Rubber cloth/sheet, Fabrics, cotton, Silencer, Parts of footwear; removable insoles, heel cushions and similar articles; gaiters, leggings and similar articles, and parts thereof, Pen body plastic, Sports goods rubber, Light fitting accessories, Boxes, corrugated sheet, Garment cloth, cotton, Parts for motor cycle/moped/ cycle, Parts of petrol engines for motor vehicles, Parts and accessories for the goods of subclass 49211, Books, Audio cd/dvd player, Meter, electric –others, Instruments and apparatus (except cathode-ray oscilloscopes and oscillographs) for telecommunications, Carpets and other textile floor coverings, tufted, Blade, stainless steel, Components plastic and Plastic bag recorded as positive growth in this group. The index of Staplers, Air conditioner-window/wall, Ac motor car, Yarn of wool, containing 85% or more by weight of wool, not put up for retail sale, Garments made up of textile fabrics coated with other materials, Fabrics, mixed, Carpets and other textile floor coverings, knotted, Cotton fabrics, Other paper, paperboard, cellulose wadding and webs of cellulose fibres, cut to size or shape; cigarette paper, in booklets or tubes, or in rolls of a width not exceeding 5 cm; of other articles of paper pulp, paper, paperboard, cellulose wadding or webs, Garments made up of textile fabrics impregnated, Other sports footwear, except skating boots, Drafting tables and machines, and other drawing, marking-out or mathematical calculating instruments and Footwear incorporating a protective metal toe-cap, except those covered in subclass 29320 recorded as a negative growth.

F. Consumer Non -Durables Industries

The Consumer Non-Durable Goods Industries has been allotted the weight of 111.57. The Index of this industry group has increased from 40.8 in 2021-22 to 90.4 in 2022-23 have recorded a positive growth of 121.6 percent as compared to previous year. The index of Rectified spirit, Butter and other fats and oils derived from milk of cattle, Skim milk and whey powder, Biscuits, Sugar confectionery (including white chocolate), not containing cocoa; vegetables, fruit, nuts, fruit-peel and other parts of plants, preserved by sugar, Malt, whether or not roasted, Other vegetable oils and fats, refined, Sugar, Tobacco, chewing (scented or not), Antidiabetic drugs excl.insulin (metformin, pioglitazone, glimepiride etc), Guar kernel, Bandage including adhesive gauze bandage, Other shelled nuts,

Soft drink , carbonated beverage other than soda water, Ointments, allopathic, Milk, Vaccine Paper, printing & writing, Handicraft / decorative fancy items, Lens, ophthalmic, Footwear with uppers of leather, other than sports footwear, footwear incorporating a protective metal for veterinary medicine, Country Liquor and its variant, Refined sugar and Filters for beverages recorded as a positive growth. The index of Gola (cattle feed), Dried vegetables, Sauces; mixed condiments; mustard flour and meal; prepared mustard, Husk (animal feed), Rice basmati, Black Tea (CTC), Glues and gelatine, peptones and their derivatives, and related products; caseinates and other casein derivatives; albuminates and other albumin derivatives, Beer made from malt and Waste paper have recorded as negative growth respectively.
