No. 7-11/EC/DD/2015: Whereas, the Administrator of Daman and Diu has increased the number of Gram Panchayats from ten to eleven in Daman district in the Union Territory of Daman & Diu vide Notification No. 08 F. No. 5-49/PRI/(DELI-PAN)/2014-15/120 dated 24.03.2015;

And, whereas, the Administrator of Daman and Diu has determined the total number of seats (including the seats of Sarpanch) for each Gram Panchayat vide Notification No. 10 F. No. 5-49/PRI/(DELI-PAN)/2014-15/121 dated 09.04.2015;

And, whereas, the UT Administration of Daman and Diu has published the Daman and Diu Panchayat (Reservation and Rotation of seats for the Scheduled Castes, the Scheduled Tribes and women) Rules, 2015 vide Notification No. 12 F. No. 5/58/PRI/REV-RULES/2014-15/14 dated 30.04.2015;

And, whereas, the Election Commission for the Union Territory of Daman and Diu, appointed under section 185 of the Andaman and Nicobar Islands (Panchayats) Regulation, 1994, has delimited the wards of Gram Panchayats in the UT of Daman and Diu and notified them in the Official Gazette of Daman and Diu vide Notification No. 14 F. No. 7-5/EC/DD/2015 dated 09.05.2015.

And, whereas, Rule 3 (1) (b) of the Daman and Diu Panchayats (Election Procedure) Rules, 2014 provides that "wards in which seats are reserved for the Scheduled Castes, the Scheduled Tribes, Women belonging to these castes or tribes and Women shall, as far as practicable, be distributed in different parts of the Gram Panchayat and the District Panchayat and they shall be rotated by the Commission by draw of lots so that it is ensured that seats are so reserved in all the wards of a Gram Panchayat and the District Panchayat, as the case be, before such reservation is made in respect of a ward for the second time."

Therefore, in compliance thereto, a public draw of lots was held at Vivekananda Hall at Nani Daman on 15.07.2015 in the presence of representatives of Political Parties and others interested in the subject to identify the seats reserved for women, the Scheduled Castes, the Scheduled Tribes, and women belonging to these castes or tribes in the Gram Panchayats and the offices of Sarpanches of the Gram Panchayats in Daman District;

Now, consequent to the draw of lots, the Election Commission hereby allots the seats reserved for women, the Scheduled Castes, the Scheduled Tribes, and women belonging to these castes or tribes in the Gram Panchayats and the offices of Sarpanches of the Gram Panchayats in Daman district in the UT of Daman and Diu, as appended in Schedule 'A' & 'B' of this order respectively for the forthcoming General Election in compliance with sub-section 12 of the Daman and Diu Panchayat Regulation, 2012 read with rule 3 (1) (b) of the Daman and Diu (Election Procedure) Rules, 2014.

Whereas, the Election Commission for the Union territory of Daman and Diu, appointed under section 185 of the Andaman and Nicobar Islands (Panchayats) Regulation, 1994, in exercise of the powers conferred by sub-section (1) of section 9A of the Daman and Diu Village Panchayats (Amendment) Regulation, 1994 read with rule 28 and 33 of the Daman and Diu (Panchayats) (Election Procedure) Rules, 1995 had issued the Daman and Diu Panchayats Election Symbols (Reservation and Allotment) Order 2000 vide Order No.7-9/EC/DD/99/323 dated 03.07.2000 and subsequently modified it vide Order No.7-9/EC/DD/2005 dated 26.08.2005 and Order No.7-9/EC/DD/2010 dated 26.07.2010;

Whereas, Table-1 and Table-3 of the said Order have become outdated;
