ORDER

8 -16 /EC/DNH/2005

Dated the 6th October, 2005

Whereas, In exercise of the powers vested in him under sub-sections (1),(2) & (3) of section of the Dadra and Nagar Haveli Municipal Council Regulation, 2004, the Administrator of Union Territory of Dadra and Nagar Haveli has determined the number of seats to be reserved the Scheduled Castes and the Scheduled Tribes, women belonging to the Scheduled Castes the Scheduled Tribes and women in the Silvassa Municipal Council vide the Administrations ification No. DNHMR/Munl./Seats - Reser./2005/9/491, dated the 19th July, 2005;

Whereas sub-section (4) of section 10 of the Dadra and Nagar Haveli Municipal Council, 4 provides that the seats reserved for the Scheduled Castes or the Scheduled Tribes or the men under sub-sections (1), (2) & (3) shall be allotted by rotation to different wards in a ncil in such manner as the Election Commission may. by order published in the Official ette, direct in this behalf.

Whereas the Election Commission, vide its Order No. 8 -13/EC/DNH/2005, dated the h September, 2005, has directed that the seats reserved for the Scheduled Castes and the eduled Tribes, women belonging to the Scheduled Castes and the Scheduled Tribes and men shall be allotted by rotation to different wards in a Council by draw of lots ;

Now, therefore, in exercise of the powers vested in it by sub-section (4) of section 10 of the Dadra and Nagar Haveli Municipal Council Regulation, 2004, read with rule 3(1) (c) of the Dadra and Nagar Haveli Municipal Council (Elections) Rules, 2005, the Election Commission, consequent upon the draw of lots held on the 3rd October, 2005 at Silvassa, hereby allots the seats reserved vide the Administration's Notification No. DNHMR/Muni/Seats-reserved/2005/9/491, dated the 19th July, 2005, aforesaid, to different wards of the Silvassa Municipal Council, as shown in the Table below, for the purpose of ensuing elections.
