
Subject: - Result of Bye Elections to casual vacancies in PRIs - reg.

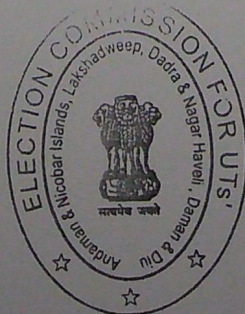


And, whereas, for the aforesaid constituencies, the poll was taken on 18th August, 2019;
