No. 8-2/EC/DNH/2020: Whereas, in pursuance of the provisions of Rule 29 of the Dadra and Nagar Haveli Panchayats (Election Procedure) Rules, 2014, the Election Commission for the Union Territory of Dadra & Nagar Haveli and Daman & Diu, had issued the election programme for the conduct of election to all wards of Gram Panchayats and District Panchayat in Dadra and Nagar Haveli, Union Territory of Dadra & Nagar Haveli and Daman & Diu, to constitute new Gram Panchayats and District Panchayat in Dadra and Nagar Haveli vide Notification No. 8-2/EC/DNH/2020 dated 14<sup>th</sup> October, 2020, according to which the poll was held on 8<sup>th</sup> November, 2020;

And whereas, the Director of Panchayat & Municipal Elections, Dadra & Nagar Haveli and Daman & Diu, vide her letter No. JS/PE-ME/ELEC/Repoll/2020/338 dated 9<sup>th</sup> November, 2020 has recommended for re-polling on Polling Station No. 130 of Ward No. 9/9 of Gram Panchayat, Randha, on the report of the District Election Officer, Dadra and Nagar Haveli / Returning Officer, District Panchayat, Dadra and Nagar Haveli. The District Election Officer, Dadra and Nagar Haveli / Returning Officer, District Panchayat, Dadra and Nagar Haveli in his report bearing No. ADM/Election/D-SMC/2020/CR-Rep/4304 dated 9<sup>th</sup> November, 2020 has mentioned that on scrutiny of Presiding Officer's Diary, it has been ascertained that at Polling Station No. 130 of Gram Panchayat, Randha, the votes polled on the EVM and the votes recorded of Register of Voters (Form-25) did no match and recommended that re-poll on the aforesaid Polling Station No. 130 be undertaken.

And whereas, the Election Commission for the Union Territory of Dadra & Nagar Haveli and Daman & Diu, after careful examination of the recommendations of the Director of Panchayat & Municipal Elections, Dadra & Nagar Haveli and Daman & Diu, report of the District Election Officer, Dadra and Nagar Haveli / Returning Officer, District Panchayat, Dadra and Nagar Haveli, and after taking all material facts and circumstances into account is satisfied that the poll process has been vitiated at Polling Station No.130 of Ward No.9/9 of Gram Panchayat, Randha, in Dadra and Nagar Haveli.
