No.5-2/EC/A&N/2021 : Whereas, the Administrator of the Union Territory of Andaman and Nicobar Islands has, by a Notification under Rule 19 of the Andaman and Nicobar Islands (Municipal) (Preparation of Electoral Rolls and Conduct of Elections) Rules, 1995, published in the Official Gazette on the 4th February, 2022, called upon all Wards of Port Blair Municipal Council in the Andaman and Nicobar Islands to elect members for the purpose of constituting a new Council.

And, whereas, in pursuance of the provisions of Rule 24 of the Andaman and Nicobar Islands (Municipal) (Preparation of Electoral Rolls and Conduct of Elections) Rules, 1995, the Election Commission for the Union Territory of the Andaman and Nicobar Islands, vide its Notification No. 5-2/EC/A&N/2021 dated 4th February, 2022, has appointed dates for filing nominations, taking the poll, etc..
