- 1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. # Buyer Added Bid Specific Terms and Conditions/क्रेता द्वारा जोड़ी गई बिड की विशेष शर्तें

### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity  $\div$  Original quantity)  $\times$  Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### 2. Generic

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

### 3. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

### 4. Generic

Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.

## 5. **Generic**

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- 2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

### 6. Scope of Supply

Scope of supply (Bid price to include all cost components): Only supply of Goods

### 7. Turnover

Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

## 8. Inspection

**Nominated Inspection Agency:** On behalf of the Buyer organization, any one of the following Inspection Agency would be conducting inspection of stores before acceptance: Pre-dispatch Inspection at Seller Premises (applicable only if pre-dispatch inspection clause has been selected in ATC):

### 9. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- A. The product offered must match the specifications. Better and Higher Specifications and Positive deviations will be accepted.
- B. Sample Clause: Concerned Consignee shall draw sample from delivered good, or inspect ion from Government Notified Labs, amount towards inspection shall be reduced from Pay ment of delivery. If Material fails to confirm specification, supplier shall be responsible for r eplacement of goods. Such replacement shall be done within 1 week from date of commun ication on email.
- C. Bidder experience: In respect of the filter applied for experience criteria, the Bidder can have any experience working with Govt /Pvt.
- D. The Purchaser reserves the right to issue Repeat Orders per Clause 3.3.2 of Maharashtra Government Resolution dated 01.12.2016.
- E. Terms and conditions mentioned in Maharashtra Government Resolution for Purchase by industry, Power and Labour department dated 01.12.2016, 24.08.2017 as well as 08.12.20 17 will also be applicable.
- F. Quantity & Delivery: Quantity of goods mentioned in contract is indicative quantity, it m ay vary with actual requirement. Purchaser reserve the rights to reduce or increase Quantit y based on actual requirement. Delivery shall be on monthly basis and Quantity shall be co nveyed, supplier shall supply within 30 days from receipt of such communication. (Minimu m Quantity per Delivery can be 100-150 Kgs).
- G. Liquidated Damages: If the supplier fails to deliver any or all of the goods within the peri od specified in the Contract. The purchaser shall, without prejudice to its other remedies under the Contract, deduct from the Contract Price, a s liquidated damages, a sum equival ent to 0.5% of the delivery price of the delayed goods for each week or part thereof of dela y until actual delivery, up to a maximum deduction of 5% of stipulated price of the stores. However, the Purchaser may in its sole discretion without assigning any reason may refuse

to extend the delivery period.

H. Payment: 100% payment against delivery after satisfactory inspection report from Gove rnment Approved LAB. Subject to availability of Grants from State Government.

**Risk Purchase:** The contractor fails to deliver the stores of any instalment thereof within the period fixed for such delivery or at any time repudiates the contract before the expiry of such period, the Government is entitled to cancel the contract and repurchase the stores not delivered at the risk and cost of the defaulting contractor. In the event of such a risk purchase, the defaulting contractor shall be liable for any loss which the Government may sust ain on that account provided the purchase, or if there is an agreement to purchase, such a greement is made, in case of default to deliver the stores by the stipulated delivery period, within one month from the date of such default and in case of repudiation of the contract before the expiry of the aforesaid delivery, within one month from the date of cancellation of the contract.

**Fall Clause:** It is a condition of the contract that all through the currency thereof, the price at which you will the supply stores should not exceed the lowest p rice charged by you to a ny customer during the currency of the rate contract and that in the event of the prices go ing down below the rate contract prices you s hall promptly furnish such information to us to enable to amend the contract rates for subsequent supplies.

3. Force Majeure Clause: If, at any time, during the continuance of this contract the perf ormance in whole or in part by either party of any obligation under this contract shall be pr evented of delayed by reason of any war, hostility, acts of the public enemy, civil commoti on, sabotage, fires, floods, explosions, epidemic quarantine restriction, strikes, lock-outs or acts of God (hereinafter referred events"), provided notice of happening of any such event uality is given by either party to the other within 21 days from the date of occurrence thereof, neither party shall by reason of such event, be entitled to terminate this contract n or shall either party have any claim for damages against the other in respect of such nonperformance or delay in performance: and deliveries under the contract shall be resumed a s soon as practicable after such event has come to an end or ceased to exist, and the decis ion of the purchasing officer as to whether the deliveries have been so resumed or not, sha Il be final and conclusive, provided further that if the performance in whole or part of any o bligation under this contract is prevented or delayed by reason of any such event for a peri od exceeding 60 days, either party may at its option terminate the contract PROVIDED ALS O that it the contract is terminated under this clause, the purchaser shall be at liberty take over from the contract at a price to be fixed by the purchasing Officer which shall be final a Il unused, undamaged and acceptable materials. bought out components and stores course of manufacture in the possession of the contract or at the time of such termination or such portion there of as the purchaser may deem fit accepting such material, bought ou t components and stores as the con tractor may with the concurrence of the purchaser elec t to retain.

# Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
