Their promotion is subject to the following conditions:-

1. That in the event of final decision in the disciplinary proceedings which are pending against his seniors they shall have no right on the post of Assistants/Accountant, if their seniors are found fit for promotion after the decision of disciplinary proceedings.
2. They will also not claim seniority above his seniors on the basis of their present promotion and they will be reverted- to the post of Clerk/Steno-typist without giving any notice, if any senior to them is/are found fit for promotion to the post of assistant later on in the event of decision in their seniority position made by the department/Court and their inter-se-seniority will not be disturbed.
3. If they forgo their promotion, they will not be reconsidered for atleast one year and the persons promoted during this period will rank senior to them and they will not be entitled for the ACP scale & ACP scale already sanctioned to them will be withdrawn from the date of refusal as per ACP rules of 7.1.1998 para No. 11.
