**These promotions are also on the following conditions:-**

1. That in the event of final decision in the disciplinary proceedings which are pending against their seniors they shall have no right on the post of MPHS(F), if their seniors are found fit for promotion after the decision of disciplinary proceedings.
2. They will also not claim seniority above their seniors on the basis of their present promotion and they will be reverted to the post of MPHWF without giving any notice, if any senior to them is/are found fit for promotion to the post of MPHS(F) later on in the event of decision in their seniority position made by the department/Court and their inter-se-seniority will not be disturbed.
3. That they will be on probation for a period of one year and if their work and conduct during the period of probation is not found satisfactory, they will be reverted on the post of MPHWF without giving any notice thereof.
4. That the above promotions are subject to the outcome of the decision of CWP No. 11073 of 2015 in the Hon'ble Punjab and Haryana High Court regarding 20% reservation of schedule caste employees.


