The sanction is issued with the concurrence of Finance Department conveyed vide their U.O.No. 136/2017-2FD-III/16606, dated 20.07.2018 subject to the following conditions:-

1. No additional Budget will be provided for this purpose.
2. The vacant posts of Medical Officers are converted/upgraded as Sr. Consultants and Consultants as Personal Measure and after attaining the age of 65 year/retirement, the converted/upgraded posts will revert back as Medical Officer.
3. Pay and Allowances and Terms & Conditions for re-employment will be as per Health Department Policy No. 118-2016/Ext. No. 25/18/2016-6HB I dated 26.11.2016 and subsequently corrigendum to notification dated 06.07.2017.
4. Department will ensure that the Pay Scales drawn by Doctors at the time of retirement as mentioned by then is correct.
5. The number of re-employed doctors must not exceed the sanctioned strength and they must be posted against vacancy.
