In terms of Haryana Government's Notification No. 25/18/2016-6HB-1 dated 01-09-2021 which has been adopted by ESI Health Care, Department vide letter No. 10/231/2016-5Lab, dated 30.09.2021 the following Doctors/Consultants/Re-employment Consultants shall stand retired from Government Service with effect from 30-09-2021 (A.N) with an opportunity for re-employment, without prejudice to the Vigilance Clearance Certificate pending against them and any claim of the State Government, which may arise against her hereafter the same would be recovered from retiral benefits made to them as "admissible under the rules." Further the retiral benefits are subject to any disciplinary action pending/likely to be initiated against them:-
