### (j) Liberalization of Punjab Medical Attendants Rules-1940 Enhancement of Powers for sanctioning of Medical Reimbursement.

(Copy of H.D. Hr. No. 2/871/08-1HBIII dt. 15.03.10)

I am directed to invite your attention towards State Government's letter No. 2/523/2007-1HBIII, dated 20.05.2008 vide which the delegation of powers in the matter of reimbursement of medical charges of Officers/Employees/Pensioners/Family Pensioners/Dependents were inter-alia revised to the following extent :

1. Head of Office Upto Rs. 15,000/-
2. Head of Department Upto Rs. 50,000/-
3. Administrative Department Full Power

Now after reconsideration, the Government have decided to enhance the powers to the following extent:

1. Head of Office Upto Rs. 50,000/-
2. Head of Department Upto Rs. 1,00,000/-
3. Administrative Department Full Powers as per Finance Department issued vide their U.O. No. 5/7/2005. 1B&C dated 9-5-2005, 3-5-2006 and 25-9-2006

The other conditions prescribed in the Government letter bearing No. 2/244/93-1HBIII, dated 22-12-94 will remain unchanged.
