Prima facie, it appears that the impugned termination order dated 30.06.2022 has been passed in a slipshod manner in complete short

shrift to the reply filed by the petitioner(s) to the show cause notice as to why their services be not dispensed with. On one hand, the petitioners were asked to give reply to the notice within a period of seven days i.e. upto 02.07.2022, on the other hand, the common termination order dated 30.06.2022, whereby, the petitioners were ordered to be relieved from service, was passed even prior to expiry of the time granted to the petitioners.

It appears that the decision to relieve the petitioners from service has been taken without considering the response of the petitioners to the show cause notice(s), resulting in the entire exercise to be a futility and perhaps a mere formality of eyewash to comply with the orders passed by this Court in *CWP-15672-2021*.

Notice of motion.

On advance service, learned State counsel appears and accepts notice on behalf of the respondent-State of Haryana and seeks time to file return.

Post it on 28.07.2022.

In the meanwhile, *status quo ante* qua services of the petitioners, one day prior to the passing of respective relieving order, shall be maintained, with liberty to the competent authority to pass a speaking order after duly considering the reply filed by the petitioners and in case, any adverse order is passed, the same shall not be implemented till the next date of hearing.
