- Appointment will be provisional subject to the conditions mentioned in Govt. letter No. 52/08/2022-3GS-III dated 23.06.2022 and letter no. 52/06/2018-2HR-III dated 05.02.2024.
- 2. That in case your certificate/document found fake/bogus, your candidature will be cancelled automatically without any notice/intimation.
- 3. You will be entitled to draw such allowances and other benefits as sanctioned by the Government from time to time.
- 4.
