1. The promotion of the above MPHWF to the post of MPHS (F) is subject to the content regarding integrity/any disciplinary action etc. in their awaited ACR.
2. That in the event of final decision in the disciplinary proceedings which are pending against their seniors they shall have no right on the post of MPHS(F), if their seniors are found fit for promotion after the decision of disciplinary proceedings.
3. They will also not claim seniority above their seniors on the basis of their present promotion and they will be reverted to the post of MPHWF without giving any notice, if any senior to them is/are found fit for promotion to the post of MPHS(F) later on in the event of decision in their seniority position made by the department/Court and their inter-se-seniority will not be disturbed.
4. They will be participate in next online transfer drive.
5. That they will be on probation for a period of one year and if their work and conduct during the period of probation is not found satisfactory, they will be reverted on the post of MPHWF without giving any notice thereof.
6. If there are found any clerical mistake in seniority /roaster point they will be reverted on the post of MPHWF without giving any notice thereof.
