- 4 That they will be on probation for a period of one year and if their work and conduct during the period of probation is not found satisfactory, they will be reverted on the post of Pharmacist without giving any notice thereof.
- 5 If there are found any clerical mistake in seniority /roaster point they will be reverted on the post of Pharmacist without giving any notice thereof
