The prospective bidders may also witness the occasion on the said date and time, if desired so.

A Bid Security of Rs.10,000/-[Rupees Ten Thousand Only] required to be furnished in the form of Demand Draft in favour of "Kendriya Vidyalaya Sangathan [HQ]" payable at New Delhi.

Bid Security of unsuccessful bidder will be returned to them at the earliest after expiry of the final bid validity and latest by on or before the 30th day after the award of the contract.

The successful bidder will require to furnish a Performance Security of Rs.50,000/-[Rupees Fifty Thousand Only] in the form of Demand Draft in favour of "Kendriya Vidyalaya Sangathan [HQ]" payable at New Delhi which should be valid for a period of sixty days beyond the date of completion of all contractual obligations of the supplier including warranty obligations. Bid Security will be refunded to the successful bidder on receipt of Performance Security.

The work is required to be completed within 15 days from the receipt of award letter. The designated Committee may be at liberty to decide the L1 firm after overall evaluation. In case of any dispute the decision of the Committee shall be final and binding to the bidders.
