MEMORANDUM


Subject: Promotion through Limited Departmental Examination from the post of TGT to PGT for the year 2019 to 2023 from Main Panel.

In continuation to this office memorandum dated 05.10.2023, the following TGT who has been selected through LDCE-2022 to the post of PGT(Physics) for the year 2022, as the panel for the year 2022(UR) Category of PGT(Physics) has been revised.

Accordingly, with the approval of the competent authority, the following TGT(Math) is hereby promoted through Limited Departmental Examination for the year 2019 to 2023 to the post of PGT in the Pay Matrix **Level 8 (7th CPC) corresponding grade pay of Rs. 4800 (6th CPC) Pay Band-2 of Rs. 9300-34800** from the date he/she assumes the charge of the post. He/she is posted to Kendriya Vidyalaya shown in column 7 against his name. If he is willing to join as PGT on account of this offer of promotion, he should give his acceptance by 18.07.2024 positively, and he should get relieved for joining the place of posting as PGT. If he fails to get relieved by 29.07.2024 and join the new place of posting, this offer of promotion will automatically be treated as withdrawn.
