Sub: Non-applicability of higher rate of TDS/TCS as per provisions of section 206AA/ 206CC of the Income-tax Act, 1961, in the event of death of deductee/collectee before linkage of PAN and Aadhaar- reg.

As per Circular no. 06 of 2024 dated 23.04.2024, the Board had provided a window of opportunity to the taxpayers upto 31.05.2024 for linkage of PAN and Aadhaar for the transactions entered into upto 31.03.2024 so as to avoid higher deduction/collection of tax under section 206AA/206CC of the Income-tax Act, as the case maybe.

- 2. Several grievances have been received from the taxpayers where they have cited instances of demise of the deductee/collectee during the said period (i.e, on or before 31.05.2024) before the option to link PAN and Aadhaar could have been exercised. In such cases, tax demands are standing against the deductor/collector as a result of failure to link PAN and Aadhaar of the deceased person.
- 3. In order to redress such grievances of the taxpayers, the Board, hereby specifies that in respect of cases where higher rate of TDS/TCS was attracted under section 206AA/206CC of the Act pertaining to the transactions entered into upto 31.03.2024 and in case of demise of the deductee/collectee on or before 31.05.2024 i.e. before the linkage of PAN and Aadhaar could have been done, there shall be no liability on the deductor/collector to deduct/collect the tax under section 206AA/206CC, as the case maybe. The deduction/collection as mandated in other provisions of Chapter XVII-B or Chapter XVII-BB of the Act, shall be applicable.

I am directed to say that in the recent past, it has been observed that a lot of grievances on service related matter are being lodged in Centralized Public Grievance Redress and Monitoring System (CPGRAMS). CPGRAMS is an online platform which enable citizens to lodge their grievances to the public authorities on any subject related to service delivery.

- 2. As per the mandate of CPGRAMS, following issues are not required to be taken up for redressal:
 - (a) RTI Matters
 - (b) Court related / Subjudice matters
 - (c) Religious matters
 - (d) Suggestions
 - (e) Grievances of Government employees concerning their service matters including disciplinary proceedings etc. unless the aggrieved employee has already exhausted the prescribed channels keeping in view the DoPT OM No. 11013/08/2013-Estt.(A-III) dated 31.08.2015.
- 3. As per the spirit of CPGRAMS, a government employee who wishes to raise his service grievance is required to first to press a claim or to seek redressal of grievance by submitting an appropriate representation to immediate officer superior, or Head of his office, or such other authority at the appropriate level who is competent to deal with the matter.

4. In view of the above, all Circles are requested to sensitize all officials that instead of lodging grievance on CPGRAMS portal, to opt official channel and represent/raise service related issue to their immediate officer or to the officer designated to disposal of such grievance.

विषय: Policy for references of Court Cases to Department of Pension and Pensioners' Welfare - Instructions - reg.

The undersigned is directed to refer to this Department's OM No.38/70/14-P&PW(A) dated 07.10.2015 regarding consultation with this Department in all cases for implementation or otherwise of the court orders, where any policy issue relating to pension matters is involved.

- 2. The Department of Pension and Pensioners' Welfare, being nodal Department on pension matters, is impleaded along with the concerned administrative Ministries/Departments, either as main party or proforma party in almost all CAT/High Court/Supreme Court cases.
- 3. As per the instructions of DoPT vide OM No. 43011/9/2014-Estt.D dated 13.02.2015 and DO letter No. 1/50/3/2016-Cab dated 16th June 2016, the primary responsibility for defending the court case on behalf of the Government lies with the administrative Ministry/ Department concerned. If, however, any clarification is required on the interpretation or application of the rules or instructions relevant to the case, the concerned Ministry/ Department may consult the nodal Department, for that purpose a unified stand should be taken before the court of law and a common counter reply should be filed on behalf of the Government by the concerned administrative Ministry/ Department. In no case should the litigation be allowed to prolong to the extent that it results in contempt proceedings.
- 4. Under the extant policy, this Department is receiving Inter- Ministerial references in matters where SLP cases are to be filed. However, it has been observed that admission for filing SLP in concurrent judgments of Hon'ble CATs and High Courts have been minimal, as issues of facts/policy have already been addressed. Therefore, there is a pressing need to improve the quality of presenting Govt policy/rules in pleadings before the High Courts for safeguarding the interest of the UOI before the Courts of Law.

- 5. Hence, it is decided that all matters where Ministries/Departments seek to approach High Courts in CCS (Pension) Rules/Policy related issues, be referred to Department of Pension and Pensioners' Welfare alongwith the views of the administrative Ministry/ Department in a timely manner and comments/opinion of this Department received, if any, may be incorporated in the submissions made before Hon'ble High Courts in the matters involving major pension policy issues.
- 6. The administrative Ministry/Department while referring the proposal should invariably indicate all facts pertaining to the case in a Self Contained Note. The note should also include the relief sought by the petitioner/applicant, earlier advice/opinion of DoPPW, submission made by the Department before the Court/CAT, opinion of the Government Counsel on the judgment, opinion of D/o Legal Affairs and D/o Expenditure/DoPT, if any. All the references should be made to this Department alongwith views in the matter and with the approval of the Secretary of the Administrative Ministry/Department well in advance.
- 7. The above instructions may be brought to the notice of all concerned for strict compliance. These instructions are issued in consultation with Department of Expenditure.

mendment to Central Civil Services (Pension) Rules, 2021

G.S.R. 452 (E) - In exercise of the powers conferred by the proviso to Article 309 and Clause(5) of Article 148 of the Constitution and after consultation with the Controller and Auditor-General of India in relation to persons serving in the Indian Audit and Accounts Department, the President hereby makes the following rules further to amend the Central Civil Services (Pension) Rules, 2021, namely:-

 Short titles and commencement - (1) These rules may be called the Central Civil Services (Pension) Amendment Rules, 2024.

(2)"They shall come into force on the date of their publication in the Official Gazette.

- 2. In the Central Civil Services(Pension) Rules,2021, in Rule 50,in sub-rule(8), after Clause(j), the following clauses shall be inserted namely,
- "(ja) Where, a female Government servant or female pensioner has filed a case against her husband for divorce or under the Protection of Women from Domestic Violence Act,2005(43 of 2005) or the Dowry Prohibition Act, 1961 (28 of 1961) or the Indian Penal Code (45 of 1860) and such proceedings are pending in a competent court of law, the said female Government servant or female pensioner may make a request in writing to the concerned Head of Office to the effect that, in the event of her death during the pendency of any of the aforesaid proceedings, the family pension may be granted to her eligible child or children the precedence over her spouse;
- (jb) Where the female Government servant or female pensioner who had made a request under Clause (ja) dies during the pendency of any of the proceedings mentioned therein, the family pension shall be disbursed in the following manner, namely:
 - i) Where the deceased female Government servant or female pensioner is survived by a widower and no child is eligible for family pension on the date of death of the female Government servant or female pensioner, family pension shall be payable to the widower;
 - where the deceased female Government servant or female pensioner leaves behind a widower with a minor child or a child or children suffering from disorder or disability of mind including the mentally retarded, the family pension in respect of the deceased shall be payable to the widower, provided he is the guardian of such child or children and if the widower ceases to be the guardian of such child or children, such family pension shall be payable to the child through the person who is the actual guardian of such child or children;

Provided that where the minor child, after attaining the age of majority, remains eligible for family pension, the family pension shall become payable to such child from the date on which he attains the age of majority;

- where the deceased female Government servant or female pensioner is survived by a widower with a child or more than one child who has attained the age of majority and is eligible for family pension, the family pension shall be payable to such child or children;
- iv) Where any child referred to in Clause(ii) or Clause(iii) ceases to be eligible for family pension under this rule, the family pension shall become payable to the other child who is eligible for family pension;
- After all children cease to be eligible for family pension under this rule, the family pension shall become payable to the widower till his death or remarriage, whichever is earlier,
