OFFICE ORDER

The Ministry of Education, Govt. of India vide letter 7-14/2022-UT-2 dated 20.12.2024 has conveyed the approval of Government of India for setting up of 85 new Kendriya Vidyalayas under Civil/Defence Sector all over the country and expansion of 1 existing KV i.e. KV Shivamogga, District Shivamogga, Karnataka by adding 2 additional Sections in all the classes.

The existing school building of KV Shivamogga is constructed for running classes up to 02 sections and therefore, not sufficient to meet the requirement of expansion of additional sections. The Sponsoring Authority is therefore, requested to provide a safe and suitable rent free temporary accommodation as per KVS norms nearby to the existing KV for accommodating additional sections besides completing other requirements (electricity, potable water etc.) till the construction of additional sections in all classes in the existing permanent school building of KV Shivamogga.
