Implementation, Uploading, and Tracking related questions:

S1. No.	Question	Answer
1.	From which date will the implementation of 50 hours of CPD every year suffice to replace the 21-day in-service training every six years?	The notification for restructuring of the 21-day in-service course to implement 50-hours of CPD was issued vide letter no. 11-ACTR0Ltr/11/2023-AC(TRG)/1530-59, dated 03.12.2024. It is effective from this date only.
2.	Where will the teachers record their 50 hours of CPD?	Teachers must upload the certificates of the courses done by them on the KVS Samagam portal (app.kvs.gov.in
3.	Can the offline courses be replaced with the online courses?	It is mandatory to complete 50 hours of CPD, out of which at least 30 hours of offline/ face-to-face courses in a year. The remaining 20 hours may be completed in offline or online manner. However, one cannot complete all 50 hours of CPD in the online mode, but one can complete all 50 hours in the offline mode.
4.	I have done 1st spell of in-service course in June, 2024 for 12 days. How many hours to complete Online CPD to upload on Samagam portal.	Yes, 12-day ISC will be counted as 12x6=72 hours of CPD.
5.	If a teacher completes more than 50 hours in a year, will the extra hours carry over to the next year?	No, CPD hours completed in one year will not be carried forward.
6.	Will the induction course be included in CPD?	Yes
7.	I have done induction course for 10 days. How many hours will that count?	For the offline phase of the induction course, 6 hours will be counted for each day. For the online phase, the number of hours given in the schedule will be counted.
8.	CPD 50 hours to be counted for the Academic session i.e. 1st April to 31st March or from 1st January to 31st December.	CPD hours uploaded on the Samagam portal will be as per the calendar year.
9.	I wish to know if I can upload the certificates of the courses done in Feb/Mar 2024 or not.	CPD certification will be done as per the calendar year. So, the courses done in Feb/Mar 2024 will be included in 2024.
10.	There is no provision of decimal values like 1.5 hours as suggested in CPD guidelines for workshops	The Samagam portal has been updated and half hour courses can be added.

11.	How to upload certificate in SAMAGAM PORTAL?	Step-by-step guidelines are given in letter no. 11-ACTR0Ltr/11/2023-AC(TRG)/1775-1804, dated 03.01.2025
12.	Can we upload relieving certificate/ attendance given by venue instead of certificates in Samagam portal?	Relieving orders and attendance certificates cannot be uploaded. The principal will issue a certificate for uploading on basis of the relieving order/ attendance certificate.
13.	How can a teacher's course be unverified again after verifying it from school login?	After verification by the Principal, the portal is locked for further editing. Hence, verification should be done with utmost care. However, if any error still persists, the editing can be done at the RO level.
14.	How will I get CPD completion certificate?	CPD completion certificate will be generated on KVS Samagam portal once the principal verifies 50 hours of CPD done by the teacher.
15.	If a course on Swayam portal is completed in December 2024 and the certificate is issued in 2025, in which year will the course be included?	2024
16.	I have completed 80 hours of CPD courses which have 20 hours online and 60 hours offline. So I have completed 30 more hours in year 2024. Will these 30 extra hours applicable for 2025?	No, hours more than 50 hours of CPD courses cannot be carried forward.
17.	Will the certificates obtained in January 2025 (from online courses with a January 2025 date) be valid for uploading on the Samagam Portal by January 31, 2025?	Case 1: The course completed in December 2024 and the certificate is issued in January 2024- It should be uploaded for the year 2024. Case 2: The course is completed in January 2025 and the certificate is issued in January 2025- It should be uploaded for the year 2025.
18.	Do the teachers having more than 30 years of experience have to complete 50 hours of CPD?	Yes, 50 hours of CPD every year is mandatory for every teacher, irrespective of their length of service/experience.
19.	What is last date to complete CPD for a year?	31 December of every calendar year
20.	How will the tracking of CPD done on teachers' transfer?	Teachers should update their CPD on the Samagam portal as soon as a course is completed and request the Principal to verify it. All the certificates uploaded on the Samagam portal will be transferred to the new school of the teacher through PIMS.

23.	Who will be responsible if the teacher is unable to complete 30 hours of off-line training in a year?	The teacher has to take initiative and inform the Principal for getting his/her offline courses completed at school/ cluster/ RO/ ZIET/KVS HQ level by including the activities mentioned in the latest CPD guidelines.
24.	Since the deadline for uploading the certificates for 2024 has been extended to 31st January 2025, can teachers include the online courses completed in January 2025 as part of the 50 hours of CPD for 2024?	No, the online courses of 2025 will be considered for the calendar year 2025 only.
25.	I am (OH)disabled teacher ,can i do 50 hours online CPD COURSE as offline courses are not fully available for me?	KVS provides an inclusive atmosphere in all offline courses which are done at HQ/ ZIET/ RO/ Cluster/school level.

68.	Are various assignments given by ZIETs and ROs a part of CPD?	The ZIET Director/ Deputy Commissioner of the regional office will decide whether the activity is suitable for CPD and issue a certificate accordingly.
