- 1. In response to the Ministry of Health and Family Welfare, Government of India, O.M. No. S. 11011/23/2099-CGHS D II/ Hospital Cell (Part-IX), dated the 14th February 2013, Directorate's Letter No. S. 11045/23/2013/CGHS D-II (HEC)/CGHS (P) (Pt.) dated the 15th July, 2013 and Directorates letter No: S. 11011/28/2017-CGHS (HEC) dated 16th May, 2017 for empanelment of Health Care Organizations under CGHS Trivandrum, M/s. BIOLAB ADVANCED DIAGNOSTIC CENTRE, Near Trade Union Centre, Payannur Po., Kannur: 670307 had applied for empanelment. Sub: Notification of Empanelment of Health Care Organization (HCO) under Continuous Empanelment Scheme.

With reference to the Ministry's Office Memorandums 1.No. S.11045/36/ 2012/CGHS EC dated 10.12.2014, 2.S.11035/36/2012- CGHS/ HEC dated 16.10.2015, 3.S.11045/36/2012-CGHS/HEC dated 26.12.2017 vide which the continuous Empanelment Scheme for private hospitals and Diagnostic Center/ eye care & Dental care center having under CGHS was revived with a view to empanel more such facilities for the CGHS beneficiaries. Accordingly after following due process, a list of private hospitals has/have been finalized as per the terms and conditions laid down:

- 1. The Hospital mentioned below is being empanelled for a period of one year provisionally from the date of issue of this office memorandum or till next new empanelment whichever is earlier subjected to signing of a Memorandum of Agreement (on Rs. 500/- non-judicial stamp paper), submission of Performance Bank Guarantee (PBG).
- 2. This Office Memorandum is issued in pursuance of delegation of power for empanelment's of private hospitals vide O.M. No. S.11045/36/2012-CGHS (HEC) dt. 26.12.2017 of Deptt. Of Health & Family Welfare, Hospital Empanelment Cell, New Delhi.
- 3. It is highlighted that the Hospitals has been empanelled for all facilities/services available in the Hospital.
- 4. That Hospital shall not charge CGHS beneficiaries higher than the CGHS notified rates or the rates charged from other patients who are not CGHS beneficiaries. In the event of such overcharging, the excess amount will be recovered from the Performance Bank Guarantee of the Hospital along with the suitable administrative action.

Sub:- Settlement of Family Pension between two wives of a Government Servant or Pensioner under Central Civil Services (Pension) Rules, 2021 - reg.

The undersigned is directed to say that Department of Pension, in supersession of the Central Civil Services (Pension) Rules, 1972 has notified the Central Civil Services (Pension) Rules, 2021 and Rule 50 of the Central Civil Services (Pension) Rules, 2021 deals with payment of family pension on death of a Government servant/pensioner.

- 2. In accordance with Rule 50 (6) of the CCS (Pension) Rules, 202, the family pension shall be payable to the members of the family of the deceased Government servant or pensioners in the following order -
 - Subject to provisions of sub-rule (8), widow or widower, (including a post-retiral spouse and judicially separated wife or husband)
 - ii. subject to provisions of sub-rule (9), children (including adopted children, step children and children born after retirement of the pensioner),
 - subject to provisions of sub-rule (10), dependent parents (including adoptive parents) of the deceased Government servant or pensioner,
 - iv. subject to provisions of sub-rule (11), dependent siblings (i.e. brother or sister) of the deceased Government servant or pensioner, suffering from a mental or physical disability

Whereas the Explanation to Rule 50(6) (1) of the CCS (Pension) Rules, 2021 states that –For the purpose of this rule 'widow' and 'widower' shall mean a spouse, legally wedded to the deceased Government servant or the pensioners.

3. Whereas Rule 50(8)(c) of the CCS (Pension) Rules, 2021 states that-

Where the deceased Government servant or pensioner is survived by more widow than one, the family pension shall be paid to the widows in equal shares and on the death or ineligibility of a widow, her share of the family pension shall become payable to her child or children who fulfil the eligibility conditions mentioned in sub-rule (9).

- 4. In this regard, references have been received in this department regarding eligibility of family pension to the second wife when the first wife is alive. Having second wife when the first wife is alive is against the provisions of Hindu Marriage Act, 1955 and also contradictory to the provisions of CCS(Pension) Rules, 2021. The matter has been examined and it has been decided that such cases needs to be processed in accordance with the provisions of CCS (Pension) Rules, 2021 and the issue of second wife or second marriage being legal or otherwise, may be decided first in consultation with Department of Legal Affairs on case to case basis for deciding the eligibility for Family Pension.
- 5. All Ministries/Departments are requested to follow the process of consultation with Department of Legal Affairs before arriving at decision regarding Settlement of Family Pension between two wives under Central Civil Services (Pension) Rules, 2021. Such cases must be brought to the notice of the officer dealing with the pensioners' benefits in the respective Ministry/Department by the attached/subordinate offices.

विषय:Conditions for grant of additional pension to the retired Central Government Civil Employees covered under Central Civil Services (Pension) Rules, 2021– reg.

The undersigned is directed to say that as per the provisions of Sub Rule 6 of Rule 44 of CCS(Pension) Rules 2021 [erstwhile Rule 49(2-A) of CCS(Pension) Rules 1972], after completion of eighty years of age or above by a retired Government servant, in addition to a pension or a compassionate allowance admissible under the rules, additional pension or additional compassionate allowance shall be payable to the retired Government servant in the following manner:

Age of pensioner	Additional pension/additional compassionate			
From 80 years to less than 85 years	20% of basic pension/compassionate allowance			
From 85 years to less than 90 years	30% of basic pension/compassionate allowance			
From 90 years to less than 95 years	30% of basic pension/compassionate allowance			
From 95 years to less than 100 years	40% of basic pension/compassionate allowance			
100 years or more	50% of basic pension/compassionate allowance			
res years of more	100% of basic pension/compassionate allowance			

- 2. The additional pension or additional compassionate allowance shall be payable from first day of the calendar month in which it falls due. For example, a pensioner born on 20th August, 1942 shall be eligible for additional pension at the rate of twenty percent of the basic pension with effect from 1st August, 2022. A pensioner born on 1st August, 1942 shall also be eligible for additional pension at the rate of twenty percent of the basic pension with effect from 1st August, 2022.
- 3. All Ministries/Departments and Pension Disbursing Authorities/Banks are requested that the above provisions of Central Civil Services (Pension) Rules, 2021 may be brought to the notice of all concerned for compliance.

विषय: Revision of pension after authorisation under Central Civil Services (Pension) Rules 2021 - reg.

The undersigned is directed to say that as per Sub Rule 2 of Rule 66 of CCS(Pension) Rules 2021 [erstwhile Rule 70 of CCS(Pension) Rules 1972], subject to provisions of Rule 7 and 8 of CCS(Pension) Rules 2021, pension or family pension once authorised after final assessment or revised under Sub Rule 1 of Rule 66 of CCS(Pension) Rules 2021 shall not be revised to the disadvantage of the pensioner or family pensioner unless such revision becomes necessary on account of detection of a clerical error subsequently. In case the clerical error is detected after a period of two years from the date of authorisation or revision of pension or family pensioner, no revision of pension to the disadvantage of the pensioner or family pensioner shall be ordered without the concurrence of Department of Pension and Pensioners' Welfare.

- 2. Further, the question whether the revision has become necessary on account of a clerical error or not shall be decided by the administrative Ministry or Department. If, consequent on revision of pension or family pension under sub-rule 2, an excess payment of pension or family pension is found to have been made to the pensioner or family pensioner and if such excess payment is not on account of any misrepresentation of facts by the pensioner or family pensioner, the administrative Ministry or Department shall examine in consultation with the Department of Expenditure whether or not recovery of such excess payment can be waived off and issue appropriate orders in accordance with the relevant rules and instructions in this regard. Where the administrative Ministry or Department decides not to waive off the excess payment of pension or family pension, the retired Government servant concerned or family pensioner shall be served with a notice by the Head of Office requiring him to refund the excess payment of pension within a period of two months from the date of receipt of notice by him. In case the Government servant fails to comply with the notice, the Head of Office shall, by order in writing, direct that such excess payment shall be adjusted in instalments by short payments of pension in future, in one or more instalments, as the Head of Office may direct.
- 3. All Ministries/Departments are requested that the above provisions of Central Civil Services (Pension) Rules, 2021 may be brought to the notice of all concerned for compliance.

<u>Subject:- Reservation in promotion with Persons with Benchmark Disabilities- grant of notional promotion w.e.f. 30.6.2016- reg.</u>

The undersigned is directed to say that this Department, vide its OM of even number, dated <u>28.12.2023</u> (copy enclosed) had informed all the Ministries/Departments that in pursuance of the Hon'ble Supreme Court judgement in *Rajeev Kumar Gupta* Case, detailed instructions regarding grant of benefit of reservation in promotion to PwBDs upto the lowest rung of Group 'A' have been issued. Further, in pursuance of the Hon'ble Supreme Court Order dated 18.7.2023 in the Contempt Petition (Civil) No. 873/2023 titled *S.S.Sundram vs. Shri Vivek Johri & Anr*, this Department, vide OM dated 28.12.2023 extended the benefit of reservation in promotion on notional basis w.e.f. 30.6.2016 to all PwD employees who fulfill the eligibility condition as laid down in the DoPT O.M. dated <u>17.5.2022</u> (copy enclosed). The Ministries/ Departments are required to create supernumerary posts for extending the benefit of reservation in promotion to PwD employees on notional basis and to send such proposal to DoPT to enable this Department to seek concurrence of Department of Expenditure. However, proposal has not been received from any Ministry/ Department so far.

- 2. In this regard, it is reiterated that as per the above mentioned O.M. dated 28.12.2023, it is provided, "extending the benefit of reservation in promotion to the PwD employees on notional basis between 30.6.2016 and actual assumption of the charge of the post may affect the inter-se-seniority of the officials in various grades. Due to this, there may be cases in which some officials may have to be placed in a select list/seniority list, subsequent to the year of their existing/present seniority list/select list. This may have a chain effect as it may result in revision in seniority lists in subsequent years in many cases which may cause administrative inconvenience. In order to avoid such situation, from the date on or after 30.6.2016, when they become eligible to get the benefit of reservation in promotion, till the availability of vacancy in which the promotion is to be made or till they vacate the post on their retirement, further promotion etc. whichever is earlier."
- 3. In view of the above, Ministries/ Departments, vide OM dated 28.12.2023, were requested for the following:
 - i. To undertake an exercise to ascertain the requirement of supernumerary posts required to be created in order to grant the benefit of reservation in promotion to PwD employees, who would have become eligible for such

benefit during the period from 30.6.2016 to 16.5.2022 but could not be given such benefit due to absence of instructions in the matter. The Ministries/ Departments were requested to submit the proposal for creation of supernumerary posts to DoPT for sending the same to Department of Expenditure for concurrence.

Ministries/ Department were informed and requested to send such proposal in II. respect of the entire Department/ Ministry and not to send the proposal in

It was also requested that a certificate to the effect that the proposal is iii. complete in all respects and the requirement of creation of supernumerary posts has been projected in respect of the entire Department may also be furnished along with the proposal. IV.

They were also requested that each proposal shall have the concurrence of the Liaison Officer for PwDs of the Department/ Ministry concerned and shall be forwarded with the approval of the Secretary of the Administrative

Department/ Ministry.

- As already mentioned in para 1 above, the above instructions have been issued in 4. pursuance of the Hon'ble Supreme Court directions. Hence, all Ministries/ Departments were required to take necessary action to ensure that the benefit of reservation in promotion is extended to the PwD employees from 30.6.2016 onwards as per their eligibility. However, proposal from Ministries/ Departments are awaited. Ministries/ Departments are requested to undertake the exercise regarding ascertaining the requirement of creation of supernumerary posts for the purpose of granting the notional benefit of reservation in promotion to PwD employees during the period from 30.6.2016 to 16.5.2022 in terms of DoPT O.M. dated 17.5.2022 and O.M. dated 28.12.2023 and submit the proposal to DoPT in the prescribed proforma (Annexure-I) at the earliest and latest by 31.12.2024. In case there is no such proposal from any Ministry/ Department, NIL information may be provided/ furnished.
