SUBJECT: Further Action on Approved Proposal for 3-Tier Exam for KVS Recruitment reg.

Madam,

With reference to the communication received from the Ministry of Education vide their letter dated 15.03.2025, I am pleased to inform you that the proposal for implementing a 3-tier examination structure for KVS recruitment has been approved by the Ministry. This approval marks a significant step towards streamlining the recruitment process for various posts in KVS. However, to proceed with the implementation, the following actions are proposed for your kind consideration and approval:

- 1. The approved proposal for the 3-tier examination structure, submitted on 10.02.2025, has been received back with the Ministry's comments and suggestions, which have been duly noted for incorporation.
- 2. It is proposed to initiate the process of selecting a suitable recruiting agency to conduct the 3-tier examination. A tendering process may be started to identify agencies with prior experience in handling large-scale recruitment exams for educational institutions.
- 3. A high-level process meeting may be convened at KVS (HQ) involving all Regional Deputy Commissioners and key stakeholders to finalize the examination schedule, modalities, and guidelines for the 3-tier structure.

- 4. To ensure transparency and efficiency, it is suggested that a dedicated task force be constituted under your guidance to oversee the entire recruitment process, from the examination phase to the final selection of candidates.
- 5. Additionally, a **preliminary budget estimate** for the recruitment process, including the cost of engaging the recruiting agency, conducting the exams, and other logistics, may be prepared and submitted for approval.
- 6. To keep all stakeholders informed, a circular may be issued to all KVS Regional Offices and schools, detailing the approved 3-tier examination structure and the tentative timeline for the recruitment process.

This issues with the approval of the competent authority. I kindly request your guidance and approval to proceed with the aforementioned actions at the earliest to ensure the timely implementation of the 3-tier examination structure for KVS recruitment.
