Kendriya Vidyalaya Sangathan vide office-order of even number dated 27.12.2024, conveyed the approval of Government of India, for establishing 85 new Kendriya Vidyalayas under Civil/Defence Sector with the stipulation that the sponsoring authority concerned is required to transfer the identified demarcated land and also to give possession of the temporary accommodation to KVS prior to opening of the new Kendriya Vidyalaya. **Kendriya Vidyalaya, Patnagarh, Distt. Bolangir, Odisha** in **Parliamentary Constituency Bolangir** is one of the 85 new Kendriya Vidyalayas sanctioned in December 2024.

Since the land proposed by the Sponsoring Authority for this Kendriya Vidyalaya has been accepted by the Kendriya Vidyalaya Sangathan and temporary accommodation has been found suitable, sanction is hereby conveyed to start a new Kendriya Vidyalaya under Civil Sector with immediate effect at the following location:-
