- They must communicate their unconditional acceptance positively by 16.01.2026 in their present place of posting as Staff Car Driver, Grade II & Grade-I and join the place of posting on promotion latest by 19.01.2026. If they do not accept their offer of promotion, the same will automatically be treated as withdrawn and they would be debarred from getting further promotion for **01** year with consequential benefits such as seniority etc. with effect from 20.01.2026 as per KVS (HQ) letter No.6-6/1999/KVS(HQ)RPS dated 04.09.2008.

3. They are required to have passed the trade test as per model RRs of SCDs, which is a required eligibility criterion for the grant of Grade-I Scale. The same shall be ascertained before the employee joins the duty.
4. They will be entitled for fixation of pay as per provision of FR 22, having the option to get their pay fixed from the date of promotion or from the date of increment. The option should be exercised within a month of promotion
5. The ACP/MACP, if any granted earlier to them in CTSA/KVS, the same shall be deemed to have withdrawn in the light of fact that only single scheme (either MACP or promotional Scales) will be applicable to Staff Car Drivers.
