6. The candidates recommended by Regional Office and short listed by KVS(HQ) will be interviewed online/offline at KVS(HQ), New Delhi in different stages as per decision of the competent authority subject to availability of suitable candidates for final selection.
7. All eligible candidates can apply for posting to KVs abroad. The Regional Office should instruct the employee to download prescribed forms from the website of regional office concern. The contents of this circular is also available on Regional Office website.
8. All the applications duly filled in **Annexure-I** received by the Principal of the Vidyalaya concerned should reach to the Dy. Commissioner, of the Regional Office concerned by dated **27-02-2026 along with checklist in Annexure-II duly filled** for screening and selection by the Regional Selection Committee.

9. The Regional Selection Committee shall select the names from each category of post as per the eligibility condition and selection criteria given above in **Point 2** above but not more than the allotted quota mentioned in **Point-4** of this letter for submission to the KVS(HQ), New Delhi by dated **10-03-2026**. 
