The Deputy Commissioners/Directors of all the Regional Offices/ZIETs are requested to observe, plan and execute the above three-month campaign (17th August 2026 to 16th November 2026) at Regional Offices, ZIETs, and all Kendriya Vidyalayas under their jurisdiction, as per the instructions given by the Central Vigilance Commission. **A monthly report ending 31st Aug, 30th Sep and 31st Oct be sent to Assistant Commissioner (Vig) through e-mail: acvigilancekvs@gmail.com.**

The final report in respect of the three-month campaign on the above focused areas from the ZIET/ Regional Office and all the Kendriya Vidyalayas under their jurisdiction may be compiled by each Regional Office concerned, and a consolidated report may be sent to this HQ through aforesaid email in the format prescribed by CVC in **Annexure A**, latest by **18.11.2026** positively for onward submission to the Commission in time.
