Instructions For filling up the Application Form for admission to B.Tech/B.Arch./B.Pharmacy/BHMCT/BFAD/BFA/BBA/BMS/BCA under NRI Quota

- Application under NRI quota can be made for admission to Govt. aided/ Selffinanced/ Private Institutions affiliated to Dr. APJ Abdul Kalam Technical University, Lucknow in all courses except MBA/MCA, as per AICTE norms from NRI Candidates.
- 2. Applications from the real brother/sister and son / daughter of NRI may also be considered, if the seats remain vacant after the admission of the NRI candidates.
- 3. Candidates seeking admission under this quota must have obtained 60% (55% for SC/ST) in qualifying subjects 10+2 level or equivalent examination. The subject combination required in the qualifying examination (intermediate examination of U.P. Board or 10+2 level examination or its equivalent) for admission to first year of different courses shall be as per Clause 3 of Information Brochure 2024 available online at https://uptac.admissions.nic.in/
- 4. The candidates seeking admission to the B.Arch course are required to be qualified in NATA-2024 conducted by Council of Architecture.
- 5. The last date for applying online https://uptac.admissions.nic.in/ is July 10, 2024 up to 05:00 PM.
- 6. Applications without declaration of 10+2 result or applications incomplete in any respect will not be considered.
- 7. The shortlisted candidates for counseling will be displayed on the website https://uptac.admissions.nic.in/ on July 14, 2024.
- 8. The date of counseling of the shortlisted candidates is July 19, 2024 at Dr A.P.J. Abdul Kalam Technical University Uttar Pradesh, Sector 11, Jankipuram Extension, Lucknow (U.P.)-226 031.
- The candidates are advised to see the notice showing candidates shortlisted for counseling on the website https://uptac.admissions.nic.in/ before reaching the counseling centre on scheduled date/time for counseling.
 The counseling letter will NOT be sent to the candidates separately.
- 10. At the time of counseling, the candidates have to submit three latest passport size color photographs and their original documents along with one set of photocopies of following:
 - a. SAT-II Score Card, if applicable
 - b. Marksheet of 10+2 or equivalent examination
 - c. High School (10th Std) Certificate

- d. Bank drafts of Rs 10,000/= as initial fee and Bank draft of Rs 1000/= as counseling fee in favor of Finance Officer, Dr A.P.J. Abdul Kalam Technical University Uttar Pradesh, Lucknow payable at Lucknow
- e. Proof of claimed category (NRI and relationship certificates) shall be as mentioned below:

NRI candidates who possess minimum requisite qualification may get direct admission on 5% seats of total intake in State Funded and Private Institutions of Uttar Pradesh in all courses except MBA/MCA/. However, the candidates seeking admission to the B.Arch course are required to be qualified in NATA-2024 conducted by Council of Architecture. The University shall fill the seats of NRI quota (5%) seats in the following manner:

- (i) NRI quota seats shall be filled from NRIs who
 - (a) have passed the qualifying examination with Physics, Chemistry and Mathematics from an Institution situated outside India, which is considered equivalent to (10+2) examination by the Association of Indian Universities.

OR

have passed High School Certificate Education (GCE) examination with Physics, Chemistry and Higher Mathematics (A) from London / Cambridge / Sri Lanka.

(b) have appeared in SAT II examination with Mathematics level II C, Physics and Chemistry.

The relative merit of such cases will be decided on their SAT-II score.

- (ii) The vacant seats in NRI quota, if any, shall be filled up by such son / daughter / real brother /real sister of NRIs, who have passed intermediate or (10+2) or equivalent examination; with physics, chemistry and mathematics in each of physics, chemistry and mathematics and securing minimum 60% marks (55% for SC/ST) in physics, chemistry and mathematics taken together, from an institution situated in India.
- (iii) The relative merit of candidates mentioned in (ii) will be decided based on the total marks obtained by them in physics, chemistry and mathematics. Such candidates need not appear in JEE (Main)-2024 or CUET-2024.
- (iv) All such candidates MUST submit an NRI certificate obtained from Indian Diplomatic Mission / Chancellery / High Commission

- under their seal at the time of counseling.
- (v) The candidate also MUST submit sufficient documents clarifying without ambiguity their true relationship with the sponsoring NRI to the satisfaction of the University.
- (vi) The candidates will be informed separately about the date of counseling and number of seats under this quota. Candidates are required to be present in person on the day of counseling with original documents / certificates, failing which they will lose their claim.
- 11. Important: NRI Candidates must submit the required NRI certificate, in original, obtained from Indian Diplomatic Mission / Chancellery / High Commission under their seal and relationship document at the time of counseling as per above clause 10, failing which, the candidature of such candidates shall be cancelled and such candidates will not be permitted to participate in the counseling process.
- 12. The candidate MUST also submit sufficient documents clarifying without ambiguity their true relationship with the sponsoring NRI to the satisfaction of the University.
- 13. Further information/ decision of the University regarding required Proof of being NRI / Proof of relationship of NRI with the candidate, if any, may be notified onthe website https://uptac.admissions.nic.in/
- 14. The candidates are advised to keep on visiting regularly the website https://uptac.admissions.nic.in/ and act accordingly. The notices placed on the website shall be treated as served to the candidates.
- 15. Candidates seeking admission in more than one course under NRI quota must fillseparate application forms for each course (B.Tech / B.Pharm/ B.Arch or (BHMCT/BFAD/BFA together)).
- 16. The latest orders issued by Govt. of U.P. up to the date of NRI counseling shall be applicable for admission in NRI quota.
