Dear Shri Dhamiji,

In terms of Article 280 of the Constitution, the President of India has constituted the Sixteenth Finance Commission (SFC), to make recommendation on distribution of the net proceeds of taxes between the Union and the States, principles governing grants-in-aid of the revenues of the States out of the Consolidated Fund of India and measures to augment the Consolidated Fund of States to supplement the resources of Local Bodies. The Commission is also mandated to review and recommend on the present arrangements on financing disaster management initiatives. The recommendations of the SFC will cover the period of five years from 1st April 2026 to 31st March, 2031. The Commission is required to give its report by 30th October 2025.

2. I would take this opportunity to seek your valuable views on the general approach that the Commission should adopt as well as on specific terms of reference, that is, distribution of net proceeds of central taxes between Union and States and inter-se distribution between States; principles that should govern grants-in-aid of the revenues of the States; the measures to supplement the resources of the Panchayats and Municipalities in the State; and present arrangements on financing disaster management initiatives. If you have thoughts on any other issue relevant to the work of the Finance Commission, I would urge you to share those too with us.

3. A letter has already gone from the Secretary of the Commission to your Chief Secretary to submit a set of data and views of the State Government. We have requested States to set up a Finance Commission Cell and nominate a Nodal Officer as we expect close and intense interaction with the State Government over next eighteen months. After we have received inputs and information from your side, we will seek your convenience and visit the State to interact with your team and other stakeholders in the State in person, but our officers will be regularly interacting with your Government on a regular basis.

4. We look forward to productive interaction and continuous dialogue between the Commission and your Government.
