भारताचे संविधान.

क्रमांक आरटीआर.२०१०/प्र. क्र.१४०/१०/वैसेवा-२.—भारताचे संविधान यांच्या अनुच्छेद ३०९ च्या परंतुकाढारे प्रदान करण्यात आलेल्या अधिकाराचा वापर करून आणि याबाबतीत करण्यात आलेले सर्व विद्यमान नियम किंवा काढण्यात आलेले आदेश आणि संलेख यांचे अधिक्रमण करून, महाराष्ट्राचे राज्यपाल, याद्वारे, महाराष्ट्र शासनाच्या वैद्यकीय शिक्षण व ओषधिद्रव्ये विभागाच्या अधिपत्याखालील वैद्यकीय शिक्षण व संशोधन संचालनालयातील महाराष्ट्र वैद्यकीय शिक्षण व संशोधन सेवेतील सहयोगी प्राध्यापक, “गट अ” च्या विविध पदांवरील सेवाप्रवेशाचे विनियमन करणारे पूर्णील नियम करीत आहेत :—

१. या नियमांना, महाराष्ट्र वैद्यकीय शिक्षण व संशोधन सेवेतील सहयोगी प्राध्यापक, गट-अ (सेवाप्रवेश) नियम, २०१४ असे म्हणावे ;
२. या नियमांमध्ये, संदर्भानुसार दुसरा अर्थ अपेक्षित नसेल तर,—
 - (क) “सहयोगी प्राध्यापक” याचा अर्थ, अनुसूचीमध्ये नमूद केलेल्या कोणत्याही विषयातील, वैद्यकीय शिक्षण व संशोधन संचालनालय, महाराष्ट्र राज्य याच्या अधीन असलेल्या वैद्यकीय महाविद्यालयामधील सहयोगी प्राध्यापक, असा आहे ;
 - (ख) “केंद्रीय अधिनियम” यांचा अर्थ भारतीय आर्योदयाचा अधिनियम, १९५६ (१९५६ चा १०२) असा आहे ;
 - (ग) “आयोग” याचा अर्थ, महाराष्ट्र लोकसेवा आयोग, असा आहे ;
 - (घ) “पदवी” किंवा “विद्यावाचस्पती” यांचा अर्थ, संविधिक विद्यापीठाची पदवी किंवा विद्यावाचस्पती, असा आहे ;
 - (इ) “राष्ट्रीय मंडळाचा” विद्यानिपुण (डीएनबी) यांचा अर्थ, राष्ट्रीय परीक्षा मंडळाने दिलेली पदवी, असा आहे ;
 - (फ) “शासन” याचा अर्थ, महाराष्ट्र शासन, असा आहे ;
 - (ह) “अनुसूची” याचा अर्थ, या नियमांना जोडलेली अनुसूची, असा आहे.

३. सहयोगी प्राध्यापक या पदावरील नियुक्ती एकतर,—

(क) शासकीय वैद्यकीय महाविद्यालयात संबंधित विषयामधील सहायक प्राध्यापक किंवा अधिव्याख्याता हे पद धारण करण्याच्या तसेच अनुसूचीमध्ये नमूद केलेली अर्हता व अनुभव धारण करणाऱ्या आणि खाली नमूद केल्याप्रमाणे किमान नियमित सेवा पूर्ण करणाऱ्या योग्य व्यक्तींच्या जेष्ठता अधीन पात्रता निकावर पदोन्नतीने,—

(एक) अनुसूचीतील तक्ता क्र. १ विशेष महत्त्वाच्या विषयातील पदांवर, त्या विषयांतील एम डी किंवा एम एस शैक्षणिक अर्हता धारकांसाठी ४ (चार) वर्षांहून कमी नसेल इतकी नियमित सेवा आणि डीएनबी शैक्षणिक अर्हताधारक उमेदवारांसाठी पाच वर्षांहून कमी नसेल इतकी नियमित सेवा.

(दोन) अनुसूचीतील तक्ता क्र. २ मध्ये नमूद केलेल्या अंतिविशेषोपचार विषयातील पदांवर, त्या विषयांतील डीएम किंवा एमएस शैक्षणिक अर्हताधारकांसाठी २ (दोन) वर्षांहून कमी नसेल आणि डीएनबी शैक्षणिक अर्हताधारक उमेदवारांसाठी तीन वर्षांहून कमी नसेल इतकी नियमित सेवा.

स्पष्टीकरण.—या खंडाच्या प्रयोजनासाठी “नियमित सेवा” याचा अर्थ, महाराष्ट्र लोकसेवा आयोगाने केलेल्या शिफारशीवरून सहायक प्राध्यापक किंवा अधिव्याख्याता या संवर्गात केलेल्या नियुक्तीच्या दिनांकापासून केलेली किंवा सहायक प्राध्यापक किंवा अधिव्याख्याता या पदावर शासनाने नियमित केल्याच्या दिनांकापासून केलेली अखंड सेवा, असा आहे;

किंवा

(ख) खालील उमेदवारांमधून नामनिर्देशनाद्वारे,—

(एक) ज्यांचे वय पंचेचाळीस वर्षांहून अधिक नाही :

परंतु, शासनाच्या सेवेत अगोदरच कार्यरत असलेल्या उमेदवारांच्या बाबतीत, कमाल वयोमर्यादा दहा वर्षांपर्यंत शिथिल करण्यात येईल, आणि

(दोन) ज्यांनी अनुसूचीमध्ये संबंधित पदासमोर नमूद केलेली किमान शैक्षणिक अर्हता किंवा भारतीय वैद्यकीय परिषदेने ज्यास समतूल्य म्हणून मान्यता दिलेली अशी अनुसूचीमध्ये संबंधित पदासमोर नमूद केलेली अर्हताधारण केली आहे :

परंतु, पदोन्नतीद्वारे किंवा नामनिर्देशनाद्वारे नियुक्ती करण्यासाठी आवश्यक वैद्यकीय अर्हताधारक उपलब्ध झाले नाहीत तर अनुसूचीमध्ये नमूद केल्यानुसार अवैद्यकीय विद्यावाचस्पती अर्हताधारण करणाऱ्या व्यक्तींची **शरीररचनाशास्त्र, शरीरक्रियाशास्त्र, औषधशास्त्र, सुक्षमजीवशास्त्र व जीवरसायनशास्त्र** या विषयांतील सहयोगी प्राध्यापक या पदावर आयोगाने केलेल्या नामनिर्देशनानुसार शासनास नियुक्ती करता येईल. परंतु शरीररचनाशास्त्र, शरीरक्रियाशास्त्र, औषधशास्त्र आणि सुक्षमजीवशास्त्र या विषयांच्या बाबतीत असे पद धारण करणाऱ्या व्यक्तींची संख्या सहयोगी प्राध्यापकांच्या एकूण विद्यमान पदसंख्यांच्या तीस टक्क्यांहून अधिक आणि जीवरसायनशास्त्र या विषयाच्या बाबतीत सहयोगी प्राध्यापकांच्या एकूण विद्यमान पदसंख्येच्या पत्रास टक्क्यांहून अधिक असणार नाही.

स्पष्टीकरण.—(क) अनुसूचीमध्ये नमूद केलेली अर्हता ही केंद्रिय अधिनियमाच्या अनुसूचीमध्ये नमूद केलेली अर्हता असेल.

(ख) अनुसूचीमध्ये नमूद केलेली पदव्युत्तर अर्हता व अनुभव विषयातील अशा भारतीय आर्युविज्ञान परिषदेने वेळोवेळी पदव्युत्तर अर्हतेस दिलेल्या मान्यतेनुसार किंवा यथास्थितीनुसार सुधारित झाल्याचे मान्यतेस येईल.

४. सहयोगी प्राध्यापक पदावर नामनिर्देशनाने नियुक्त केलेली व्यक्ती दोन वर्षांच्या कालावधीसाठी परिवीक्षाधीन असेल. परिवीक्षा कालावधी जास्तीत जास्त एका वर्षांपर्यंत वाढविता येईल. या पदावर नियुक्त केलेल्या व्यक्तीने परिवीक्षा कालावधी यशस्वीरीत्या पूर्ण करणे आवश्यक असेल. त्या व्यक्तीने परिवीक्षा कालावधी यशस्वीरीत्या पूर्ण न केल्यास किंवा ती व्यक्ती पदासाठी योग्य नसल्याचे आढळून आल्यास ती व्यक्ती सेवा समाप्त केली जाण्यास पात्र असेल.

५. सहयोगी प्राध्यापक पदावर नियुक्त केलेल्या व्यक्ती, हिंदी आणि मराठी भाषा उत्तीर्ण त्याबाबतीत करण्यात आलेल्या नियमानुसार झाली नसेल, किंवा उत्तीर्ण होण्यापासून तिला सूट मिळालेली नसेल तर सदर परीक्षा उत्तीर्ण करणे आवश्यक असेल.

६. सहयोगी प्राध्यापक पदावर नियुक्त केलेल्या व्यक्तीने, महाराष्ट्र शासनाच्या महिती व तंत्रज्ञान संचालनालयाने वेळोवेळी विहित केलेले “संगणक हाताळणीबाबतचे प्रमाणपत्र” धारण करणे आवश्यक असेल.

७. सहयोगी प्राध्यापक पदावर नियुक्त केलेल्या व्यक्तीने महाराष्ट्र वैद्यकीय परिषद अधिनियम, १९६५ (१९६५ चा महा. ४६) अन्वये महाराष्ट्र वैद्यकीय परिषदेकडे स्वतःची नोंदणी करून घेणे आवश्यक असेल किंवा ती व्यक्ती कामावर रुजू होण्यापूर्वी त्या व्यक्तींचे नाव भारतीय वैद्यक परिषद अधिनियम, १९५६ (१९५६ चा केंद्रिय अधिनियम २) अन्वये, भारतीय वैद्यक नोंदवहीवर नोंदलेले असणे आवश्यक असेल :

परंतु, नियम ३ च्या परंतुकानुसार नियुक्त केलेल्या अवैद्यकीय अर्हताधारण करणाऱ्या उमेदवारास वरीलप्रमाणे नोंदणी करण्याची आवश्यकता असणार नाही.

८. सहयोगी प्राध्यापक पदावर पदोन्नती आणि नामनिर्देशनाने केलेल्या नियुक्तीचे प्रमाण अनुक्रमे ५०:५० असे असेल.

परंतु शासनाच्या मते, सेवेची निकड विचारात घेऊन शासनास, आयोगाशी विचार विनियम करून जेव्हा आवश्यक असेल तेहा, सहयोगी प्राध्यापक पदावर नामनिर्देशन व पदोन्नतीसाठी विहित केलेले प्रमाण शिथिल करून नियुक्ती करता येईल.

९. सहयोगी प्राध्यापक पदावर नियुक्त केलेली व्यक्ती, भारत सरकारने तरो आवश्यक केल्यास भारताच्या संरक्षण सेवामध्ये किंवा भारताच्या संरक्षण सेवाशी संबंधित कोणत्याही पदावर, भारतात किंवा भारताबाहेर कुठेसी चार वर्षांहून कमी नसेल इतक्या कालावधीसाठी, प्रशिक्षणावर व्यतित केलेल्या कालावधीसह, भारत सरकार, वेळोवेळी ठरवील अशा शर्तीवर, सेवा करण्यासाठी पात्र असेल :

परंतु अशा व्यक्तीला, तिची नियुक्ती झाल्याच्या दिनांकापासून दहा वर्षांचा कालावधी समात झाल्यानंतर किंवा सर्वसाधारणपणे त्याने वयाची

५५ वर्ष पूर्ण केल्यानंतर, यापैकी जे आगोदर घडेल, त्यानंतर वरीलप्रमाणे सेवा करण्याची आवश्यकता असणार नाही.

१०. सहयोगी प्राध्यापक पदावर नियुक्त केलेली व्यक्ती महाराष्ट्र राज्यात कुठेही बदली होण्यास पात्र असेल.

NOTIFICATION

CONSTITUTION OF INDIA.

No. RTR.2010/CR-140/MS-2.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and in supersession of all existing rules, orders and instruments made or issued in this behalf, the Governor of Maharashtra is hereby pleased to make the following rules regulating recruitment to the various post of Associate Professor, Group 'A', the Maharashtra Medical Education and Research Service, in the Directorate of Medical Education and Research under the Medical Education and Drugs Department of the Government of Maharashtra, namely :—

1. These rules may be called the Associate Professor in Maharashtra Medical Education and Research Service, Group 'A' (Recruitment) Rules, 2014.

2. In these rules, unless the context requires otherwise :—

(a) "Associate Professor" means the Associate Professor in Medical Colleges under the Directorate of Medical Education and Research, Maharashtra State, in any of the subject mentioned in the Schedule ;

(b) "Central Act" means the Indian Medical Council Act, 1956 (CII of 1956) ;

(c) "Commission" means the Maharashtra Public Service Commission ;

(d) "Degree" or "Doctorate" means "Degree" or "Doctorate" of a statutory University ;

(e) "Diplomate of National Board" means the Degree awarded by the National Board of Examination ;

(f) "Government" means the Government of Maharashtra ;

(g) "Schedule" means the Schedule appended to these rules.

3. Appointment to the post of Associate Professor shall be made either, —

(a) By promotion of a suitable person on the basis of seniority subject to fitness from amongst the persons holding the post of Assistant Professor or Lecturer in respective subjects in Government Medical Colleges, possessing qualification mentioned in the Schedule and having minimum regular service as under :—

(i) In case of Doctor of Medicine (M.D.) or Master of Surgery (M.S.) in Board Specialities subjects mentioned in the Table-1 of Schedule, qualified candidates shall have regular service of not less than four years; and for Diplomate of National Board, qualified candidates shall have regular service of not less than five years.

(ii) In case of Doctor of Medicine or Master of Chirurgie in Super Specialities subjects mentioned in the Table-2 of Schedule, qualified candidates shall have regular service of not less than two years; and for Diplomate of National Board, qualified candidates shall have regular service of not less than three years.

Explanation.— For the purpose of this clause the term "regular service" means continuous service in the cadre of Lecturer or Assistant Professor from the date of appointment on recommendation through the Commission or from the date of regularization by the Government on the post of Lecturer or Assistant Professor, or

(b) by nomination from amongst the candidates who,—

(i) are not more than forty five years of age :

Provided that, the upper age limit may be relaxed by ten years in case of candidates already serving in the Government; and

(ii) possess the minimum educational qualifications mentioned against concerned post in the Schedule or qualifications recognized by the Indian Medical Council as equivalent thereto, and experience mentioned against the concerned post in the Schedule :

Provided that, if candidates with requisite medical qualification are not available for appointment, either by promotion or by nomination, appointment of persons possessing non-medical Doctorate qualification, as mentioned in the schedule, to the post of Associate Professor in **Anatomy, Physiology, Pharmacology, Micro-biology and Bio-chemistry** shall be made by the Government on the nomination by the Commission to the extent that the total number of posts of Associate Professors in such a subject held by such persons shall not exceed thirty per cent. of the total number of existing post of Associate Professors in case of Anatomy, Physiology, Pharmacology and Micro-biology and fifty per cent. of the total number of existing posts of Associate Professors in case of Bio-chemistry.

Explanation.—

(a) The qualifications mentioned in the Schedule shall be the qualifications mentioned in the Schedule to the Central Act.

(b) A post-graduate qualification and experience mentioned in the Schedule shall stand amended in accordance with the recognition or de-recognition, as the case may be, of such post-graduate qualification and experience by the Medical Council of India, from time to time.

4. A person appointed to the post of the Associate Professor by nomination shall be on probation for a period of two years. Probation period may be extended maximum up to one year. A person appointed shall be required to complete the probation period successfully. If he does not complete the probation period successfully or is not found suitable for the post, he shall be liable for termination from the service.

5. A person appointed to the post of the Associate Professor shall be required to pass examinations in Marathi and Hindi languages, according to the rules made in that behalf, unless he has already passed or has been exempted from passing those examinations.

6. A person appointed to the post of the Associate Professor should possess a certificate in Computer Operation, prescribed by the Directorate of Information Technology, Government of Maharashtra, from time to time.

7. A person appointed to the post of the Associate Professor shall be required to get registered his name in the registered maintained under the Maharashtra Medical Council Act, 1965 (Mah.XLVI of 1965) or in the register maintained under the Indian Medical Council Act, 1956 (Central II of 1956), before joining the appointment, unless he has already been so registered and his name is borne on the Indian Medical Register :

Provided that, candidates possessing non-medical qualifications appointed under proviso of rule 3 need not be so registered.

8. Appointment to the post of the Associate Professor by promotion and nomination shall be made in the ratio of 50:50 respectively :

Provided that, if in the opinion of Government, exigencies of service so require, Government may, in consultation with the Commission, whenever necessary, make appointment to the post of Associate Professor in relaxation of the ratio prescribed for recruitment by promotion or nomination.

9. If required by the Government of India, a person appointed to the post of the Associate Professor shall, be liable to serve in any Defence Service of India or in a post connected with the Defence of India, anywhere in India or abroad for a period of not less than four years, including the period spent on training, if any, on such conditions as may be determined by the Government of India :

Provided that, such person shall not be required to serve as aforesaid, after the expiry of ten years from the date of his appointment, or on attaining the age of fifty five years whichever is earlier.

10. A person appointed to a post of the Associate Professor shall be liable for transfer anywhere in the State of Maharashtra.
