## OFFICE ORDER

By the Office Orders dt.5<sup>th</sup> December, 2013 & 31<sup>st</sup> January, 2014, the Hon'ble President, State Consumer Disputes Redressal Commission, Maharashtra, as per powers under Sec.16(1B)(ii) of Consumer Protection Act, 1986 have constituted the Benches at Aurangabad & Nagpur Circuit Benches respectively and thereby assigned the business for those constituted Benches.

By this order, with prior approval of Hon'ble President, the following standing instructions are issued :-

- 1) Division Bench of two Hon'ble Members be constituted and this Bench shall take all the matters on board of Division Bench and Single Member Bench;
- 2) If the Division Bench comprises of both the Non Judicial Members, then that Division Bench shall conduct the judicial proceedings subject to provisions of Regulation 12 of Consumer Protection Regulations, 2005. Further, the Senior-most Hon'ble Member shall preside over the Bench;
- 3) The Registrar Legal of Nagpur & Aurangabad Circuit Benches shall issue necessary notice time to time, as and when required and notify the same on the Notice Boards of the respective benches in advance. Further, the Registrars also be directed to send the copy of said Notice by e-mail to all the District Consumer Fora in the State and to this office for notifying the same on Notice Boards of their respective offices.
