

C I R C U L A R

Complainant/Appellant or the Revision Petitioner/Applicant as the case may be within the territorial jurisdiction of Kolhapur, Pune and Nashik Circuit Bench who prefer to lodge/institute the proceeding can even lodge the same before the State Commission, Maharashtra at its main Bench at Mumbai. The proceeding if filed shall be given appropriate number of lodging or registration by the Clerk accepting the same at Mumbai. If the proceeding is lodged or registered at Mumbai, it shall be preferably heard at Mumbai unless the parties choose otherwise. By consent of the parties, the proceeding will be heard at the Circuit Bench concerned. If the parties by consent choose to take the proceeding to the State Commission, Maharashtra at its main Bench at Mumbai for final hearing, the said proceeding may be taken up for hearing at the State Commission, Maharashtra at its main Bench in Mumbai provided that contesting parties are willing. Registrar (Legal) to forward this Circular to all the Circuit Benches and District Fora in the State of Maharashtra.
