**-: C I R C U L A R :-**

It is notified for the information of all concern that The Hon'ble President, State Consumer Disputes Redressal Commission Maharashtra Mumbai has given following directions regarding filing of Complaints, Appeal, Execution Applications and Misc. applications that,

- (i) As per the Consumer Protection (Consumer Commission Procedure) Regulations, 2020, Rule 9, it is directed that any defect in the filing of the complaint or appeal or revision petition, which are raised by the Registry of this Commission, such defects should be removed within fifteen days.
- (ii) After fifteen days these matter will be notified on daily board of Commission for passing appropriate order. If concern complainant/advocate failed to appear on that day the matter will be dismissed without further notice to concern party/parties.
- (iii) The rest of instructions regarding filling of cases i.e. Complaints, Appeals Execution Applications and Misc. Applications are remains same.

The above directions are applicable to State Commission Mumbai and its Benches in Maharashtra from the date of issuance of this circular.
