Supply Order

Sir,

This is to inform you that your offer for the bullet proofing work of Mercedes Benz E-350 has been accepted as per the terms and condition of the tender. You are requested to complete bullet proofing of Mercedes Benz E-350 vehicle to the specifications given in annexure-A of tender documents.

1. The total cost of the bullet proofing work is Rs. 47,00,000/- inclusive of all taxes and transportation charges for delivery at Maharashtra Sadan, Copernicus Marg, New Delhi.
2. The security deposit of 10% of the tendered amount i.e. Rs. 4,70,000/- for due performance of contract made by you should be deposited in the form of Term Deposit in the name of Resident Commissioner, Maharashtra Sadan, New Delhi and sign contract agreement on the terms and conditions mentioned in the tender within 7 days.
3. As per tender condition a team of officials from Maharashtra Police as deputed by Special I.G. (VIP Security) and MT Department of Director General of Police, Maharashtra, Mumbai will visit the factory site during the bullet proofing work and ensure that the bullet proofing work is carried out as per the specifications given in the tender document. In case of any discrepancies in the specifications or vehicle not having the requisite standard of bullet proofing will not be accepted. The entire cost of vehicle would be recovered from the supplier.
4. Supplier, M/s. Streit Armoring Pvt. Ltd. will be responsible for necessary certifications and clearances from various competent authorities complying with the specifications given in the tender document.
5. Supplier will also get the vehicle registered as bullet proof vehicle and registration will be done at Mumbai in the name of Resident Commissioner c/o General Administration Department (Protocol), Mantralaya, Mumbai.

6. Supplier will also responsible for shifting the vehicle from Mumbai to place of bullet proofing and after bullet proofing & registration delivering the vehicle at Maharashtra Sadan, Copernicus Marg, New Delhi. During the transportation / bullet proofing any damage to the vehicle the entire cost of the vehicle shall be recovered from the supplier.
7. Supplier will ensure that the bullet proofing work of the vehicle shall be of best quality (and workmanship) and shall be strictly in accordance with the specifications and particulars contained / mentioned in the tender documents and the supplier hereby guarantees that after bullet proofing work the vehicle continue to confirm to the description and quality of aforesaid for a period not less than three years or upto the period as mentioned in the specifications whichever is hired from the date of acceptance of the vehicle. During the warrantee period supplier shall be liable for correcting any defects as per the warrantee conditions. After bullet proofing by the supplier, in case of rejection of vehicle, entire cost of the vehicle shall be recovered from the supplier.
8. All conditions mentioned in the tender document shall be applicable on the supplier.
9. Bills must be prepared in duplicate and sent to the Resident Commissioner & Secretary, Maharashtra Sadan, New Delhi for payment.
10. Necessary Octroi Exemption Certificate will be issued by the office of the Resident Commissioner, Maharashtra Sadan, New Delhi.
11. Please quote in all letters, invoices, etc. the number and date of this Supply order.
12. This office must be kept informed of the progress of the delivery of vehicle etc. and intimation should be sent upon final completion of bullet proofing work.
13. Please acknowledge receipt of this supply order.
