The pandemic in year 2020 and 2021 was a challenge before the legal aid movement. The difficult period taught us relevance of assimilating technology with the cause of dispensation of Justice. INTRODUCTION

By the constitutional 42nd amendment, a new provision was incorporated in the Constitution under Article 39 A, for providing free Legal Aid and concept of equal justice found a place in our constitution, Article 39-A which was incorporated under part IV-Directive Principles of State Policy reads as under:-

"Equal justice and free legal aid - The State shall secure that the operation of the legal system promotes justice, on the basis of equal opportunity, and shall, in particular, provide free legal aid by suitable legislation or schemes or in any other way, to ensure that opportunities for securing justice are not denied to any citizen by reason of economic or other disabilities.

Access to justice simply means people's ingress to court for getting justice. The major steps to accessibility to justice are identification and recognition of grievance, awareness and legal advice or assistance, accessibility to court or claim for relief adjudication of grievance; enforcement of relief, of course this may be the paramount aim of a litigant. We being State legal Services Authority have attempted to best of endeavours to provide legal service to relieve them from suffering, and to prevent recurrence.

Imparting justice in a just and fair manner in order to ensure fair justice to each and every individual of the State.

MISSION /

To ensure that access to justice is available to all the needy. Deprived, oppressed sections of the society and that every individual of the State gets equal opportunity to represent himself in the temple of justice.

Capacity Building

Special programme on clinical legal education of Lawyers:-

A Special Clinical Legal Education programme was organized at Government J. Yoganandam Chhattisgarh Collage, on 02.04.22 Hon'ble Shri Justice Goutam Bhaduri, Executive Chairman, Chhattisgarh State Legal Services Authority, emphasized on relevance of Legal Education.





Orientation Program for Volunteer Advocates and Panel Lawyers:-

One Day Orientation Program for Volunteer Advocates of Chhattisgarh High Court Bar Association and Panel Lawyers of High Court Legal Services Committee on 07-05-2022. The participants were trained by Hon'ble Mr. Justice Gautam Bhaduri, Executive Chairman, Chhattisgarh State Legal Services Authority and other eminent dignitaries.





Internship :-

Chhattisgarh State Legal Services Authority has successfully organized an internship program for 1110 law students in the year 2022 from June 09, 2022 to June 29, 2022 for a total of 21 days. Internship programme was designed in a very diverse fashion, so as to include all the facets of legal Services. During the internship, law students were informed about legal service activities conducted by NALSA, SLSA and DLSAs and Chhattisgarh High Court Legal Services Committee Bilaspur. Special visits for law students were organized to High Court, District Court, Central Jail/Sub Jail, Child Reform Home/Juvenile Justice Board, Child Welfare Committee and Child Home, Old Age Home, Mental Hospital, Legal Awareness Camp, Mediation Center, Lok Adalat/ Permanent Lok Adalat, Management Office, Legal Literacy Club being run in the school, Legal Aid Clinic run in the college.

The meeting was held on 18-06-22, under the Section 16(2) of juvenile justice Act, in order to have a discussion about various aspects of juvenile justice like conditions of Juvenile homes, problems during trial of such cases. The meeting was organized with aim to provide common platform to all the concerned department in order to remove difficulties and to ensure better co-ordination.



Special Legal Awareness Programme for Senior Citizens, organised at Mahamaya Premises, Ratanpur

Under the aegis of Chhattisgarh Senior Citizens Confederation and Senior Citizens Association Ratanpur, the fourth regional conference was organized in Mahamaya courtyard, Ratanpur, for senior citizens. JAIL LOK ADALAT

First State Level Jail Lok Adalat organized in Chhattisgarh :-

In compliance of the order passed by Hon'ble Supreme Court in "Sonadhar vs State of Chhattisgarh appeal (criminal) number 529/2021" and under the direction of the Hon'ble Mr. Justice Goutam Bhaduri, Executive Chairman CGSLSA, the Jail Lok Adalat campaign was started in state of Chhattisgarh, in view of the increasing crowd in the jail, in order to facilitate release of the detained prisoners in the jail.

Jail Lok Adalat was inaugurated on October 15, 2022, with lightening of lamp by Hon'ble Executive Chairman, State Legal Services Authority, Mr. Justice Goutam Bhaduri, at the Central Jail, Raipur. It is noteworthy, that in total, 448 jailed prisoners were released. As per the order of the Hon'ble Chhattisgarh High Court, the Jail Adalat will be organized by the Magistrates in the Jail premises every week, on working day. Up to December 2022, 725 prisoners detained in Jail have been released and efforts are being made to extend its benefits to other competent jail inmates.

LEGAL SERVICE FORTNIGHT

In compliance of NALSA Scheme "Empowerment of Citizen through Legal Awareness and Outreach" and "Haq Hamara bhi to Hai@75", and under the guidance of Hon'ble Chief Justice/Patron-in-Chief Mr. Justice Arup Kumar Goswami and Hon'ble Executive Chairman Mr. Justice Goutam Bhaduri, Mega Legal Service Campaigned were organised in the state of Chhattisgarh from 31-10-22 to 13-11-2022.

Under the aforesaid campaign, efforts were made by the District Legal Services Authority to take various legal service activities to the common people living in remote areas through door-to-door visits, schools, colleges, social organizations etc. Cooperation of concerned departments of the government like Women and Child Development Department, Social Welfare Department, Labor Department etc., panel advocates, paralegal volunteers were also taken For the successful operation of the campaign.

Under the campaign, cycle rally, essay competition, rangoli competition, debate competition, painting competition etc. were successfully organized. Under the aforesaid campaign, a one-day "Mega Legal Service Camp" was also successfully organized in all district

Unprecedented success was achieved in the state of Chhattisgarh under the Legal Services Campaign. "Legal awareness" programs were conducted in 7670 villages and 2690 other areas in the entire state, in which a total of 542505 people participated. A total of 4876 villages and in 2882 other areas, "legal aid camps" were also organized in the campaign, in which 364839 people were benefited. Under the campaign, efforts were made to make the campaign successful by using Facebook, TV, Radio and other mediums of media.

Successful Organisation of First Quarterly Review Meeting:-

In the joint aegis of Chhattisgarh State Legal Services Authority, Chhattisgarh State Commission for protection of Child Rights and UNICEF, first quarterly review meeting cum workshop was organized on 06 November 2022 at Raipur. The workshop was aimed to bring Juvenile Justice Boards of the districts, the chairpersons of child welfare committees, the District Legal Services Authorities and the District Child Protection Unit of police on one platform.

The Chief guest of workshop was Hon'ble Mr. Justice Gautam Bhaduri, Judge of Chhattisgarh High Court and Executive Chairman of Chhattisgarh State Legal Services Authority. Addressing the workshop, Hon'ble Mr. Justice Shri Bhaduri appreciated the efforts of Chhattisgarh State Legal Services Authority and Chhattisgarh State Commission for protection of Child Right for bringing together all the concerned organizations and units, and gave valuable insights over pertinent issues like relevance of moral stories, side

effects of mobiles in shaping childhood and need for framing new laws to curb child related crimes. The event was also graced by Mrs. Tejkunwar Netam, Chairman of Chhattisgarh State Child Protection Commission Dr. Sanjeev Shukla, IG Police, Mr. Job Zachariah, State Chief, UNICEF, Mr. Poshan Chandrakar, Special Secretary Nutrition of Women and Child Development Department, Mr. Anand Prakash Wariyal, Member Secretary, CGSLSA & Mrs. Kamini Jaiswal, Under Secretary CGSLSA.



One day State level workshop on POCSO Act was organized on 8th November 2022 at Chhattisgarh High Court, Bilaspur.



The above workshop was inaugurated by Hon'ble Justice Shri Arup Kumar Goswami, Chief Justice, Chhattisgarh High Court, Hon'ble Justice Shri Goutam Bhaduri, Judge Chhattisgarh High Court and Executive Chairman, State Legal Services Authority and other eminent dignitaries by lighting the lamp.

Hon'ble the Chief Justice Shri Arup Kumar Goswami addressing the program said that today we are reviewing the Protection of Children from Sexual Offenses Act, which was enacted in 2012, we have to consider the challenges and short comings in its, true implementation, Hon'ble directed all the stakeholders to play their role seriously, for the benefit of the children.

In his address Hon'ble Justice Shri Goutam Bhaduri, Judge, Chhattisgarh High Court and Executive Chairman, State Legal Services Authority said that the society has to come out of such mentality that only small girls are unsafe in the country, but according to the figures small boys are also at risk. It is also worth mentioning here that men are considered to be the culprits for these crimes, while sometimes women also have equal participation in it. Hon'ble Lordship also said in his address that only women doctors have been authorized for health examination in the Act, the same must be taken seriously.





Keynote address was given by Hon'ble Justice Shri Sanjay K. Agrawal, Judge Chhattisgarh High Court and Chairman, Chhattisgarh State Judicial Academy. Introductory speech and welcome speech by Hon'ble Justice Shri P. Sam Koshy, Judge Chhattisgarh High Court and Chairman Juvenile Justice Committee, in connection with the program, The vote of thanks of inaugural session was done by Hon'ble Justice Shri Deepak Kumar Tiwari, Judge Chhattisgarh High Court and Member Juvenile Justice Committee.

Hon'ble Shri Justice P. Sam Koshy, Judge of Chhattisgarh High Court and Chairman, Juvenile Justice Committee, said that sexual crime against children is not discussed openly in India and it is considered as a taboo subject. Good touch, bad touch, lack of communication regarding sexual consent and non-reporting of crimes in this regard increases these crimes. Hon'ble said that it is the pious duty of all of us under the Constitution that any kind of violence against children is not be just and forgivable and therefore, all of us have to take such type of crimes seriously, so that real culprit should not only be sent to behind bars but also be punished adequately and victim or his /her survivor's or guardians should also be adequately compensated well in time.

The first session of the workshop was presided over by Hon'ble Justice Shri P. Sam Koshy and as members, Hon'ble Justice ShriArvind Singh Chandel, Smt. Tej Kunwar Netam, Chairperson, Child State Commission for Protection of Child Rights, Smt. Divya Umesh Mishra, Director, Women and The Child Development Department. In it, presentations were given by Anand P. Wariyal, Member Secretary, Chhattisgarh State Legal Services Authority, Department of Women and Child Development, Government of Chhattisgarh, UNICEF, Commission for Protection of Child Rights, Judge of Special Court, POCSO Act.

The Second Session has been presided over by Hon'ble Justice Shri Arvind Singh Chandel along with Members, Hon'ble Justice Shri Deepak Kumar Tiwari, Shri Arun Dev Goutam, Secretary, Home Department and Shri Job Zachariah, Chief Officer, UNICEF. The closing address was given by Hon'ble Justice Shri Deepak Kumar Tiwari, Member, High Court Juvenile Justice Committee, Chhattisgarh. Presentations were presented during the session by Smt. Sushma Sawant, Director, State Judicial Academy, Department of education, health and police. The discussion in the program was done by Dr. Sanjeev Shukla, IG, Dr. V R Bhagat, Deputy Director, Health Department, Mr. Raj Kumar Tiwari, Assistant Director, Public Education.

SLSA's Visit to Halfway Home to provide necessary aid to recovering mental Patients:-





As per the instructions of the Hon'ble Justice Shri Gautam Bhaduri, on the occasion of Legal Services Day, on 09-12-2022, special program was organized at Halfway Home. On this occasion, Member Secretary, Mr. Anand Prakash Warial, Mrs. Kamini Jaiswal, Under Secretary, Mr. Shashank Shekhar Dubey, Legal Aid Officer, went to the Half Way Home to meet the mentally ill patients who had become healthy. After recovering from mental hospital, such patients are kept in half way home and after some time arrangements are made to send them home. On this occasion fruits were distributed by the authority. We have successfully rehabilitated eight recovered mental patients during the period January to December 2022. Of which seven are from Chhattisgarh and one from another (Bihar) state.






OUR PROGRAMS

Legal Aid and Advise

Prime obstacle that people face in accessing justice is the lawyer's fees, cost of legal advice and legal representation. Legal Aid programs are central component of strategies to enhance access to justice during the year our focus was to ensure that quality of Legal Aid and advices rendered to the seekers. Providing the people with legal knowledge is a checkmate in ensuring equal access to justice. With the vision of legal empowerment of every individual the Indian parliament enacted the Legal Services Authorities Act in 1987. With its grassroots out-reach CGSLSA has a completed the task of ensuring that people are legally empowered by providing legal aid and advise and secure their rights as guaranteed under the Constitution.



Pinpointing the appalling requirement of free legal aid for legal awareness the Chhattisgarh State Legal Service Authority Bilaspur is providing legal aid to various targeted identified groups such as members of schedule caste, schedule tribes, backward classes, children, under trial prisoners, senior citizens etc. Due to socio-economic constraints people from such classes fail to access to legal aid. Several strategies are adapted to by CGSLSA to create adequate legal awareness such as by facilitating initiative by holding legal literacy campus supporting strategies to address the legal barriers people face and taking proactive steps to redress the immediate cause of grievances. We work hard on attempting to upgrade and refine our dimensions of target groups by facilitating training programs and also building capacities of team involved for providing legal aid to the targeted section.


To make people conscious of their prerogative rights and privileges as well as their duties large number of legal awareness camps were held across the state by DLSAs to provide legal aid.

Legal Awareness

Legal aid to the poor and week is an necessary for the preservation of rule of law, which is necessary for existence of orderly society. Legal Aid is one of the means to ensure that the opportunities for securing justice are not denied to any person by reason of poverty illiteracy etc. The concept of legal aid is multifaceted and has two main dimensions first of which is conventional approach that is a providing free legal assistance to poor litigate and the second is preventive legal aid services program which is significant in developing countries like India, where there is appalling poverty, ignorance and illiteracy and the people like awareness of their right and needs to enforce them. More often they are not aware of available machinery for seeking judicial administrative address



It covers the disputes related to the public utility namely service of transport, post-telegraph or telephone, Supply of power, electricity or water to the public by any installation, System of public sanitation or hygiene, Service in dispensary or hospital, Insurance Service, Services of banking and other financial institutions, Supply of any type of fuel by an establishment to the general public, educational institutions, housing and real estate service etc.



Legal Aid Defence Counsel System

In previous year, Bilaspur district was selected for pioneering pilot project for the implementation of "Legal Aid Defense Counsel System". The pilot project was a huge success in terms, disposal of <u>interlocutory</u>, judgements, examination of witnesses etc.

Keeping in view the immense success of the Legal Aid Defense Counsel System, pilot project, the National Legal Services Authority, New Delhi directed its implementation in 17 other districts apart from district Bilaspur. At present, expanding the work area of Legal Aid Defense Counsel System, cases of Sessions Courts and Magistrate Courts have also been included, so that free legal aid can be provided to eligible needy accused/convict.

Under the guidance of Hon'ble Executive Chairman, Chhattisgarh State Legal Services Authority, Bilaspur, we are ready with office sites, equipment and furniture in all 17 districts of the State. Every step has been ensured for smooth functioning of office of Chief, Deputy and assistant Legal Aid Defense Counsel System. The process of appointment has also been completed. Legal Aid Defense Counsel System in the above 17 districts, will start to function from 2023 as per directions of NALSA.

This application suite will provide the vital information about the inmates, lodged in the prisons, in real time environment to the prison officials and other entities, involved in Criminal Justice System. It will also facilitate online visit request and grievance redressal.

e-Prisons application suite, developed by NIC, is cloud based product designed with easy to use GUI and embedded with a comprehensive security features. It can be easily adopted by any state prisons department with minimum customization efforts since all the possible customization features are parameterized and can be configured by the users. This application suite consists of three main products:


Virtual Outreach


We have attempted to make optimum use of Social Media Platform for legal awareness and outreach activities.

After completion of treatment, he was discharged and was kept under the protection of "Half Way Home" at Bilaspur. Umesh Yadav's relatives were not coming to take him. As a result, information was given to Chhattisgarh State Legal Services Authority. Due to necessary counseling and effective legal aid through PLV by SLSA, Umesh Yadav was rehabilitated, united with family and living a happy life.



Success Story

Mentally treated patient Naval Singh Rathore, age 50 Years, Resident-D.L.S. College Road, Near Bagdai Mandir, Ashok Nagar, District - Bilaspur (Chhattisgarh) was brought to "Half Way" Care home on 10.07.2019 for Rehabilitation. His relatives were not willing to accept him back. Request was made to State Legal Services Authority, for rehabilitation assistance of Nawal Singh Rathore from District-Bilaspur (Chhattisgarh). State Legal Services Authority, District-Bilaspur Chhattisgarh provided effective counseling to the relatives. Due to efforts of SLSA consequently naval Singh Rathore's brother Mr. Kamal Singh Rathore, agreed to take his brother back to his home.


The **Karuna** Scheme is crafted with the object to identify the senior citizens who require food, shelter, medications and are incapable to maintain themselves, to classify such senior citizens who have been deserted by their children inspire of having means, to provide them necessary counseling, making attempts to reunite them with their family and to provide them with free legal aid to destituteed senior citizens to seek maintenance from their children, who refuse to maintain them. During the period January to December, 2022 CGSLSA has identified 800 such cases. Necessary counseling has been provided to them in 553 cases, out of it, 426 cases have been amicably resolved and penal advocates have been provided in 11 cases so far.



SUCCESS STORIES

1 CGSLSA extended helping hand to patient Rajendra at Half Way Home:-

During visit to Half Way Home at bilaspur, on occasion of Legal Service Day on 9th Nov. 2022, Member Secy. Shri Anand Prakash Wariyal distributed fruits to the inmates and interacted with them. One of the inmate named Rajendra inform in grief that since he was admitted in a mental hospital and is currently living in a half-way home, no one from his family, his wife, children or brother comes to meet him. Nor has the family members been talked to on the phone, on which the member secretary Anand Prakash Wariyal immediately called his brother Kaushal Chandrakar to talk to Rajesh on the mobile number given by him, he complained to his brother that after getting him admitted here, no one came to see him and expressed his desire to meet his wife and child. After getting the information of his brother's recovery, Kaushal assured to come to pick him up within a week, and then on 16-11-2022, after reaching Half Way Home Bilaspur with the help of PLV, he happily took his recovered brother Rajesh @ Rajender with him to his home village Pendrikala.

(2) Address was traced & the inmate was sent safely to his home in Bihar:-

Surendra Yadav, who was living in a half-way home after recovering, could not be sent back to his home due to non-availability of his address, the address of Surendra Yadav was arranged by the Chhattisgarh State Legal Services Authority with the cooperation and coordination of the Bihar State Legal Services Authority,. After finding out the address of at Mohammadpur district Vaishali, Bihar, information about his stay and health in Bilaspur was given to his family members, on which his mother took her son Surendra Yadav from half way home to her native home at Bihar. The family has expressed their gratitude to both the State Legal Services Authorities for their prompt help and action.

(3) Recovered mental patient Shobha shifted to special home GHARONDA for rehabilitation

An unknown man, and two unknown women alias Shobha and unknown woman alias Rajni, admitted in the State Mental Hospital Sendri. They had recovered on proper treatment in the mental hospital, but their residence could not be traced even after many efforts. State Legal Services Authority made sincere efforts to arrange place for their stay. In this regard correspondence was made with the Joint Director, Social Welfare Department, Raipur requesting for stay arrangements. On request of SLSA arrangements were made to send them for rehabilitation to the Gharaunda Sensational Mental Handicapped Service Institute, operated in Raipur till there actual residence is ascertained.

Missing daughter of complainant recovered on prompt action by DLSA Balrampur

During the legal awareness camp organized at village Devsarakala police station Kusmi, Sasti Bai husband Sangeet Ram present in the camp informed about the missing of her minor daughter victim, aged 17 years, to PLV IrsadAlam. As soon as the information about the incident was received from that woman, the PLV, along with that woman, informed kusmi police station and the Superintendent of Police, Balrampur, after receiving information prompt action was taken, during investigation, the police got information that the victim, daughter of Sasti Bai, was taken with him by the boy of village Kodwa. Action is being taken by the police in this regard the applicant got her daughter back, she praised concerned DLSA for their efforts.

(5) Examplary Judicial Sensitivity & award of Rs. 19,00,000/- was made

District Legal Services Authority played an important role in providing quick and easy justice to the paralyzed party. In the National Lok Adalat held on November 12, 2022 Mr. Prashant Kumar Shivhare, during the hearing of pending accident claim proceedings in the Court of Additional District Judge, Mr. Judge left his court and came to the court premises to meet the paralyzed party. Considering his physical incapacity, an award of Rs.19,00,000/- (Rupees Nineteen Lakhs) was made on the basis of mutual agreement between the applications and the insurance company

Relentless efforts of DLSA Raipur made dispute resolution possible from ventilator

Most, noteworthy success story is from Raipur, where a complainant, who was a patient of brain cancer, connected with the aid of video conferencing facility, and successful resolution of dispute was made possible. Due to effective counseling and hard work, fruitful outcome could be obtained as disposal by successful compounding was made possible by using video conferencing facility, in a case pertaining to 76 year old complainant who was hospitalized and is in ventilator support.

7 Family reunited after necessary counseling by DLSA Korba

The petitioner Mrs. Mamta Sahu, age 31 years and her husband Satyanarayan Sahu alias Sonu resident of Brahmin Para Korba got married in 2007. The couple had two daughters. The non applicant Satyanarayan Sahu alias Sonu started abusing and assaulting the petitioner in the desire of son and got involved in illicit relationship with another woman The non applicant stopped supporting them financially. Due to non applicants failure to maintain them, the petitioner and two minor girls were facing huge economic crisis. In order to meet the demands of herself and both the minor children, the applicant was compelled to maintain her minor children by demanding from others. The destituteed petitioner Mrs. Mamta Sahu and her two minor children filed an application for maintenance in the Court.

In the National Lok Adalat held on 14.05.2022, necessary counseling was given the parties by learned presiding officer of Family Court. The non applicant was explained, that in present times there is no difference between a son and daughter and its is responsibility of every parent to provide girl child equal care, affection and opportunity in life. The non applicant was also advised to take care of his minor children and the applicant by taking them home as it is his moral and legal duty towards them. As a result of effective counselling the non applicant agreed to live with his family. Thus the National Lok Adalat helped a poor mother and her minor children to have a happy life.


