In supersession of the earlier Round-2 Educational Notification dated 26<sup>th</sup> August, 2025, regarding Round-2 of Tripura Undergraduate Medical Counselling 2025, the competent authority of Tripura Medical Counselling Committee (TRMCC) hereby publishes the Revised Round-2 schedule along with necessary instructions to the candidates.

**The candidates who desire to surrender their Round-1 admitted seat can do so up to 5 PM of 13-09-2025 without forfeiture of their security deposit.**

Please follow the Tripura NEET UG 2025 Information Bulletin, dated: 25<sup>th</sup> July, 2025 for details of Registration fees and Security deposit for fresh candidates.

The eligibility and qualification to get a seat shall be in accordance with information bulletin of Tripura Undergraduate Medical Counselling 2025 published by TRMCC and information bulletin published by NTA/Guidelines of MCC/NMC/MCI/MoHFW/Ministry of AYUSH/guidelines of Institutions.

**Instructions to the candidates:**

- 1) To participate in Round-2 Counselling, a fresh candidate has to register with submission of **registration fees (online)** and also have to **deposit security money (online)**.
- 2) Candidates who have already registered and participated in Round-1 counselling **need not register again** and shall be able to take part in the Online Choice filling of Round-2 Counselling for fresh allotment or change of Institute.
- 3) The Round-1 allotted and admitted candidates who participate in Online Choice filling during Round-2 of the counselling shall be automatically considered as **willingness to upgrade**.
- 4) All the aspirant eligible candidates are instructed to follow the TRMCC website <https://trmcc.admissions.nic.in> ) regularly for further Notices/Updates/Notification which may be issued from time to time.

Candidates are instructed to participate in the "Choice filling" as per their choices in the Counselling portal for allotment of seats as per seat matrix and category according to Merit (Result score and Rank of NEET UG 2025).

- 5) Candidates are instructed to follow the official website of the participating Institutions or contact directly for getting the details of admission procedure, fee structure and other details.
- 6) A Candidate once admitted to a Round-2 allotted seat **can upgrade but cannot resign**.
- 7) A Candidate allotted a Round-2 seat but not get admitted, can participate in Round- 3 with '**forfeiture of Security Deposit**'.
- 8) Candidates Allotted and Admitted in Round-2 shall not be permitted to resign from the admitted seat but can participate till Round-3 counselling.
- 9) A candidate who is not allotted any seat in Round-2 may surrender his/her Round-1 admitted seat with forfeiture of the Security Deposit. *However, such surrender must be completed within the stipulated deadline (date and time to be notified separately) and before the commencement of Round-3 counselling.*
- 10) Round-1 registered candidates, who applied only in Government Institutes by paying Rupees 10,000/- (Rupees Ten Thousand only) or Rupees 5,000/- (Rupees Five Thousand only), now can modify their Security Deposit for applying in either Non-Government or Government



& Non-Government Institutes by paying rest of the security deposit after 'Registration Unlocking'.

Candidates are further clarified that for applying in **Government Tuition fee seats at Tripura Santiniketan Medical College**, the candidates have to pay the security deposit similar to **Non-Government Institutions**.

All fresh candidates and those registered in Round-1 are hereby instructed to carefully go through the Tripura NEET UG 2025 Information Bulletin dated 25th July, 2025, available on the TRMCC website, for complete details (*registrations fees, security deposit, clause supporting document, necessary instructions, flowcharts, annexures etc.*) before applying for participating in Round-2 Counselling.
