**Educational Notification Regarding**

**Round-3 of Tripura Undergraduate Medical Counselling 2025**

It is hereby notified that Round-3 of Tripura Undergraduate Medical Counselling 2025 for Tripura state quota/Domicile seats and All India other than Tripura candidates will start from **08-10-2025, 2 PM**. The detailed schedule has already been published on the official website.

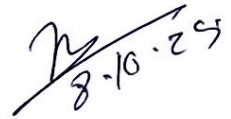
All eligible candidates who have not registered in earlier rounds may register afresh for participation in Round-3 of Tripura Undergraduate Medical Counselling 2025.

**Eligibility and qualification:** Eligibility and qualification for admission shall be in accordance with the Information bulletin of Tripura Undergraduate Medical Counselling 2025 published by TRMCC and relevant guidelines issued by NTA/Guidelines of MCC/NMC/MCI/MoHFW/Ministry of AYUSH and respective Institutions.

**Important Instructions for Candidates:**

- Newly registered candidates must pay the Registration Fee and Security Deposit as notified earlier which is mandatory for participating in Round-3. Documents of Eligibility, NEET UG 2025 score Card, Admit Card, Age Proof Certificate and all others relevant certificates shall have to be uploaded during Online Registration.
- Candidates who were allotted seats in Round-2 but did not take admission are informed that their security deposit stands forfeited. Such candidates must pay **both the Registration Fee and Security Deposit** afresh to participate in Round-3 of Tripura Undergraduate Medical Counselling 2025.
- All candidates are advised to fill their desired choices even if seats of that category seat are not available, as vacancies may arise due to upgradation.
- The admitted candidates willing to upgrade may fill additional choices during Round-3 but shall not be permitted to remove their presently allotted institution.
- Candidates are instructed to follow the website of Allotted Institutions for details regarding admission and other details.
- A Candidate allotted a seat in Round-3 but **does not join/admitted**, then there will be **exit with forfeiture** of security deposit and Elimination (cannot participate in further rounds of counselling).
- A Candidate once admitted to a Round-3 allotted seats **cannot upgrade/resign**.

- If a candidate is not allotted any seat in Round-3, the previously allotted seat in Round 1 or Round-2 will be retained. However, on up- gradation of a seat in round 3, the previously allotted seat in Round-1 or Round-2 will automatically be cancelled and allotted to another candidate. The candidate will have **NO CLAIM** over the previously allotted seat. Therefore, the Candidates are advised to fill choices carefully.
- Candidates retaining seats from Round-1 or Round-2 but not allotted any seat in Round-3 cannot resign thereafter.
- All candidates participating in Round-3 are instructed to go through all the previous notifications/Information Bulletin/guidelines/steps of counselling/flow chart related to Tripura Undergraduate Medical Counselling 2025 Counselling carefully before proceeding.
