The Information Bulletin regarding Round-1 Schedule, Seat matrix, Eligibility criteria, Procedure of Counselling, Guidelines, requisite fees etc. in connection with Tripura Postgraduate Medical Counselling 2025 is published herewith.

All the eligible candidates are instructed to visit the Tripura Medical Counselling Committee (TRMCC) website: https://trmcc.admissions.nic.in regularly for next Notification/updates/Memorandum in connection with Tripura Postgraduate Medical Counselling 2025 and to keep all testimonials and documents ready for all eligibility criteria/qualification/others particulars requiring documents in respect of a candidate which will be needed for necessary uploading during online registration by the candidate and also during physical verification of documents as when and where it will be scheduled and asked for.

All the eligible In-Service candidates of Tripura are also instructed to keep ready their 'No objection Certificate' and 'Service Certificates' of Difficult/Remote areas in completed years to be issued by the Director of Health Services, Govt. of Tripura to be eligible for getting requisite Incentives accordingly.

INFORMATION BULLETIN

REGARDING ELIGIBILITY, GUIDELINES, BOND STRUCTURE, REQUISITE FEES, ETC. IN-CONNECTION WITH TRIPURA POSTGRADUATE MEDICAL COUNSELLING 2025.

1. Admission to the State Quota/domicile Seats and Seats in the Private Medical College in different Post Graduate Medical Courses shall be made on the basis of inter se merit of NEET PG (MD/MS) POST MBBS DIPLOMA 2025 through Single point entry of different categories of UR/ST/SC/PwD (Persons with benchmark disability), WESM (Ward of ex-serviceman) & EWS (Economically Weaker Section) successful candidates as per cut off marks determined by NBE/MCI/NMC/MoHFW, New Delhi with applicable incentive for eligible in-service candidates as defined by Health and Family welfare Department, Government of Tripura. The Counselling authority of the above seats shall be the Tripura Medical Counselling Committee (TRMCC).

2. General information for Tripura Postgraduate Medical Counselling 2025

- *a)* Candidates who will register through online counselling portal (https://trmcc.admissions.nic.in/) will be eligible for participating in the Tripura Postgraduate Medical Counselling 2025.
- b) There will be 4 (four) rounds of counselling: Round -1, Round- 2, Round-3 and Stray Vacancy Round. All rounds of the said counselling will be performed online.
- c) The candidate must possess MBBS from the Institution recognized by National Medical Commission (NMC), New Delhi or having the required eligibility as prescribed by NMC.
- d) The candidate shall be selected as per Merit and choice filled by the candidates for admission to different Post Graduate Medical Courses in the Medical Colleges of the State of Tripura or outside the State.
- e) Candidates are deemed to have read, agreed and accept the Information Bulletin for NEET PG 2025, Eligibility Criteria, Terms and Conditions, Steps of Counselling, Applicable registration fees and mandatory security deposit etc. before registering their candidature in the counselling.
- The candidate must have completed the compulsory Rotatory Internship for 1(one) year on or before 31/07/2025. He should possess registration from State Medical Council or NMC. If a candidate is not having Registration from Tripura State Medical Council (TSMC), he/she must produce a copy of the said registration within 3(three) months of his/her admission in the concerned Institution and submit a copy of Registration to the admission section of Medical College of the State as well as to the office of the Director of Medical Education, Govt. of Tripura.

Candidate who is pursuing any course or internship in any Institutions/Universitiesis not eligible for

admission if she/he did not complete the internship within 31/07/2025. Such candidates shall have to submit the Internship completion certificate from the Head of the concerned Institution.

Candidate pursuing any course presently must submit acceptance of resignation and release certificate from the Head of the Concerned Institution before getting admission to the PG Courses for the academic session 2025-26 (MD/MS and Post MBBS Diploma) if gets selected.

- g) The candidate must register his/her name in Tripura Postgraduate Medical Counselling 2025 through (https://trmcc.admissions.nic.in) with requisite fees, security deposits, information and documents which ever and wherever applicable. There will be fresh Registration in all rounds of Counselling.
- h) The candidates once registered in any round shall not be required to deposit the registration fee again for subsequent rounds, unless after forfeiture of security deposit the candidate wish to participate in the next round. The candidates once paid the Security Deposit in any round shall not be required to deposit the Security money again for subsequent rounds, unless Security Deposit is forfeited.
- i) The eligibility for participation in every round (Round-1, Round-2, Round-3 and Stray Vacancy Round) will be in accordance to **rule of that Round**.
- j) A candidate must get Qualifying marks in NEET PG 2025 as declared by NBE/MoHFW/NMC to participate in the counselling.

k) Reservation of seats: The reservation of seats in Medical Colleges/Institutions for respective categories shall be as per applicable laws prevailing in State of Tripura. An all-India merit list as well as state wise merit of the eligible candidates shall be prepared on the basis of the marks obtained in National Eligibility-Cum-Entrance Test and candidates shall be admitted to Postgraduate Courses from the said merit lists only.

For State Quota/domicile seats, will be distributed in the counselling as per merit and seat matrix as per existing Tripura State Reservation Rules. For seats for All India Candidates other than Tripura domicile, the seat will be distributed as per Central Reservation Rules. SC, ST, EWS, WESM (Certificate approved by Director of Sainik Welfare, Agartala, Tripura) and PwD reservation will be followed as per existing guidelines of NMC/MCC/BOG/Government of Tripura/Government of India. Reservation of seats for Post graduate degree (MD/MS) Course and Diploma Course will be distributed as per 100 point Roster and existing Rules/Guidelines/Notifications/Order/Memo of the

- Government of Tripura. Horizontal reservation of seats for eligible PwD Candidates with bench mark disabilities as per guidelines shall also be provided in the seat matrix **after registration** for the 1st Round of Counselling (if any such candidate is registered).
- I) The choice or preference regarding subject, Course, Institution, once exercised shall be final for a particular round and cannot be subsequently changed in that particular round of counselling. Therefore, applicant shall have to be very careful during online choice filling of seats. The candidate will have to fill his/her choices in counselling portal, which he/she will have to lock within a schedule period, otherwise there will be auto locking of the filled choices of the candidate at the end of scheduled date and time of choice filling.
- m) In online mode the allotment will be generated (as per preference of subject and Institution) as per merit and seat matrix. The allotment of seats, once made will be final. Change of course/discipline/ Institution is not permitted thereafter. Request for the same shall not be entertained by the Tripura Medical Counselling Committee (TRMCC).
- n) A candidate will have to appear in person in due date and time and venue at allotted admitting institutions for physical verification of their original documents/relevant certificates etc. if gets allotted and intend to get admitted against the seat in that round. Absence of a candidate on the day of physical verification and/or failure to submit original relevant documents/certificates during the physical verification, he/she will be marked as absent and her/his candidature/nomination may stand as cancelled for that round of counselling. Similarly, the candidates after allotment of a seat, failed to join the college on that seat on/before the last date of joining as scheduled, he/she shall have no further claim for the seat.
- o) The Selection/Nomination/Admission against any PG seats in respect to a candidate shall be cancelled at any point of time if a candidate is found to have submitted any false/fabricated/erased/incomplete/indistinct/untraced documents or any false information in obtaining eligibility for NEET PG 2025 examination/registration for counselling/ Selection/Nomination/Admission to be allotted courses to the allotted Institutions and in such cases the candidate will not be permissible and may be debarred to participate further in the counselling for the entire academic session.
- p) The selection of candidates against a State Quota seat will be as per seat matrix, State Eligibility, Merit, State reservation rules and fulfilment of Eligibility Criteria as prescribed in the InformationBulletin of NEET PG 2025. For State Counselling/Selection/Nomination/Admission of a candidate for State Quota seats/non govt. seats, the jurisdiction of court cases/disputes shall be at Agartala, Tripura, India only.
- q) Any amendment/modification in the PGME regulations as adopted by NMC/MCC/MoHFW (GoI)

- from time to time shall be applicable on the State PG counselling for the corresponding year.
- r) Category of a candidate (ST/SC/EWS/WESM/PwD) registered during NEET PG examination 2025 shall be treated as final and cannot be modified/corrected subsequently during State Counselling. Further, no request in this regard shall be entertained.
- s) Application for surrender of seat should be physically submitted by the candidate in the admitting Institution and the Surrender certificate to be generated online by the admitting institute.
- t) A Candidate can submit his/her online application form only once. Multiple registration/submission of application from a candidate applying as different category and profile of seats shall summarily be rejected.
- u) Candidate should ensure that all the Information entered during the Online filling of Application Candidates producing false or fabricated information shall not be considered and candidates may be further debarred from appearing in any future counselling of Tripura Postgraduate Medical Counselling 2025 and further penal action may be taken.
- v) In the event of rejection of application form, no correspondence/request for re consideration will be entertained.
- w) Candidates should go through this Information Bulletin as well as NEET PG 2025 examination Information Bulletin published by NBE/MCC/NMC/MoHFW/State Guidelines for Eligibility Criteria before registration in the Tripura Postgraduate Medical Counselling 2025.
- x) Tripura Medical Counselling Committee disclaims any liability that may arise due to incorrect information provided by the candidate during online application, form submission of NEET PG 2025 examination and or during online registration and in uploading the relevant documents by a candidate in Tripura Postgraduate Medical Counselling 2025.
- y) Candidates are instructed to visit the counselling website (https://trmcc.admissions.nic.in) regularly and go through every Annexure and Notices in-connection with the Information Bulletin of Tripura Postgraduate Medical Counselling 2025 along with all Educational Notifications, Merit list, Instructions, any corrigendum or any Information in connection with Tripura Postgraduate Medical Counselling 2025 which is publish and would be published from time to time in the web site https://trmcc.admissions.nic.in. All the candidates should also visit respective website of Medical Colleges/Institutions for other details regarding all fees structure accommodation etc.
- **z)** In-Service Candidates of Tripura are reminded to be aware of latest guidelines, norms, rules of sponsorship, study leave and Rules of leave as per leave rules of Government of Tripura.

The guidelines for the counselling are in accordance with the latest guidelines/recommendations of NBEMS/MCC/NMC/MoHFW/State guidelines adopted by the state and will be followed accordingly.

3. Eligibility Criteria

3.1. Eligibility Criteria for the State quota/Government seats (OPEN CANDIDATES)

- (a) The candidate must be a Citizen of India, and
- (b) The candidate must be a domicile of the State of Tripura, and
- (c) The candidate must obtain the MBBS Degree from any Medical College Recognized by MCI/NMC with MBBS Registration Certificate of Tripura State Medical Council or any other State/Central Medical Council.

3.2. Eligibility Criteria for the State quota/Government seats (IN-SERVICE CANDIDATES)

- (i) A candidate must be a domicile of Tripura, and
- (ii) A candidate must pass MBBS Degree from Medical Colleges of Tripura or outside the State of Tripura and
- (iii) The candidate must possess **No Objection Certificate** from the appointing authority for appearing Tripura Postgraduate Medical Counselling 2025.
- (iv) The Candidate must possess **Service Certificate** denoting eligibility from the appointing authority which would determine the ultimate merit/rank of the candidate with applicable weight age in the marks as incentives. Incentives and other eligibility criteria of In-service candidates will be as per **Annexure-J.**
- (v) Study leave or other admissible leave, service bond and discontinuation bond etc will be applicable as per State Government Rules/guidelines in respective regard.
- (vi)Post MBBS Diploma seats at IGM Hospital are available for In-service Medical Officers only through Tripura Postgraduate Medical Counselling 2025 as per existing guidelines.

3.3. Eligibility for the Non-Government (TRIPURA MEDICAL COLLEGE) seats.

Must qualify NEET PG-2025 and meet one of the following-

a. The candidate must be a permanent resident of Tripura.

OR

- b. Ex-Students, passed MBBS from Agartala Government Medical College or Tripura Medical College irrespective of Tripura domicile.
- **4. Tripura State Merit List:** Tripura State Merit List of Registered eligible NEET PG 2025 candidates shall be prepared from the eligible NEET PG 2025 candidates who have registered their name for Tripura Postgraduate Medical Counselling 2025 with requisite fees and relevant documents. There

shall be a common merit list including in-service candidates (after adding applicable incentives) indicating the merit position and stating each category/subcategory (ST, SC, EWS, WESM, PwD) which will be published in due course.

5. Registration fees and mandatory security deposits:

- a) Registration fees for Tripura Postgraduate Medical Counselling 2025 are Rs. 8,000/- per candidate for General/EWS/WESM category and Rs. 7,000/- for SC/ST/PwD category. No registration will be allowed beyond schedule period of registration. The candidates once registered in any Round, he/she need not have to deposit registration fees for subsequent rounds, unless after forfeiture of security deposit the candidate wish to participate in the next round.
- **b) Security deposit** is mandatory to participate in Tripura Postgraduate Medical Counselling 2025. The candidates once paid the Security Deposit in any round shall not be required to deposit the Security money again for subsequent rounds, unless Security Deposit is forfeited.
 - i. Candidates willing to take part for State quota/Government seats shall have to deposit Rs. 25,000 /- for General Candidate and Rs. 12,500/-. for SC/ST candidate.
 - ii. Candidates willing to take part for only Non-Government Quota seats at TMC shall have to deposit Rs. 2 Lakh irrespective of category.
- iii. Candidates willing to take part in both State quota/Government seats and Non-Government Quota seats at TMC will have to deposit an amount of Rs. 2 Lac only irrespective of category.
- 6. Procedure of online counselling: The flow chart of the Counselling is furnished along with Information Bulletin. Further intimation will be furnished in the TRMCC website in due course at the time of Round-2, Round-3 and Stray Vacancy Round. Successful Physical verification of documents which will be carried out in the allotted admitting Institution for a selected candidate is mandatory for that candidate for getting admitted to his/her allotted seat.

ROUND-1

- a) Registration which will include payment of Non-refundable Registration fee and Security Deposit.
- b) Exercising of Choice filling and locking of choices.
- c) Publication of Tripura State Merit List.
- d) Process of Seat Allotment Round-1.
- e) Publication of result of Round-1 on counselling website (https://trmcc.admissions.nic.in).
- f) Downloading of allotment letter from counselling portal by the candidate and submit to the

Directorate of Medical Education, Bidurkarta Chowmuhani, Agartala, Tripura.

- g) Collection of Nomination letter from the office of DME, Tripura.
- h) Physical Reporting at the allotted Medical college/ Institute with original documents against Round -1.
- i) Candidates who have been allotted a seat in Round-1 can opt for free exit and can directly participate in Round-2.
- j) Candidates who have been allotted a seat in Round-1 can opt for willingness to upgrade from Round-1 to Round-2 after admission at college/institute.
- k) If a registered candidate is not allotted a seat in Round-1, he can participate in Round-2 directly without fresh registration fee.
- 1) Candidates willing to upgrade from Round-1 to Round-2 have to report at the allotted institute/college with original documents of round 1 and complete the admission formalities.

ROUND-2

- a) The candidates who have already registered in Round-1 after paying Registration fee and Security deposit need not have to pay registration fee and security money again.
- b) The candidates who have not registered in Round-1 can register for Round-2 with payment of registration fee and security deposit.
- c) To participate in Round-2, all the candidates must fill the choices online through the counselling portal (https://trmcc.admissions.nic.in).
- d) Candidates who have Resigned / Not reported in Round-1 need not pay registration fee and security deposit again.
- e) Publication of Tripura State Merit List.
- f) Fresh Choice filling and locking of choices for Round-2.
- g) Process of Seat Allotment Round-2.
- h) Publication of result of Round-2 on Counselling website (https://trmcc.admissions.nic.in).
- i) Downloading of allotment letter from counselling portal by the candidate and submit to the Directorate of Medical Education, Bidurkarta Chowmuhani, Agartala, Tripura.
- j) Collection of Nomination letter from the office of DME, Tripura.
- k) Physical Reporting at the allotted Medical college/ Institute with original documents against Round-2.
- 1) If upgraded in Round 2 from Round-1 admitted seat, the candidate must take relieving letter from Round-1 seat and join Round-2 seat.
- m) If a candidate freshly registered in Round 2, is not allotted a seat, he/she can participate in round

- 3 directly without payment of fresh registration fee.
- n) Candidates getting upgraded in Round 2 SHALL NOT HAVE ANY CLAIM on Round 1 seat.
- o) Candidates who have been freshly allotted a seat in round 2 can opt for willingness to upgrade from Round-2 to Round-3, for which first they will have to admit in Round 2 allotted college/institute.
 - p) If Seat allotted in Round-2 but not reported/ not joined then he/she can proceed for Round-3 counselling by submitting fresh registration fee and security deposit.

ROUND-3

- a) Those candidates who are applying for the **first time** in Tripura Postgraduate Medical Counselling 2025 has to register themselves with payment of registration fee and Security deposit for Round-3.
- b) Those candidates who have already registered in either Round-1 or Round-2 has to fill the choices online through counselling portal for upgradation in Round-3.
- c) Those candidates who have resigned from Round-2 seat, need to pay fresh registration fees and mandatory security money to participate in Round-3.
- d) Those candidates who have registered in Round-2 and exited with Forfeiture of fees without joining need to pay fresh registration and mandatory security money to participate in Round-3.
- e) Those who registered but were not allotted a seat in Round-1 & Round-2 need to fill choices online through counselling portal for participation in Round-3.
- f) Publication of Tripura State Merit List.
- g) Exercising of Fresh Choice filling and locking of choices.
- h) Process of Seat Allotment Round-3.
- i) Publication of result of Round-3 on Counselling website (https://trmcc.admissions.nic.in).
- j) Downloading of allotment letter from counselling portal by the candidate and submit to the Directorate of Medical Education, Bidurkarta Chowmuhani, Agartala, Tripura.
- k) Collection of Nomination letter from the office of DME, Tripura.
- 1) Physical Reporting at the allotted Medical college/ Institute with original documents against Round-3.
- m) If upgraded, the candidate must relieve from previous admitted seat and join Round-3 seat. Once joined, he **cannot upgrade or resign** from Round-3 seat.
- n) If any candidate does not join Round 3 seat, he may exit with forfeiture of security deposit and **elimination** (cannot participate in further rounds of counselling conducted by TRMCC.
- o) If a candidate freshly registers in round 3 and is not allotted any seat, he/she is eligible to participate

- in further rounds.
- p) Candidates getting upgraded in Round 3 shall Not have any claim on earlier round allotted seat.
- q) Once admitted in the allotted seat in the Round-3, his/her Counselling for the year finishes at that point.

STRAY VACANCY ROUND

- a) Those candidates who are applying for the first time in Tripura Postgraduate Medical Counselling 2025 has to register themselves with payment of with payment of registration fee and deposit of mandatory security money for Stray Vacancy Round.
- b) Fresh choice filling for Stray Vacancy Round will be required. The choices filled during Round-3 will not be considered for allotment in Stray Vacancy Round.
- c) Candidates **who are not holding any seat** or did not get any seat in Round-1/Round-2/Round-3 (AIQ, State, Deemed) can participate in Stray Vacancy Round.
- d) In case any candidate is found holding any seat (AIQ, State, Deemed) of any Round, his/her candidature for stray vacancy round will automatically be cancelled.
- e) Candidates who were allotted seats in Round 3 and did not join, cannot participate in Stray Vacancy Round.
- f) If a candidate is allotted a seat in Stray vacancy round, he/she has to report & join the allotted seat at college/institute else he/she shall be debarred from NEET PG Examination for subsequent 1(one)year along with forfeiture of security deposit as per MCC guidelines.

6. The candidates appearing for Counselling will have to upload/submit the following documents as per registration form :

- (i) Admit Card of NEET PG.
- (ii) All India NEET PG Rank/Score Card.
- (iii) University MBBS Degree Certificate.
- (iv) Mark Sheets of MBBS- 1st, 2nd & Final MBBS(Part I & II).
- (v) Internship completion certificate (Cut-off date 31-07-2025).
- (vi) Medical Registration Certificate issued by MCI/State Medical Council.
- (vii) School Leaving Certificate/Class X Mark sheet/Class X Admit card denoting date of birth as proof of age.
- (viii) ST/SC/WESM/PwD/EWS Certificate of FINANCIAL YEAR 2024-25.

 Certificate of Disability for PwD candidates shall have to be in prescribed format on online

uploading signed by Designated Authority as per prescribed latest norms and as per MCI Gazette Notification No.MCI-18(1)/2018-Med./187262, dated 5th Feb, 2019/14th May, 2019.

Economically weaker section (EWS) Certificate of **FINANCIAL YEAR 2024-25** shall have to be in prescribed format and signed by designated issuing authority as belonging to EWS for an eligible EWS candidate asper Office Memorandum No. 36039/1/2019-Estt (Res), Ministry of Personal, Public Grievances & Pensions, GoI, Dated, 31/10/2019.

- (ix) PRTC (Permanent Resident of Tripura Certificate) in case of State domicile candidates only.
- (x) Photo.
- (xi) Signature of the Candidate.
- (xii) Signature of the Parent/Guardian.
- (xiii) Mobile phone number of the candidate.
- (xiv) E-mail ID of the Candidate.
- (xv) For in-service candidates (in addition to above documents).
 - (a) No objection certificate from appointing authority for NEET PG 2025 exam.
 - (b) Service Certificate stating service in rural/difficult/Remote areas with exact duration.

Candidates without uploading the above documents/information shall not be considered for the Counselling and/or shall not be considered for any weight –age in the marks (for in-service candidates).

- 7. Bond: For details, please follow the latest Notifications of Bonds (Annexure-I).
- **8.** Schedule of Tripura State PG (MD/MS) Counselling 2025: All the schedules and guidelines etc. are subjected to change as per latest Notification from NMC, Directives from Ministry of Health & Family Welfare, Govt. of India and Directives from Govt. of Tripura and any Directives/Verdict from the Court of Law.
- **9.** The TRMCC reserves the right to Withdraw / Cancel any Allotment / Selection /Nomination /Admission, if any, later found to have been granted or allowed inadvertently to any candidate who is not eligible to appear/participate in the counselling or not eligible to be allotted /selected/Nominated or not eligible to get admitted against a seat at anypoint of time.

10. Communication Protocols:

Information in the Information Bulletin of Tripura Postgraduate Medical Counselling 2025 will guide the candidate through the entire process of counselling and help answer most of queries.





It is for appraisal of all concerned that Under Graduate (UG) & Post Graduate (PG) Courses aspiring candidates that, the following clauses regarding execution of the Bond before admission to Medical Colleges shall come into force from the academic session 2020 and onwards as under :-

- A. (Post Graduate Degree (PG) & Diploma Courses):- PG Service Bond: In the event of failure to serve the stipulated period under Govt. of Tripura as per Bond, he/she has to pay an amount of Rs. 35.00(Rupees thirty five) lakhs only for Post Graduate Pre & Para Clinical Subjects Courses (Anatomy, Physiology, Biochemistry, Pharmacology, Pathology, Microbiology, Forensic Medicine & Toxicology, Community Medicine etc.) and Rs. 50.00 (fifty lakhs) only for Clinical Subjects Courses (General Medicine, General Surgery, Orthopaedics, Otorhinolaryngology (ENT), Obsterics & Gynaecology, Anaesthesiology, Paediatrics, Ophthalmology, Psychiatry, Respiratory Medicine, Radio Diagnosis, Dermatology, Radiotherapy etc.) and Rs.15(fifteen) lakhs for PG Diploma Courses to the Government of Tripura as under Clause 1,2 & 3.
- B. PG/Diploma Discontinuation Bond:- Execution of a Bond by a Candidate stating that a Candidate will pay an amount of Rs. 25.00 lakhs in Pre-Clinical & Para Clinical PG Degree Courses and Rs. 35.00 lakhs in Clinical PG Degree Subjects Courses and Rs. 10.00 lakhs for all PG Diploma Courses to the Govt. of Tripura/Concerned Institution if he/she discontinues his/her PG Course as under Clause 1,2,3 & 4.

NOTIFICATION

It is for appraisal of all concerned, Under Graduate (UG) and Post Graduate (PG) Students of Medical Colleges of the State and outside the State, (domicile, sponsored and Central Government nominee) that a bond has to be executed and submitted in original in the office of the Director of Medical Education, Agartala, on being selected/admitted in the U.G and P.G. Courses as per the clauses as mentioned below:

- 1. All State candidates (domicile and sponsored) of Under Graduate and Post Graduate courses shall have to execute a Bond in favour of the State Government stating that he/she shall serve under Government of Tripura for a period of at least 5 (five) years immediately after successful completion of the course.
- 2. In case such candidates fail to serve under Government of Tripura as per Bond, he/she has to pay an amount of Rs.20,00,000.00(Rupees twenty lac) instead of existing amount of Rs.5,00,000.00 (Rupees Five lac) for Under Graduate course and Rs.35.00,000.00(Rupees Thirty five lac) instead of existing amount of Rs. 25,00.000.00 (Rupees twenty five lac) for Post Graduate in Pre & Para-clinical subjects (Anatomy, Physiology, Biochemistry, Pharmacology, Pathology, Microbiology, Forensic Medicine & Community Medicine) and Rs.50,00,000.00(Rupees Fifty lac) instead of existing amount of Rs. 35,00,000.00 (Rupees thirty five lacs) in Clinical subjects (Medicine, Surgery, Orthopaedics, ENT, Obstetrics. & Gyanecology, Anaesthesiology, Paediatrics, Ophthalmology, Psychiatry, TB & Respiratory Diseases, Radio-diagnosis, Dermatology and Radiotherapy) to the Government of Tripura.
- 3. All Under Graduate and Post Graduate Students (domicile, sponsored and Central Government nominee) should execute a Bond stating that he/she will pay an amount of Rs. 20,00,000.00(Rupees twenty lacs) if he/she discontinues the course before completion.
- 4. The Bond obligations will not apply if the offer of appointment is not made by the Government within 1(one) year from the date of communication of the results specified in Sub-clause ix(a) of Clause-3 of the bond or the candidates accepts the offer of employment even after one year.

This is issued in cancellation of all previous Notifications issued in this regard and with the approval of the Government, vide U.O. No.F.1(23)- GA(CAB)/2007(1) dated 3rd August,2016.
