Educational Notification Regarding
Provisional Allotment and Waiting List of
Stray Vacancy Round of Tripura Undergraduate Medical Counselling

The Provisional Allotment and Waiting List of the Stray Vacancy Round of Tripura Undergraduate Medical Counselling 2025 is already published on 25-11-2025 for the information of all concerned candidates.

All candidates who have been provisionally allotted seats are mandatorily required to report to the Office of the Directorate of Medical Education (DME), Bidurkarta Chowmohani, Agartala, along with all requisite documents of eligibility and qualification, and 04 (four) passport-size photographs, on or before 27-11-2025, 5:00 PM, for collection of the Nomination Letter.

Failure to collect the Nomination Letter within the stipulated time shall result in automatic cancellation of the allotted seat without further notice, and the said seat shall be allotted to the next eligible candidate from the waiting list strictly as per merit. In such cases, the concerned candidate shall have NO further claim whatsoever over the cancelled allotment, and NO request, representation, or appeal in this regard shall be entertained under any circumstances.

After collecting the Nomination Letter from the Office of the DME, all allotted candidates must report to the respective admitting institute between 25-11-2025, 3:00 PM and 28-11-2025, 5:00 PM, for physical verification of all original certificates and documents relating to eligibility, qualification, category, sub-category, and any other applicable criteria. The last date for admission under the Stray Vacancy Round is 28-11-2025, up to 5:00 PM.

Candidates allotted seats outside the State of Tripura are advised to report at the earliest within the scheduled timeframe to the Office of the DME, Tripura, for obtaining the Nomination Letter and for procuring the required Certificate of Fitness from the respective admitting Medical College.

The Nomination Letter issued is **purely provisional**, subject to verification of original documents. Each candidate must substantiate all claims made during registration/allotment with valid and authentic documents within the prescribed admission period.

Candidates included in the WAITING LIST, as per merit rank, are instructed to regularly monitor their TRMCC login account and the TRMCC website for immediate updates and to remain themselves prepared for instant reporting and admission in case any vacancy arises after 27-11-2025, 5:00 PM.

Any candidate having been found to have submitted false / fabricated/untrue/ partially true/ incomplete/ illegitimate/ illegible documents in support of eligibility / qualification/ status or not comprising with the norms and guidelines of NTA/MCC/NMC/Ministry of Ayush/ MoHFW/Govt of Tripura/ competent authority, his/ her allotment / nomination/ admission and other relevant Statutory may be cancelled at any point of time even after admission.

All disputes pertaining to the provisional allotment result of Stray Vancy Round of Tripura Undergraduate Medical Counselling 2025 shall fall within the jurisdiction of Agartala, Tripura only.
