Educational Notification Regarding
Provisional Allotment of Stray Vacancy Round of
Tripura Postgraduate Medical counselling 2025

The Provisional allotment of candidates selected in Stray Vacancy Round of Tripura Postgraduate Medical counselling 2025 is published herewith for general information to all concerned candidates.

1. Allotted candidates are instructed to report to the Office of DME by **11 AM, 27-02-2026** with allotment letter (to be downloaded from Candidate account), relevant documents and **service bond** along with 4 (four) passport size photo following which nomination will be issued from DME.
2. Nomination has to be collected from the office of DME by the candidate from **27-02-2026, 11 AM onwards to 28-02-2026, 3 PM.**
3. A candidate has to report at allotted admitting Institution from **27-02-2026 to 28-02-2026, 5 PM** with the nomination issued from DME for physical verification of all relevant original documents and complete admission formalities following successful verification of their original documents accordingly. The **last date of admission** is by **28-02-2026, 5 PM.**
4. A candidate has to substantiate his/her claim through valid documents within the last date of admission. In case of any ambiguity, NMC guideline will prevail over State and if any overlapping exists between state and NMC norms then the NMC norms will prevail being concurrent jurisdiction.
5. Any candidate having been found to have submitted false/ fabricated/ untrue/ partially true/ incomplete/ illegitimate/ illegible documents in support of eligibility / qualification/ status or not comprising with the norms and guidelines of NTA/MCC/NMC/MoHFW/Govt of Tripura/ Admitting Institution and other relevant Statutory Authority, his/her allotment / nomination/ admission may be cancelled at any point of time **even after admission.**
6. If any candidate fails to take admission to the allotted institute after being allotted a seat in the Stray Vacancy Round, his/her security deposit will be forfeited, and he/she shall be debarred from appearing in the NEET PG examination for the next one year.
7. All disputes pertaining to the provisional allotment result of Stray Vacancy Round of Tripura Postgraduate Medical counselling 2025 shall fall within the jurisdiction of Agartala, Tripura only.
8. All the candidates are instructed to follow the TRMCC website (<https://trmcc.admissions.nic.in>) regularly for further notification/notices/instructions and updates which may be published from time to time.
