ADMINISTRATIVE AND FINANCIAL APPROVAL FOR CONSTRUCTION OF CRC-MADURAI BUILDING THROUGH NBCC (INDIA) LIMITED

Decision:

The Chairperson EC apprised the Council that DEPwD conveyed the approval for setting up of four CRCs with approval of DoE vide order dated 15.05.2023. NIEPMD(D) had done a good job by liaison with Govt of Tamil Nadu to get the services started in temporary building. Now, NIEPMD(D) have identified a land for construction of building and Govt of Tamil Nadu has issued a GO for transfer of land to the extent of 5.05 Acre in the survey no:40/1, 40/2, 40/3A and 36/2.

Hon'ble Minister, Secretary and IFD had accorded approval for construction of the said four CRC building (including CRC-Madurai) through NBCC (India) Limited. The construction of building for CRC Jammu and Chhatarpur were started through NBCC following the due procedure. MoU was signed between PDUNIPPD and NBCC, AYJNISHD and NBCC for construction of CRC buildings.

The construction at the above two CRCs are progressing satisfactorily and now CRC-Madurai after obtaining the Government Order dated 09.12.2024 from Govt of Tamil Nadu has come out with the proposal for construction of building.

The council based upon the past work experience accord concurrence for construction of CRC-Madurai building through NBCC (India) Limited with the financial implication of Rs.36,41,18,038.93 by following the GFR procedure. The procedural part with respect to financial and following GFR norms for giving the said work to a Public Sector Undertaking will be examined by DEPwD through IFD.

The EC in principle accords approval for the proposal of construction of CRC-Madurai building through NBCC (India) Limited with the financial implication of Rs.36,41, 18,038.93 by following the GFR norms.
