IMPORTANT NOTE:

- The above consultant position will be filled purely on contractual basis.
- Engagement will be governed by the rules and regulations, terms and conditions of the engagement of the Institute presently in force or as may be framed, amended, altered or extended from time to time by the Ministry.
- A fixed monthly amount shall be admissible and the remuneration may be regulated as per the terms and conditions of the contract. No other allowances will be admissible.
- Annual increment @3% shall be allowed during the term of the contract.
- Paid leave of absence may be allowed @ 2.5 days for each completed month of service.
- On contract initially for a period of 3 years and thereafter extendable, after review of the performance, on yearly basis, upto 5 years or till the age of 65 years whichever is earlier with the approval of GC of concerned NI.
- In case of Group 'A' post, the contract can be renewed up to total 3 years based on the performance appraisal which is to be initiated by Director of respective National Institute and to be reviewed by Joint Secretary and Chairperson, Executive Council of Concerned Institute.
- The contractual appointment would be on full time basis and they would not be permitted to take up any other commercial assignment during the period of consultancy.
- Any other assignments given to the staff to be carried out from time to time.
- The HRD staff shall be assigned duties aimed towards the objectives of Institute and DEPWD at large.
- The selected candidate will be posted at CRC Karaikal, Puducherry and its sub centers/outreach centres with HQ, NIEPMD(D), Chennai. However, they are liable to be transferred to offices anywhere in India under the administrative control of NIEPMD (D), Chennai.
- The engagement of contractual staff can be terminated by the competent authority at any time without assigning any reasons thereof by giving 30 days notice. However, in case a Consultant/Contractual staff wishes to resign, he/she can resign by giving 30 days advance notice or remuneration in lieu thereof before resigning from the engagement.
