NOTIFICATION

CONSTITUTION OF INDIA.

No. RRS. 2008/CR.72/Tex-2—In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the existing rules, orders or instruments made in this behalf, the Governor of Maharashtra is hereby pleased to make the following rules regulating recruitment to the post of Assistant Director (Technical), Maharashtra Technical Service, Group-B (*Gazetted*) under the Directorate of Textiles under the control of the Co-operation, Marketing and Textiles Department of the Government of Maharashtra, namely :—

1. These rules may be called the Assistant Director (Technical), Maharashtra Technical Service, Group-B (*Gazetted*) under the Directorate of Textiles (Recruitment) Rules, 2017.

2. In these Rules, unless the context require otherwise—

(a) “ Commission ” means the Maharashtra Public Service Commission ;

(b) “ Degree ” means a Degree of a Statutory University ;

(c) “ Department ” means the Co-operation, Marketing and Textiles Department of the Government ;

(d) “ Diploma ” means a Diploma of a Statutory University or of a Recognized Institution ;

(e) “ Directorate ” means the Directorate of Textiles, Government of Maharashtra, Nagpur ;

(f) “ Government ” means the Government of Maharashtra ;

(g) “Recognized Institution” means an Institution recognized by the Government of Maharashtra or Government of India.

3. Appointment to the post of Assistant Director (Technical), Maharashtra Technical Service, Group-B (*Gazetted*) under the Directorate shall be made either :—

(a) By promotion of a suitable person, on the basis of seniority subject to fitness, from amongst the persons holding the post of Technical Assistant (Powerloom) or Senior Marketing Officer, having not less than 3 years regular service on that post and possessing qualification and experience as prescribed in the Sub-clause (ii) and (iii) of clause (b) ;

OR

(b) by nomination on the basis of selection through the Commission from amongst the candidates who,—

(i) are not more than thirty three years of age :

Provided that, the upper age limit shall be relaxed upto five year in case of candidates who are already in Government Service ;

(ii) Possess a Diploma in Handloom Technology recognized by the Government of India or by All India Handloom Board, New Delhi or Diploma in Textiles Technology or Textile Manufacturing :

Provided that, preference shall be given to candidates possessing a Degree in Handloom Technology or Textiles Technology ;

(iii) Possess practical experience in weaving of Handloom, Powerloom and Spinning section for a period of not less than three years, after acquiring the qualification mentioned in sub-clause (ii) of this clause, in any industry, Government Office, Industrial Undertaking, Commercial Concern, Local Authority, Corporation or Board established by the Government ; and

(iv) Possess adequate knowledge of Marathi language.

4. Appointment to the post mentioned in Rule 3 shall be made by promotion and nomination in the ratio of 75 : 25, respectively.

5. A person appointed to the post mentioned in Rule 3 by nomination shall be on probation for a period of two years. Probation period may be extended maximum upto one year. A person appointed shall be required to complete the prescribed training successfully and to pass the departmental examination and to complete the probation period satisfactorily. If he or she does not complete the prescribed training successfully or does not pass the departmental examination or does not complete the probation period satisfactorily or is not found suitable for the post, his or her services shall be liable to be terminated.

6. A person appointed to the post mentioned in Rule 3 shall be required to pass the examinations in Hindi and Marathi languages according to the rules made in that behalf, unless he or she has already passed or has been exempted from passing those examinations.

7. A person appointed to the post mentioned in Rule 3 shall be required to possess a certificate in computer operation as prescribed by the Directorate of Information Technology, Government of Maharashtra, from time to time.

8. A person appointed to the post mentioned in Rule 3 shall be liable to be transferred any where in the state of Maharashtra.
