## SECTOR IN FOCUS: SKILLING IN TEXTILES


#### Introduction

India is one of the world's largest textile producers and a key contributor to the economy and job creation. The industry spans traditional handlooms to modern technical textiles, making India a global leader. To meet the growing demands of domestic and international markets, there is a critical need for skilled workers across all sectors.

Focusing on skill development will improve productivity, ensure high-quality standards, and drive innovation. With the right training, India's textile industry can continue to grow, create more jobs, and stay competitive on the global stage.

Hon'ble Prime Minister has been a strong advocate for skill development in the textile sector recognizing its potential to empower individuals and drive economic growth. Under his leadership the government has introduced various initiatives aimed at enhancing the skills of workers ensuring that India's textile industry remains at the forefront of global advancements.

#### Maharashtra's Skilling Landscape

From the vibrant Paithani sarees to the intricate Himroo fabric, Maharashtra's textile traditions tell stories that span centuries. Through planned development, the textile industry in India has become the largest source of livelihood after agriculture, with Maharashtra contributing 10.4% of the country's total textile and apparel production and 10.2% of employment in the sector 1.

According to the 4th Handloom Census conducted by the Government of India in 2018, Maharashtra boasts 3,354 handlooms operated by 3,509 artisans, each preserving unique techniques passed down through generations. Yet, despite this rich legacy, many artisans struggle to sustain their livelihoods in the face of modern production demands. *(source: Integrated & Sustainable Textile Policy 2023-2028, Government of Maharashtra)* 

The traditional textile sector in Maharashtra faces significant challenges due to globalization and the rise of fast fashion, which has led to a decline in demand for handloom products over the past decade. This shift threatens not only the livelihoods of artisans but also the preservation of our rich cultural heritage. With an <u>estimated 70%</u> of the workforce lacking formal training , there exists a pressing need to bridge this skill gap, ensuring that our artisans can adapt and innovate while preserving their time-honored techniques.

## SUCCESS STORY: Skilling in Textiles From the Policy: Maharashtra's focus on Skill Development

The Integrated and Sustainable Textile Policy 2023-2028 places a strong emphasis on skill development and capacity building to address the growing demand for skilled manpower within the textile industry. A key objective of the policy is to ensure a skilled workforce, thereby increasing employability in the sector. To achieve this, various initiatives have been put in place to provide training and enhance the skills of workers across different segments of the industry, from traditional textiles to technical textiles.

In the traditional textile sector, certified weavers have been encouraged to become Master Trainers under the Skill Development Program. These trainers provide practical training, with remuneration set according to the policies of the Skills, Employment, Entrepreneurship, and Innovation Department. Additionally, the wool sector benefits from a scheme focused on onsite visits and skill development training. For technical textiles, the policy mandates that each Technical Textile Park must have a skill development center capable of training at least 30 individuals, ensuring continuous development of the workforce.


To further strengthen skill development, the policy outlines the establishment of new training centers and the upgrading of existing ones. These centers focus on various textile courses such as garmenting and apparel production. The state government provides up to 50% assistance for the creation of these centers, subject to specific financial limits. Furthermore, short-term courses and vocational training programs are being conducted through partnerships with prominent associations and training institutes, including the D.K.T.E. Society's Textile and Engineering Institute and the Maharashtra State Skill Development Society. Collaborations with leading institutions like MSSU, VJTI, DKTE, BTRA, ICT, IIT Bombay, NIFT Mumbai, SASMIRA etc. have also been established to drive research and innovation, promoting entrepreneurship in modern textile technology and design.



## Indian Textile Landscape and Skill Development **Growth of Indian Textiles:**

India stands as a powerhouse in the textile industry, The textile industry in India contributes over 10% to producing vast quantities of cotton, jute, and silk, the country's GDP and provides approximately 8% with 95% of the world's handwoven fabric of total employment, making it a key sector for both originating here. Its textile and apparel sector economic growth and job creation directly employs 45 million people, with 100 million in related industries, making it the nation's second- The textile industry in India stands out as the sole largest employer. The <u>domestic apparel & textile</u> sector industry in India contributes approx. 2.3 % to the opportunities for both skilled and unskilled laborers country's GDP, 13% to industrial production and However, as the industry 12% to exports. India has a 4% share of the global transformation due to technology, evolving market trade in textiles and apparel.

On the export front, India is among the world's new processes, techniques, and innovations. leading textile exporters, with products ranging from traditional garments to high-tech fabrics. It is projected that various India's overall textile exports will reach \$65 billion automation, by FY26 and grow at a 10% CAGR from 2019 to production processes, ensuring high-quality output \$190 billion in 2026.



Graph Depicting Global Indian Textiles Exports till 2030 Source: Ministry of Textiles


