Dear Shri Dhesi,

The last (28th) meeting of Northern Zonal Council was held on 12th May, 2017 at Chandigarh under the Chairmanship of Hon'ble Home Minister. Now, it is proposed to convene the next (29th) meeting of the Council, after getting suitable date from the Hon'ble Home Minister, Chairman of the Zonal Councils.

Before steps are initiated to convene the next meeting of the Northern Zonal Council, it is necessary that sufficient numbers of issues having inter-State/Centre-State ramifications are received from the member-States / Central Ministries / Departments.

I would, therefore, request that the State Government may identify and sponsor important issues that need to be placed before the Northern Zonal Council. Each item proposed for inclusion in the agenda may be accompanied by an explanatory memorandum both in hard & soft copies (at email: lr.gupta@nic.in or ak.shrivastwa@nic.in) indicating:-

- i) Issue or issues proposed to be raised with detailed background note;
- ii) Efforts made by the State Government / Central Ministry to resolve them; and
- iii) Specific points on which recommendation of the Council is sought.

The identified items will be scrutinized by the Standing Committee of the Northern Zonal Council, before they are placed for discussion in the next meeting of the Northern Zonal Council.

I shall also be grateful if copies of the Explanatory memoranda of items sponsored by the State Government are also sent simultaneously to the other member States / Central Ministries in the zone requesting them to forward their comments to us directly, at an early date.
