



Finance Department observes that these posts were abolished and were put in the diminishing cadre by restructuring /right sizing of Archives Deptt on 4.6.2003. Therefore these posts cannot be revived. However, if these posts are considered very essential, then AD may initiate a proposal for creation of posts duly approved by Hon'ble C.M. with requirement of minimum number of posts quoting the pay scales of these posts and total financial liability involved on creation of demanded posts.
